

External Merchandise Trade Statistics – 4th Quarter & Year 2014

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the fourth quarter of 2014 and for the years 2013 and 2014. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

Thus, while revised figures for 2013 are published in this indicator, those for 2014 are subject to revision by mid July 2015 following submission of latest yearly amendments from the MRA - Customs Department to Statistics Mauritius.


Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. It is estimated that for the fourth quarter of 2014 some 7% of Freeport exports were sourced locally.

2. Total value of trade and trade balance

Total external merchandise trade for the fourth quarter of 2014 was valued at R 73,643 million, i.e. 3.7% higher than the previous quarter and 3.9% higher compared to the corresponding quarter of 2013.

During the year 2014, total trade was valued at R 267,214 million, i.e. 5.4% higher than in 2013. Total exports were valued at R 95,191 million against imports of R 172,023 million. The resulting deficit worked out to R 76,832 million, 0.9% lower than the deficit of R 77,546 million of the previous year.



3. Exports

3.1 Total exports (Tables 1 & 3) – 4th Quarter 2014

Total export proceeds for the fourth quarter of 2014, including domestic exports¹, re-exports² and ship's stores and bunkers amounted to R 24,750 million, showing a decrease of 2.6% compared to the previous quarter. This is mainly explained by decreases in the exports of “Cane sugar” (-21.6%), “Fish & fish preparations” (-20.7%) and “Machinery and transport equipment” (-4.6%).

Compared to the corresponding quarter of 2013, total exports for the fourth quarter of 2014 rose by 4.6%. This is mainly explained by increases in “Machinery and transport equipment” (+138.6%), which is due to increases in the re-exports of “Telecommunications equipment & accessories”. Increases were also noted in the exports of “Live primates” (+31.5%), “Pearls, precious & semi-precious stones” (+30.8%), “Articles of wearing apparel and clothing accessories” (+6.0%), partly offset by drops in “Cane sugar” (-34.4%) and “Fish and fish preparations” (-13.7%).

Domestic exports, which accounted for 56.9% of total exports, decreased by 5.8% from R 14,966 million in the previous quarter to R 14,091 million in the fourth quarter of 2014. Compared to the corresponding quarter of 2013, domestic exports were lower by 4.0%. In the fourth quarter of 2014, re-exports stood at R 7,164 million, i.e. higher by 0.5% compared to the previous quarter and 48.5% higher compared to the corresponding quarter of 2013.

3.2 Exports by SITC section (Table 3) – Year 2014

Exports of “Food and live animals” for year 2014 amounted to R 25,095 million, showing a decrease of 7.7% over 2013. Exports of “Cane Sugar” and “Fish and fish preparations” fell by 17.9% and 4.4% respectively, partly offset by a rise in “Live Primates” (+38.5%).

For the year 2014, exports of “Manufactured goods classified chiefly by material” were valued at R 8,514 million, higher by 16.1% compared to the figure of R 7,333 million for the year 2013. This increase is explained by higher exports of “Pearls, precious and semi-precious stones” (+34.1%) and “Textile yarn, fabrics, made up articles” (+5.7%).

Export proceeds for “Miscellaneous manufactured goods”, representing 37.8% of total exports for the year 2014, increased by 5.5% compared to 2013. Exports of “Articles of apparel & clothing accessories”, representing 80.6% of exports of this section, increased by 6.5% compared to 2013.

¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.


3.3 Exports of Export Oriented Enterprises (EOE) – Year 2014

During the year 2014, exports of EOE amounted to R 47,215 million, showing an increase of 0.9% compared to 2013 (Table 1). Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 27 March 2015.

3.4 Exports by country of destination (Table 7) - Year 2014

Analysis of exports figures by country of destination for the year 2014 shows that the European countries were our main buyers, purchasing some 47.4% of our exports for a value of R 38,665 million. The United Kingdom remained our main market within R 11,085 million, 13.6% of total exports. The other major destinations for our exports were France (11.3%), U.A.E (10.7%), U.S.A (10.5%), South Africa (7.1%), Italy (6.5%) and Madagascar (6.5%).

Compared to 2013, total exports to U.A.E went up by 754.6% mainly explained by re-exports of “Telecommunication equipment and accessories”. Exports to Madagascar, U.S.A and France went up by 18.1%, 17.9% and 8.0% respectively, while those to Italy, United Kingdom and South Africa fell by 20.1%, 7.1% and 4.4% respectively.



4. Imports

4.1 Total imports (Table 10) – 4th Quarter 2014

Total imports for the fourth quarter of 2014 reached R 48,893 million, showing increases of 7.2% over the previous quarter and 3.6% when compared to the corresponding quarter of 2013. The increase in imports over the previous quarter is mainly due to increases in imports of “Miscellaneous manufactured articles” (+38.2%), “Crude materials, inedible, except fuels” (+21.5%), “Machinery & transport equipment” (+16.6%) and “Food and live animals” (+2.4%), partly offset by a decrease in “Mineral fuels, lubricants and related products” (-12.6%).

Compared to the corresponding quarter of 2013, imports in the fourth quarter of 2014 rose by 3.6% mainly due to increases in imports of “Machinery and transport equipment” (+25.5%) and “Food & live animals” (+8.8%), partly offset by a decrease in the imports of “Mineral fuels, lubricants and related products” (-19.5%).

4.2 Imports by SITC section (Table 10) - Year 2014

Total imports for the year 2014 amounted to R 172,023 million, showing an increase of 3.9% over the year 2013.

Around 24.4% of imports in the year 2014 consisted of “Machinery and transport equipment” (R 41,991 million), 19.1% of “Mineral fuels, lubricants and related materials” (R 32,942 million) and 16.0% of “Manufactured goods classified chiefly by materials” (R 27,598 million).

Imports of “Food and live animals” for the year 2014 were valued at R 31,353 million, lower by 0.7% compared to 2013. Decreases were noted in imports of “Wheat” (-25.1%) and “Fish and fish preparations” (-12.9%), partly offset by increases in “Dairy products and bird’s eggs” (+16.1%), “Cereal preparations” (+7.7%), “Meat and meat preparations” (+6.6%), “Vegetable and fruits” (+7.5%) and “Rice” (+6.1%).


The import bill of “Mineral fuels, lubricants, & related products” stood at R 32,942 million, representing a decrease of 8.2% over 2013.

Imports of “Manufactured goods classified chiefly by material” for the year 2014 fell by 3.6% to reach R 27,598 million from R 28,616 million during the year 2013. While imports of “Pearls, precious & semi-precious stones” increased by 21.8%, decreases were noted in “Cement” (-17.1%), “Manufactures of metals” (-16.7%), and “Iron and steel” (-15.5%).

For year 2014, imports of “Machinery & transport equipment” which were valued at R 41,991 million increased by 29.0% compared to 2013. This is mainly due to increases in imports of “Telecommunications equipment & accessories” (+127.4%), mostly meant for re-exports.

4.3 Imports by country of origin – Year 2014

During the year 2014, imports from the Asian continent, our major supplier, amounted to R 97,956 million, representing 56.9% of total imports. Our imports originated mainly from the following countries: India (21.6%), China (16.2%), France (7.6%) and South Africa (6.6%) - (Table 13).



5. Trade with Regional Organisations – (Year 2014)

Total exports to African, Caribbean and Pacific (ACP) States during the year 2014 stood at R 13,586 million, against imports of R 17,061 million (Table 14). The trade deficit with ACP countries worked out to R 3,475 million.

During the year 2014, our exports to COMESA member states attained R 6,983 million, while imports from these countries amounted to R 5,108 million resulting in a favorable trade balance of R 1,875 million for Mauritius. Madagascar was the main buyer with a share of 76.1%. Our main suppliers were Kenya (24.8%) and Madagascar (22.7%) - (Table 15).

Trade with SADC countries for the year 2014 showed a deficit of R 2,620 million, resulting from imports value of R 14,969 million against exports worth R 12,349 million. The main supplier was South Africa (75.8%) and our main buyers were South Africa (46.7%) and Madagascar (43.1%) - (Table 16).

6. Trade in Freeport Zone - Year 2014

In 2014, total imports of the Freeport Zone stood at R 18,120 million, higher by 76.1% compared to 2013. Re-exports to overseas market were valued at R 18,928 million, representing an increase of 96.8%. The main item imported and re-exported was “Telecommunications equipment & accessories”.

7. Forecast 2015

Based on past trends and information from various sources, total exports for 2015 is forecasted at R 97,000 million and imports at R 180,000 million. Trade deficit for 2015 is therefore expected to be around R 83,000 million.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS2012)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the **Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
