This report on external trade statistics was published on a semester basis from 1989 up to 1994. As from 1995 an annual report incorporating data for the four quarters is published.

This issue contains quarterly and yearly data on exports and imports for 2011 and 2012.

The basic data for the preparation of this publication are obtained from bills of entry filed in electronically at the Customs Department of the Mauritius Revenue Authority. The Mauritius Sugar Syndicate, Air Mauritius and the State Trading Corporation provide supplementary information. Grateful acknowledgement is expressed here to all these departments and organisations for their continued co-operation.

It is hoped that data given in this report will prove useful to the public in general and to users of external trade statistics in particular.

Overview of External Trade – Year 2012

Introduction

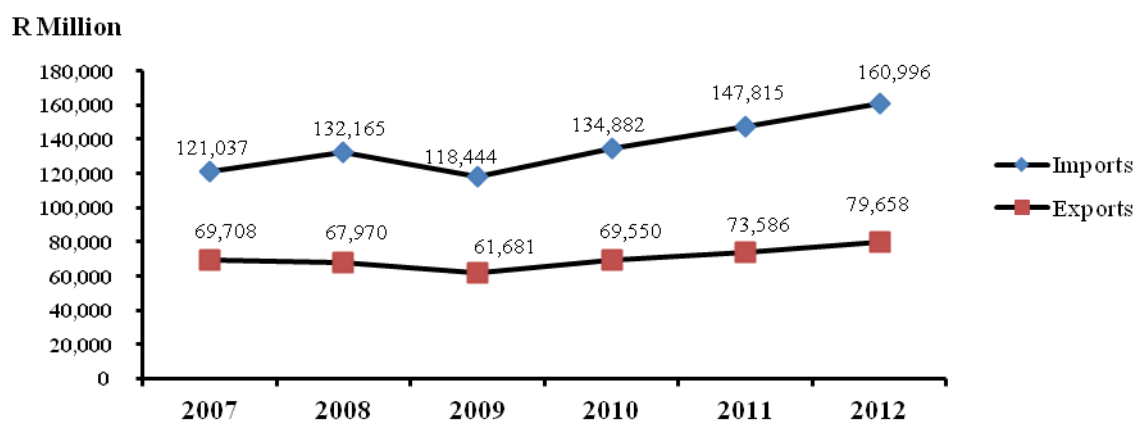
Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone, should be accounted for.

It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. For the year 2012, it is estimated that some 17.8% of Freeport exports were sourced locally.

1. Trade balance

Total exports for the year 2012 reached R 79,658 million compared to total imports of R 160,996 million, resulting in a trade deficit of R 81,338 million.

2. Terms of trade (base year: 2007 = 100)

The terms of trade index for 2012, which shows price changes of exports relative to those of imports (based on the Imports and Exports price indices – base year 2007=100), increased by 0.8% to 83.4 from 82.7 in 2011 (Table 4). This was due to increases of 6.0% in import prices and 6.9% in export prices.

Details of price changes for exports and imports are given in Tables 5 and 6.

3. Exports

Total exports (including ships' stores and bunkers) were up by 8.3% to reach R 79,658 million in 2012 from R 73,586 million in 2011. The table below shows the main changes in total exports (excluding ships' stores and bunkers) between 2011 and 2012.

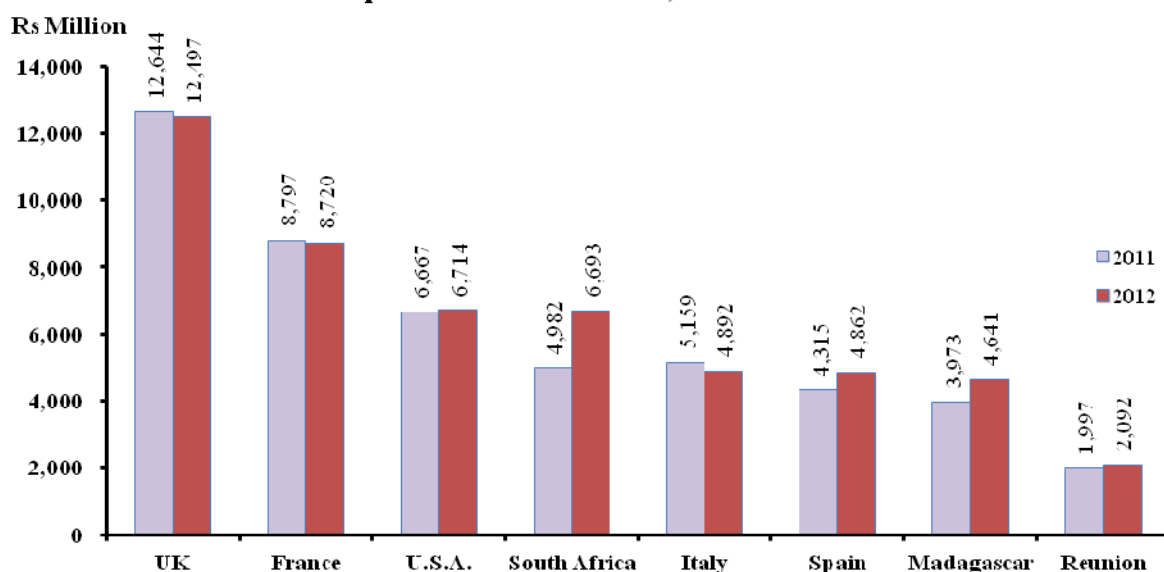
The value of exports of "Food and live animals" increased by 18.6% as a result of a price increase of 16.5% and a volume increase of 1.8%. This rise is mainly due to an increase of 34.3% in the value of exports of "Fish & fish preparations", with a share of 18.9% of total exports. During the same period, however, exports of cane sugar, representing 12.1% of total exports, fell by 1.1% from R 8,226 million in 2011 to reach R 8,135 million in 2012 (Table 14).

Export receipts of "Chemicals & related products, n.e.s" increased by 8.5% in nominal terms, resulting from a rise of 10.8% in volume. A nominal decrease of 1.6% was noted in "Miscellaneous goods classified chiefly by material" following a decrease of 4.1% in volume. For the year 2012, exports of "Articles of apparel and clothing accessories", representing 35.5% of our total exports, increased slightly to R 23,924 million from R 23,866 million in 2011.

An analysis by country of destination showed that the European countries purchased R 38,795 million in 2012, representing 57.6% of our total exports. United Kingdom (UK) remained the main buyer with R 12,497 million, or 18.5% of total exports, followed by France with R 8,720 million (12.9%). The other major markets were United States of America (U.S.A) (10.0%), South Africa (9.9%), Italy (7.3%), Spain (7.2%), and Madagascar (6.9%). Compared to 2011, total exports to Italy, U.K and France decreased by 5.2%, 1.2% and 0.9% respectively while increases were noted in exports to South Africa (34.3%),

Madagascar (16.8%), Spain (12.7%) , Reunion (4.8%) and U.S.A (0.7%). Table 15 shows further details.

4. Total Imports (including Freeport imports)

Total imports for the year 2012 attained R 160,996 million from R 147,815 million in 2011, higher by 8.9%. In 2012 imports of “Mineral fuels, lubricants and related materials”, “Machinery and transport equipment”, “Food and live animals” and “Manufactured goods classified chiefly by material”, represented 21.4%, 20.0%, 18.5% and 17.7% of total imports respectively.

4.1. Imports (excluding aircraft)

The table below shows the main changes in imports between 2011 and 2012.

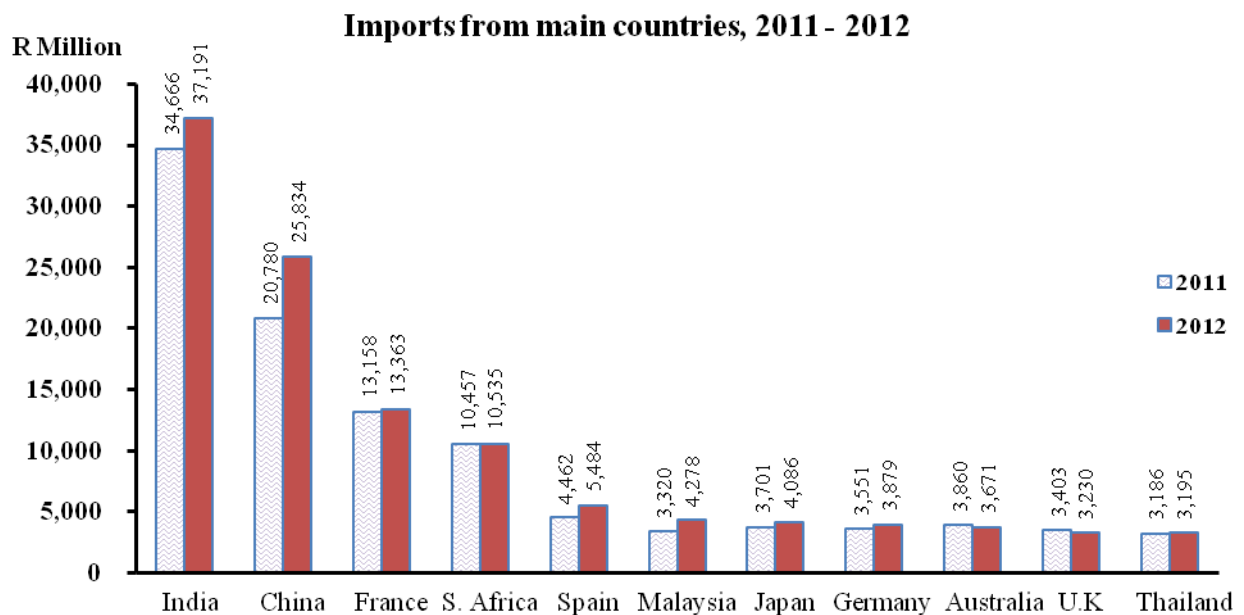

With the exception of “Crude materials, inedible except fuel” and “Animals and vegetable oils & fats” whose imports were down by 20.4% and 7.9% respectively, all other remaining main SITC sections registered increases in nominal terms, ranging from 3.0% to 22.0% in 2012.

In nominal terms, imports of “Machinery & transport equipment” was up by 22.3% as a result of increases of 4.8% and 16.8% in prices and in volume respectively. Imports value for “Food and live animals” increased by R 2,818 million (10.4%) due to increases of 7.1% and 3.1% in prices and volume respectively. That for “Mineral fuels, lubricants and related materials” rose by 8.1% with an increase of 8.4% in prices.

Details by section and commodity are given in tables 19 and 20.

Imports by country of origin are given in table 23. During the year 2012, imports from Asia reached R 90,506 million, representing 56.2% of total imports. Our main suppliers were India (23.1%), China (16.0%), France (8.3%) and Republic of South Africa (6.5%).



5. Trade in Freeport Zone

During the year 2012, re-exports in the Freeport zone were valued at R 7,676 million, representing an increase of 19.5% from R 6,425 million in 2011 (Table 12). Imports rose to R 9,651 million (11.3%) from R 8,674 million in 2011 (Table 21).

6. Trade with Regional Organisations

ACP States

During 2012, total exports to African, Caribbean and Pacific (ACP) States were valued at R 13,777 million and imports at R 15,698 million (Table 35). Our main buyers were South

Africa (R 6,693 million) and Madagascar (R 4,641 million). Imports from South Africa which amounted to R 10,535 million made up for 67.1% of supplies from the ACP states.

COMESA States

For the year 2012, total exports to COMESA countries amounted to R 6,492 million against R 4,687 million worth of imports, resulting in a favorable balance of R 1,805 million for Mauritius (Table 36). Madagascar was the main buyer (71.5%) while Kenya was the main supplier (33.3%).

SADC States

For the year 2012, exports from SADC countries were valued at R 12,735 million and imports at R 13,561 million (Table 37). Our main buyers were Republic of South Africa (52.6%) and Madagascar (36.4%). The main supplier was the Republic of South Africa (77.7%).

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2012). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

(4) **Terms of trade**

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports to imports price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power.
