INTERNATIONAL TRAVEL & TOURISM 1ST SEMESTER 1999

1. Passenger Traffic

(i) Total Passenger Traffic

Total passenger traffic for the first semester of 1999 amounted to 742,200, made up of 365,300 arrivals and 376,900 departures. Compared to the same period of last year, these figures represent increases of 6% in arrivals and 4% in departures. Table 1 shows monthly details of passenger traffic.

Total arrivals included 4,940 "excursionists", i.e. passengers arriving and leaving on the same day. Of these excursionists, 2,140 (43%) came from Reunion Island and 820 (17%) from France. Total arrivals also included 10,140 "cruise excursionists" (6,150 passengers and 3,990 crews) aboard 13 cruise ships which visited our port during the first semester of 1999.

(ii) Departures of Mauritian Residents

The number of Mauritian residents travelling abroad increased by 12% from 62,400 for the first six months of 1998 to 70,100 for the same period in 1999 and accounted for 19% of total departures. Growth was observed in departures to the following destinations: France (+29%), United Kingdom (+49%), Malagasy Republic (+23%), India (+23%), Singapore (+52%), Saudi Arabia (+24%) and Australia (+14%). On the other hand, declines of 66% to Kenya and 48% to Malaysia were also registered. A more detailed distribution by country visited is presented in Table 2.

(iii) Tourist Arrivals

Tourist arrivals for the first semester of 1999 rose by 3%, from 264,800 in 1998 to 271,900 in 1999. This was mainly due to increases in arrivals from some major generating countries like France, United Kingdom and Reunion Island. Further details on tourist arrivals are given in Tables 3 to 6.

Around 91% of the tourists came mainly for holidays while 4% were on business trips and another 2% were in transit (Table 4).

Table 6 shows that arrivals from Europe have known a growth of 6% for the first semester of 1999 and accounted for 66% of total tourist arrivals. France, our leading European market, maintained its upward trend with an increase of 7% to reach a figure of 84,050 at the end of June 1999. Arrivals from United Kingdom progressed by 18% from 21,500 in the first semester of 1998 to 25,400 for the same period in 1999. Arrivals from Germany have increased marginally by 2% while those from Italy have known a decline of 6%. Trends among the other European countries were as follows: Austria (-3%), Belgium (+12%), Netherlands (+41%), Spain (+24%), Sweden (+28%), Switzerland (-7%) and CIS (-28%).

For the period January to June 1999 arrivals from Africa registered a decline of 4% and accounted for 27% of total tourist arrivals. Arrivals from Reunion Island, the major generating country of the region, recorded an increase of 3% while those from Republic of South Africa dropped by 12% compared to the corresponding period of last year. Changes in arrivals from other African countries were as follows: Kenya (+13%), Malagasy Republic (-10%), Seychelles (-12%) and Zimbabwe (-41%).

Tourist arrivals from Asia grew by 3% compared to the first semester of 1998 and accounted for 5% of total tourist arrivals. Arrivals from India, the largest market of the continent, have increased by 4%. Among other Asian countries the following trends were observed: Japan (+16%), Malaysia (+15%) and People's Republic of China (-6%).

Arrivals from Oceania have dropped by 24%, mostly influenced by Australia.

Arrivals from the continent of America declined by 9%. This is however the net result of a growth of 7% from USA and declines of 2% from Canada and 47% from other American countries.

2. Tourist Nights

Total tourist nights spent in the country during the first semester of 1999 is estimated at 2.8 million, representing an increase of 5% over the corresponding period of last year (Table 3).

3. Hotel Statistics

At the end of March 1999, there were 89 registered hotels in operation, of which 29 were considered "Large", i.e. well-established beach hotels with more than 80 rooms. The total capacity for all registered hotels was 7,365 rooms with 15,167 bedplaces. For "Large" hotels the room capacity was 5,135 with 10,454 bedplaces (Table 3). Thus "Large" hotels, which represented 33% of all registered hotels, account for 70% of room capacity and 69% of bedplaces.

The monthly room occupancy rate for the first semester of 1999 averaged 70% for all hotels (Table 7) whereas bed occupancy rate was 61% (Table 8). For "Large" hotels, the corresponding figures were 75% for room occupancy rate (Table 9) and 66% for bed occupancy rate (Table 10).

4. Gross Tourism Receipts

Gross receipts from tourism for the first semester of 1999 is estimated at 6,441 million rupees, i.e. an increase of 16% compared to 5,568 million rupees for the same period of last year. Quarterly figures of tourism receipts are given in Table 3.

5. Employment

According to the Survey of Employment and Earnings conducted at the end of March 1999, direct employment in travel and tourism establishments employing 10 persons or more stood at 17,111, that is 4% higher than last year. Of this number, 11,715 or 68% were engaged in hotels (Table 11).

6. Forecast Year 1999

Based on the trends during the first six months of the year and patterns of previous years, it is estimated that tourist arrivals for the year 1999 will be around 580,000, i.e. an increase of 4% over last year. Corresponding gross receipts from tourism are expected to reach 13,500 million rupees compared to 11,890 million rupees for 1998.

Explanatory Notes

1. Tourist

A tourist is defined as a non-resident staying for more than 24 hours but less than a year, who is not involved in any gainful occupation in the country during his/her stay.

2. Transit

A transit passenger is one who stops over in the country for flight connections to other destinations. There are two types of transit passengers:

Type I: Passengers who do not leave the transit area of the airport or the harbour.

Type II: Passengers who do leave the airport or harbour and stay in the country for more than 24 hours but only for flight connection purposes.

Only Type II transit passengers, as defined above, are included in the definition of "Tourists".

3. Excursionist or Same-day Visitor

Excursionists are non-resident visitors, other than those who do not leave the airport, who stay in the country for less than 24 hours. They also include passengers as well as crews of *cruise ships*.

4. Tourist Nights

"Tourist nights" means the total number of nights spent in the country by tourists, as defined above, during the period under review.

5. Large Hotels

Large hotels are well established beach hotels with more than 80 rooms.

6. CIS

CIS denotes the Commonwealth of Independent States, which consists of the states of the former Soviet Union.


