

Export Oriented Enterprises (EOE) **3rd Quarter 2015**

1. Introduction

This issue of “Economic and Social Indicators” (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by the Statistics Unit of the Ministry of Industry, Commerce and Consumer Protection at the end of September 2015.

It also includes provisional figures on EOE imports and exports for the 3rd quarter of 2015 as well as figures for the years 2013 and 2014. Table 1 shows the main indicators of the EOE sector for the period 2007 to 2014.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Employment

2.1 Employment – 3rd Quarter 2015

Compared to the second quarter of 2015, employment in EOE decreased by 234 (-0.4%) from 54,122 to 53,888. Male employment increased by 7 to reach 25,400, but female employment decreased by 241 from 28,729 to 28,488 (Table 2).

The number of Mauritians employed in the EOE sector went down by 292 (-0.9%) from 31,502 to 31,210 while the number of foreign workers increased by 58 (+0.3%) from 22,620 at the end of June 2015 to 22,678 at the end of September 2015 (Table 2).

The decrease of 234 in employment during the third quarter of 2015 is the result of 774 job losses and creation of 540 new jobs.

Highest number of job losses occurred in the sub sectors “Wearing apparel” and “Food” with decreases of 485 and 114 jobs respectively and jobs were created in “Wearing Apparel”, “Food” and “Textile Yarn and Fabrics” with increases of 277, 68 and 14 jobs respectively.

2.2 Evolution of employment from September 2014 to September 2015

From September 2014 to September 2015, total employment decreased by 1,549 (-2.8%) from 55,437 to 53,888. The number of Mauritian workers decreased by 1,264 (-486 males and -778 females) and employment of foreign workers decreased by 285 (+52 males and -337 females) (Tables 2 and 5).

Jobs were lost mainly in sub sectors “Pullovers” and “Other garments” with decreases of 228 and 1,193 jobs respectively. However, some new jobs were created mainly in “Textile yarn and fabrics” and in “Leather products and footwear” with increases of 59 and 47 jobs respectively.

Details of changes in employment by product group are given in tables 3, 4 and 5.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2013 and 2014 are final, those for 1st Quarter, 2nd Quarter and 3rd Quarter of 2015 will be revised when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 3rd Quarter 2015

3.1.1 Exports (f.o.b)

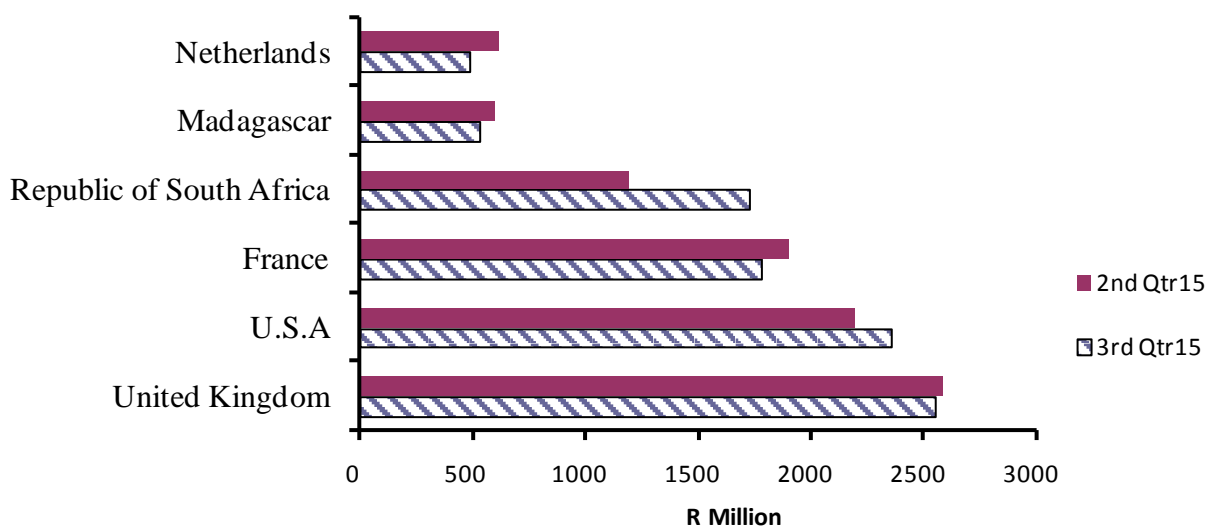
Provisional figures show that EOE exports during the 3rd quarter of 2015 amounted to R 12,986 million, that is, R 137 million (-1.0%) lower compared to the second quarter of 2015 (Table 6). That was mainly the result of decreases of R 251 million (-9.3%) in the exports of “Fish & fish preparations” and R 146 million (-17.1%) in “Textile yarn, fabrics and made up articles” partly offset by an increase of R 659 million (+10.6%) in the exports of “Articles of apparel and clothing”.

Compared to the corresponding quarter of 2014, EOE exports increased by R 293 million (+2.3%).

Details on EOE exports by section are given in Table 7.

The United Kingdom (UK), the United States of America (USA) and France remain the principal EOE markets, together accounting for R 6,684 million (51.5%) of total EOE exports. The Republic of South Africa, Madagascar and Netherlands are among the other main destinations of EOE exports.

Compared to the previous quarter, main changes in exports were as follows:

Exports went up for:

- Republic of South Africa by R 528 million (+44.0%); and
- U.S.A by R 152 million (+6.9%).

Exports went down for:

- Netherlands by R 132 million (-21.2%); and
- France by R 130 million (-6.8%).

Further details are given in Table 9.

3.1.2 Imports (c.i.f)

EOE imports during the 3rd quarter of 2015 were estimated at R 6,641 million, representing a decrease of R 548 million (-7.6%) compared to the second quarter of 2015 (Table 8). This decrease is due to lower imports of “Raw materials” by R 438 million (-6.5%) and “Machinery” by R 110 million (-27.0%).

Compared to the corresponding quarter of 2014, imports decreased by R 1,078 million (-14.0%), mainly due to drops in imports of “Fish and fish preparations” by R 827 million (-37.1%), “Pearls, precious & semi-precious stones” by R 112 million (-10.6%) and partly offset by a rise of R 116 million (+38.2%) in imports of cotton.

Details on EOE imports by section are given in Table 8.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 6,345 million in the third quarter of 2015 and its ratio to total exports worked out to around 49% compared to 39% in the corresponding quarter of 2014 (Table 6).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport are considered as local sales, were valued at R 60 million in the third quarter of 2015 compared to R 190 million in the third quarter of 2014. These sales are included in exports of Freeport, as and when the goods leave the country.
