#### **STATEMENT FROM THE AG. DIRECTOR OF STATISTICS**

It is an honour and privilege for me to present the Annual Performance Report of Statistics Mauritius which offers a comprehensive account of our achievements, challenges, and progress during the Financial Year (FY) 2023/2024.

This report serves not only as a record of our performance but also as a testament to the dedication and resilience of all our staff which has demonstrated unwavering commitment and professionalism throughout the past year. We have made significant strides in modernizing our operations, improving our publications, and enhancing the knowledge of all through the various trainings (in-house and overseas) organized. These advancements are a direct result of the strategic planning and collaboration within the department and our partners.

The implementation of our E-Business Plan is one of our flagship initiatives. In Phase 1 of this project, the modules for Housing & Population Census (HPC), Statistical Business Register (SBR) and Survey of Employment & Earnings (SEE) have been developed and the development of the modules for Demography and Trade are in progress. Online and Onsite technical meetings and discussions are conducted by iTech Mission Limited (iTM) and the units under the guidance of Statistics Mauritius'(SM) Management.

In October 2023, a mission comprising technical experts from iTM was fielded, where Minimum Viable Product (MVP) of MauStats Platform was presented, showcasing its user interface, core features and interactions. SM staff participated in the User Acceptance Test (UAT) online sessions to review and report issues in their MauStats modules.



Capacity building training workshops were also conducted from 4th to 12th Dec 2023 at various levels by the iTM team covering modules on IT, Admin and User. Moreover, a delegation from SM participated in an Advanced Technical Workshop in New Delhi, India from 08 to 23 February 2024 to learn how to improve the platform implementation and usage by testing and reviewing the architecture, processes and content. The participants interacted directly with the platform development team to review, discuss and improve the processes and their flow. This project is expected to be completed by July 2024.

SM is also assisting in the provision of data for the setting up of an "Observatoire de L'Environnement" (ODE). The main roles of the ODE are to: (i) collect environmental data and ensure accessibility to these data; (ii) determine, prioritize and monitor environmental indicators to assess the state of the environment; and (iii) generate periodic reports such as the state of the environment report. The ODE platform is expected to be launched in December 2024.

Moreover, we are participating in the preparation of the First Biennial Transparency Report (BTR) for the Republic of Mauritius. This report will consist of:

(a) Greenhouse Gas (GHG) inventory for the period 2000 – 2022; and (b) an update on the progress achieved through the implementation of Nationally Determined Contribution (NDC) which is an economy-wide 40% reduction in Net GHG emission by 2030.

As in previous years, we celebrated the African Statistics Day to engage with all producers and users of data about the importance of statistics for development. A half-day workshop on the theme "Modernizing data ecosystems to accelerate the implementation of the African Continental Free Trade Area (AfCFTA): the role of official statistics and big data in the economic transformation and sustainable development of Africa" was held in November 2023. The items on the agenda were the African Continental Free Trade Area, Mauritius-Africa Strategy, Trade in Services and Merchandise Trade Statistics.



A good team spirit and a well-equipped workforce are indispensable tools to the successful delivery of our services and improving our business operations. The need to quickly adopt new data science methods in providing timely, trusted and high-quality data to citizens, government programs and services has increased nowadays. To that end, we have invested immensely last year in the development and enhancing the skills of the staff in the technical cadre by providing training in innovative topics such as Structured Query Language, Data management and retrieval, data programming languages and application of machine learning methods. A one-year training in Advanced Statistics was also provided to some 38 Statistical Officers.

Looking ahead, we remain focused on our mission to serve, with an emphasis on innovation, efficiency, and adaptability. The lessons learned over the past year will guide us as we continue to evolve and meet the needs of all in an ever-changing environment. In conclusion, I would like to extend my deepest gratitude to the Statistics team for their steadfast dedication and their invaluable contributions towards achieving the office objectives. Together, we will continue to build on our successes, address our challenges, and uphold the highest standards of service.

#### **3. ROLES AND FUNCTIONS OF STATISTICS MAURITIUS**

Statistics Mauritius (SM) operates under the Statistics Act 2000. Statistics Mauritius therefore has the mandate of producing official statistics relating to all aspects of the country's economic, demographic and social activities except for health statistics which fall under the responsibility of the Ministry responsible for Health, and monetary and financial, banking and balance of payment statistics for which the Bank of Mauritius is responsible.

Data are collected through censuses and surveys, and from administrative sources. For more efficiency and to reduce response burden, maximum use of data collected for administrative purposes is made and data is collected only where there is a need to do so.

Our statistics are compiled according to the latest international standards. We make use of international classifications to enable comparability at the international level. By virtue of the Statistics Act, SM is mandated to co-ordinate statistical activities of all producers of official statistics including public sector agencies to ensure standards and to minimize overlap and duplication in production of official statistics in the country. It collaborates with Ministries and Departments of Government in the collection, compilation, analysis, publication and dissemination of statistical information. As working arrangement, staff of the statistical cadre are posted in line ministries, while several Memoranda of Understanding have been signed with some data producing agencies to set out the framework for cooperation, with a view to facilitating data sharing and coordination.

We conduct regular consultations with main data users to assess their needs in order to produce statistics of relevance and provide Government with statistics relevant for policy formulation and development planning.




#### 4. OUR PEOPLE

#### 4.1 Staffing

Statistics Mauritius is headed by the Ag. Director of Statistics who is also the Accounting Officer of the Department. He is assisted by three Deputy Directors, each in charge of a division, namely:

- Social and Labour Statistics Division;
- National Accounts and Prices Division; and
- Statistical Support, Informatics and Dissemination Division.

As at 30 June 2024, there were 230 staff in post as follows:

Funded Vacancies in the grades of Financial Operations Cadre, Procurement and Supply Cadre and in the General Services Class have also been filled.





#### 4.2.1 Hierarchical Structure





#### 4.5 Capacity Building

- Under the training agreement between SM and the University of Mauritius, officers of SM were sponsored for the following training courses jointly organized by Statistics Mauritius and University of Mauritius:
  - A one-year Training in Advanced Statistics for 38 officers in the grade of Statistical Officers/Senior Statistical Officers including 1 from the Ministry of Health and Wellness was organized. The course which started in July 2023 has lasted till June 2024.
  - 50 officers in the grades of Statistician/Senior Statistician and Statistical Officers/Senior Statistical Officers attended a Short Training Course in Fundamentals of Data Analytics from October 2023 to March 2024.
- (ii) In December 2023, Statistics Mauritius (SM) participated in a capacity building workshop on UNESCO's Thematic Indicators for Culture in the 2030 Agenda (UNESCO Culture 2030 Indicators) which is a conceptual framework to measure and monitor the progress of culture. Mauritius hosted the workshop and participants from Comoros, Ethiopia, Kenya, Madagascar, Namibia, Seychelles, Somalia, Sudan and Uganda attended the workshop.
- (iii) The International Labour Organisation (ILO) conducted a 5-day training on CMPHS data analysis using STATA from 3 to 7 June 2024 at Statistics Mauritius (SM). The objective of the training was to derive key labour statistics using the STATA software,



in particular, Status of Employment and informality. Ms. Maria Payet, Senior Statistician/ Statistics Specialist of ILO, provided the training to some 14 Officers of SM.

- (iv) Mr. Timo Koskimäki, Director of International Affairs and Ms. Outi Ahti-Miettinen, Quality Manager, both experts in Business Register (SBR) from Statistics Finland, fielded a mission at SM, under the EU-funded PAS2 projects for the African National Statistical Offices, from 23 to 27 October 2023 to give technical assistance to enhance its Statistical Business Register (SBR) in line with European standards. During their visit, the two experts took stock of the various sources of data used by SM to populate and update the SBR currently maintained by the office. Under the same project,
  - Mr. Ville-Matti Pilviö and Mr. Timo Laukkanen, Experts from Statistics Finland visited the office from 05 to 08 February 2024 to share the EU experience and best practices on the production of Business Statistics indicators that can be used as a model for African Countries. Discussions were also based on using the SBR to monitor response and respondent burden, essential business demography and using SQL/R programming to extract summary tables from the SBR database.
  - Statistics Norway organised a study tour in Oslo from 21-24 May 2024 for participants from Mauritius, Namibia and Senegal, Finland and Denmark. This study visit had as aim to share the Norwegian experiences in establishing their Business Register and in using administrative data and also performing quality controls for the Statistical Business Register.

#### 4.7 Study tours/visits at SM

- The UN Food and Agricultural Organisation (FAO) is implementing the STAT SANOI project "Establishment of a network of information systems on agriculture and food and nutrition security in the Indian Ocean islands. In this context, SM welcomed seven officers of the SANOI team and seven participants from Madagascar, Seychelles and the Comoros on 29 May 2024. The aim of their visit was to learn from the experience of Mauritius on the Census of Agriculture as these three countries are currently engaged in preparatory work for their next Census.
- SM had the opportunity to welcome two groups of students of Grade 12 and 13 from Notre Dame and Loreto Rose-Hill Colleges in July 2023 and June 2024 respectively. The objective of these educational visits was to prepare them for their upcoming module on Statistics and also enrich their knowledge while choosing their future career.

#### 4.8 Health and Safety

Our Occupational Health and Safety Committee comprises of representatives from concerned Units of Statistics Mauritius, the Health and Safety Officer and one representative from the Life Insurance Corporation (LIC). The Committee meets whenever needed, or else every two months in accordance with the regulations in force, to resolve issues related to health and safety of our officers.

The World Day for Safety and Health at Work is celebrated annually on 28 April to create awareness among all stakeholders on the importance of promoting a safe and healthy culture at the workplace. Statistics Mauritius in collaboration with the Non-Communicable Disease Division of the Ministry of Health and Wellness organized a free medical screening exercise for its staff on 15 and 16 April 2024. This exercise comprised of Blood Tests, Eye Test, Weighing and Scaling and special screening for female staff aged 25 years and above. Some 150 SM staff participated in this exercise.

### 7. RISK MANAGEMENT, CITIZEN ORIENTED INITIATIVES & GOOD GOVERNANCE

We continually work towards improving the quality of our statistics to better satisfy users' needs. Some of the main actions include:

Interaction with our main stakeholders to gather their views so as to produce statistics that are relevant.

Posting of an Advance Release Calendar on our website and release of our statistics accordingly on our website so that all users have free access simultaneously. We send email alerts to our main stakeholders whenever there is a new release.

To ensure transparency, our methodologies are published together with the statistical releases. Advance notice is given to our users whenever there are major changes in methodology, including data sources and statistical techniques.

Production of our statistics according to professional standards and publish them in ways which explain and inform without advocating a particular position.

We have an agreement with respondents; they are encouraged to provide accurate information while we ensure that the data provided are strictly protected. Our staff is required by law to give an undertaking of secrecy while we make sure that in publishing the statistics, identifiable information is not released. We also take necessary measures to ensure the security of the statistical information collected.

To improve accountability, we regularly receive the visits of the Internal Control Unit of the Ministry of Finance, Economic Planning and Development as well as the National Audit Office. Remedial actions are promptly taken whenever shortcomings are brought to the attention of management.

#### Major Changes from 2022 - 2023 to 2023 - 2024

The actual shifted from 420 M in 2022-23 to 229 M in 2023-24 as a result of decrease in payments related to the Housing and Population Census (HPC) 2022.

#### Major Variances from estimates and actual for Financial Year 2023 - 2024

The variance for 'Compensation of Employees' is mostly due to some vacancies that remained unfilled at the close of the financial year.

The variance for 'Goods and Services' is mainly due to the recruitment of less staff for the processing of census data and also consultancy services for tabulation and analysis of data was received from UNFPA free of charge.

The variance for 'Acquisition of Non-Financial Assets' is explained by the delay in finalising the technical need assessment for the acquisition of IT Equipment.
