Mauritius subscribes to SDDS

Mauritius subscribed to the IMF's Special Data Dissemination Standard (SDDS) on 28 February. It is the 70th country worldwide and the second Sub-Saharan African country to subscribe to the SDDS.

"The subscription to the SDDS of Mauritius represents a major step forward for official statistics in the country and for those who use these data. Subscription to the standards underscores the strong commitment to transparency in Mauritius, as well as a significant achievement in implementing internationally accepted best practices in statistics" says Ms. Adelheid Burgi-Schmelz, Director of the IMF's Statistics Department.

The SDDS is intended for member countries having or seeking access to international capital markets. Subscription to the SDDS provides investors with up-to-date data that are frequent, timely and accessible. This facilitates the country's access to international capital markets, potentially implying higher levels of foreign investment. In Mauritius, five institutions are responsible for disseminating data according to the SDDS; these are: Statistics Mauritius, Ministry of Finance and Economic Development, Bank of Mauritius, Financial Services Commission and Stock Exchange of Mauritius.

On 9 February, Statistics Mauritius signed an MOU with the Financial Services Commission. The MOU sets out the framework of collaboration between both institutions for coordinating data collection and processing. It aims at increasing the reliability and analytical value of financial services statistics and at ensuring their international comparability.

Stats M hosts a study tour on ERETES

Statistics Mauritius hosted a study tour on ERETES, an information system used for the elaboration of National Accounts, from 27 to 29 February 2012. The study tour was organised by the United Nations Economic Commission for Africa (UNECA).

Participants were from 7 English speaking statistical offices of Africa and from UNECA. They were given first-hand experience on how the office has applied the different tools of ERETES in National Accounts so that they can decide whether to adopt ERETES in their respective countries.

How many celebrated their birthday on 29 February?

Provisional data from Census 2011 suggest that there are nearly 800 leaplings (persons whose birthday falls on 29 February) in Mauritius. Census Statisticians are excited since this is close to the expected number.

Considering that 29 February occurs once every 4 years, the probability of being born on that day is 1/1461 (because 366+365+365+365 equals 1461). So the expected number of leaplings should be 1/1461 of the population or 860.

Happy Birthday to all leaplings who look 4 times older than their age!
