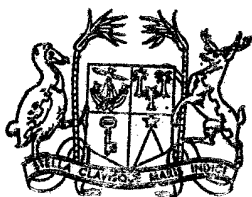

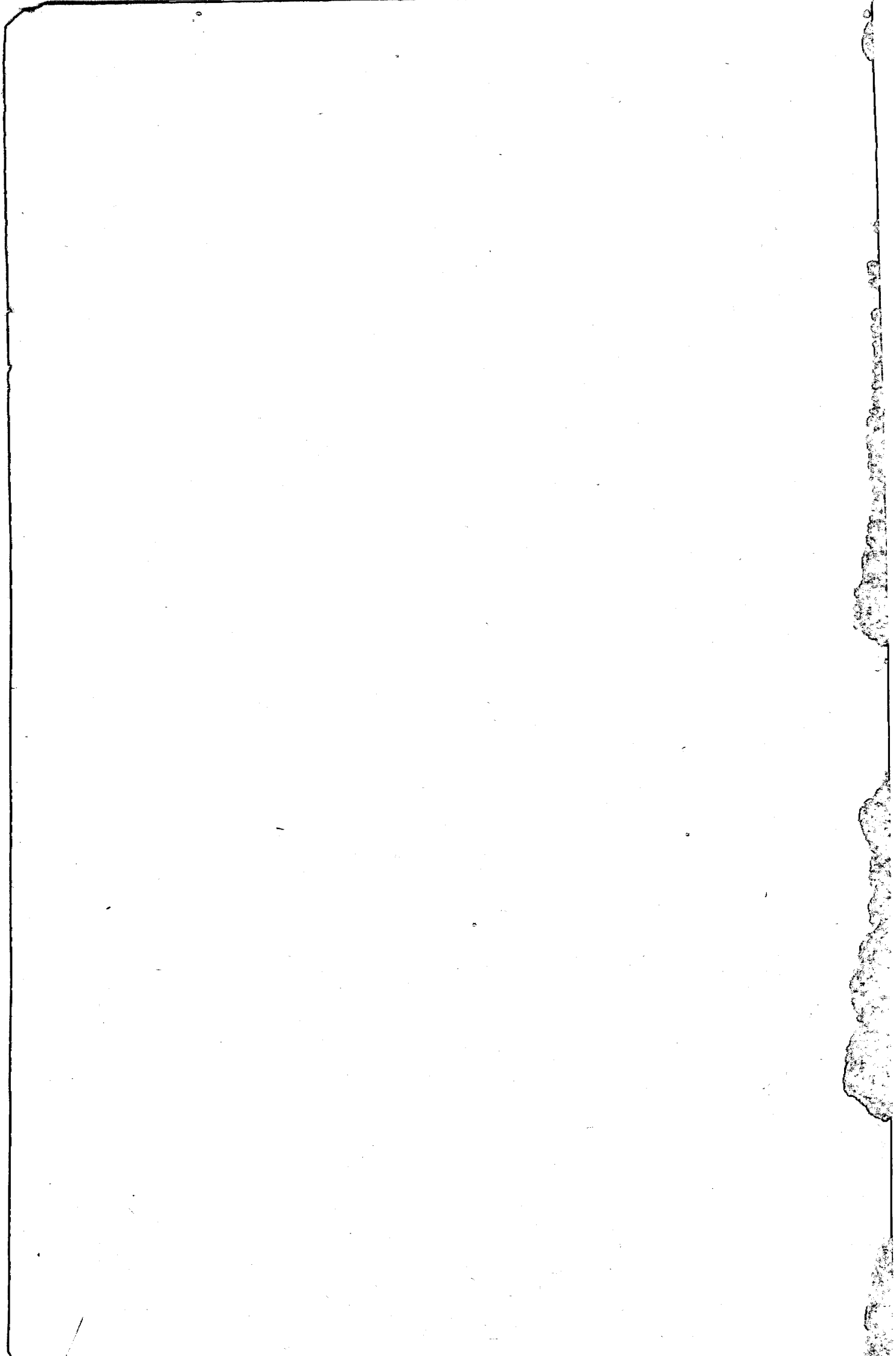

It is designed to present in a concise and readily accessible form the more important statistical series available on the demographic, economic and social characteristics of Mauritius.

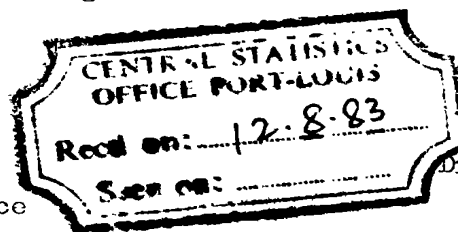
A new series of National Accounts has been prepared as from 1976 based on the United Nations System of National Accounts, 1968 (New SNA). It is therefore not comparable with any series which have been published before. Attention is drawn on the notes that appear on page 58 of this issue, where the main differences between the new SNA and the old one are given.

Some minor changes have also been introduced in Section 11 - Transport and Communication. More detailed data are provided on registration of vehicles.

Some of the figures in this digest are provisional and liable to revision in later issues. Figures in each issue of the digest supersede and replace those appearing in previous volumes.

Where necessary, figures have been rounded off to the nearest final digit, and in some tables there may be discrepancies between the sum of the constituent items and to the total as shown.

The assistance given by the Bank of Mauritius, all government departments and other bodies in providing data for publication in this issue is gratefully acknowledged.

Section 8 - EMPLOYMENT AND EARNINGS

1. The figures of employment and earnings in tables 8.1 - 8.8 apply to large establishments only. These being defined as:
 - (i) Sugar cane plantations where 25 arpents or more were harvested ;
 - (ii) Tea plantations of 5 arpents or more;
 - (iii) All 'flue-cured' tobacco establishments, irrespective of acreage;
 - (iv) Non-agricultural establishments employing at least 10 persons at the time of the survey. It is to be noted that "outdoor workers" are excluded; these are piece-rate workers who although employed by an establishment are working in their own homes;
 - (v) All central and local government departments;
 - (vi) Establishments employing development workers.

2. a) Tables 8.5 - 8.8 show changes in earnings as distinct from changes in statutory minimum wage rates which are shown in tables 8.9 and 8.10.

- b) Apart from increase in salaries and wages, fluctuations in earnings may be due to:
 - (i) changes of different magnitude in the various categories of the labour force e.g. a large intake of employees at the lower end of the wage scale (as occurs when a new factory starts operation) has the effect of lowering the average earnings. On the other hand a large intake of professionals by, say, an architectural firm can cause a sudden jump in the average monthly earnings.

 - (ii) changes in overtime, regular bonuses and commissions
