The basic data for the preparation of this publication are obtained from bills of entry filed in electronically at the Customs Department of the Mauritius Revenue Authority. The Mauritius Sugar Syndicate, Air Mauritius, Airports of Mauritius and the State Trading Corporation provide supplementary information. Grateful acknowledgement is expressed here to all these departments and organisations for their continued co-operation.

It is hoped that data given in this report will prove useful to the public in general and to users of external trade statistics in particular.

Overview of External Trade – Year 2009


Introduction

Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone, should be accounted for. However, it was not possible prior to the year 2002 to include Freeport transactions because of different processing systems at the Customs Department and the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), making it possible to integrate data of the Freeport zone with those of Customs.

As from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. For the year 2009, it is estimated that some 38% of freeport exports were sourced locally.

1. Trade balance

Total exports for the year 2009 reached Rs 61,681 million compared to total imports of Rs 118,444 million, resulting in a trade deficit of Rs 56,763 million.



2. Terms of trade (reference year: 2007 = 100)

The terms of trade index for 2009, which shows price changes of exports relative to those of imports (based on the Imports and Exports price indices – reference year 2007=100), increased by 5 percentage point to 94 when compared to 2008 (Table 4). This was due to decreases of 6.0% in import prices and 1.0% in export prices.

Details of price changes for exports and imports are given in Tables 5 and 6.

Note that the new series are not strictly comparable with previous ones published because different base periods and changes in concepts as well. The indices published in this issue are inclusive of re-exports and Freeport imports

3. Exports

Total exports (including ships' stores and bunkers) for the year 2009 reached Rs 61,681 million showing a decrease of 9.3% over the previous year.

The table below shows the main changes in total exports between 2008 and 2009.

The value of exports of “*Food and live animals*” increased by 1% as a result of 15% increase in volume offset by a price decrease of 12%. Export receipts of “*Manufactured goods classified chiefly by materials*” went down by 3% in nominal terms, resulting from an increase of 14% in prices and a decrease of 15% in volume. Exports of “*Miscellaneous manufactured articles*”, decreased by 1% in value as a result of a decrease of 6% in volume and a 5% increase in price.

For the year 2009, exports of “*Articles of apparel and clothing accessories*” representing 41.6% of total exports, fell to Rs 23,360 million, i.e. a decrease of 2.3% over the previous year. During the same period, exports of sugar, representing 12.2% of total exports, declined by 17.4% to Rs 6,828 million (Table 14).

An analysis by country of destination shows that the European countries purchased some 66.7% of our exports for Rs 37,445 million in 2009. The United Kingdom (UK) remained the main buyer with Rs 15,280 million, or 27.2% of total exports, followed by France with Rs 9,317 million (16.6%). The other major markets were United States of America (U.S.A) (8.2%), Madagascar (6.4%), Italy (5.5%), Spain (4.5%) and South Africa (4.5%). Compared to 2008, total exports to U.K went down by 24.1% while increases were noted in Spain (34.0%), USA (17.8%), France (17.7%), and Italy (15.0%). Table 15 shows further details.



4. Total Imports

Total imports for the year 2009 attained Rs 118,444 million (includes aircraft valued at Rs 2,862 million and Freeport imports) fell by 10.4% compared 2008.

In 2009 imports of “*Machinery and transport equipment*”, “*Food and live animals*” and “*Manufactured goods classified chiefly by material*” represented 23.4%, 18.6% and 18.1% of total imports respectively while imports of “*Mineral fuels, lubricants and related materials*” made up for 15.6%.


4.1. Imports excluding aircraft

The table below shows the main changes in imports between 2008 and 2009.

With the exception of “*Chemicals & related products*” and “*Miscellaneous manufactured articles*” whose imports were up by 3.0% and 2.0% respectively, all other remaining SITC sections registered decreases in nominal terms, ranging from 4% to 35% in 2009. The highest decrease in nominal terms was registered in “*Mineral fuels, lubricants and related materials*” whose imports value went down by 35% as a result of decreases of 32% and 4% in prices and in volume respectively. The other sections registering substantial price decreases were “*Mineral fuels, lubricants and related materials*”, and “*Animals and vegetable oils & fats*” whose prices were down by 32% and 29% respectively. Details by section and commodity are given in tables 19 and 20.

Table 23 shows imports by country of origin. During the year 2009, imports from Asia totaled Rs 59,049 million, representing 49.9% of total imports. Our main supplier countries were India (18.9%), China (12.6%), France (11.7%) and Republic of South Africa (8.6%).



5. Trade with Regional Organisations

ACP States

During 2009, total exports to African, Caribbean and Pacific (ACP) States were valued at Rs 7,998 million and imports, Rs 13,596 million (Table 35). Imports from South Africa which amounted to Rs 10,235 million made up for 75.3% of supplies from the ACP states.

COMESA States

For the year 2009, total exports to COMESA countries amounted to Rs 4,991 million against Rs 3,311 million worth of imports, resulting in a favourable balance of Rs 1,680 million for Mauritius (Table 36). Madagascar was the main buyer (71.9%) while Kenya was the main supplier (33.0%).

SADC States

For the year 2009, imports from SADC countries were valued at Rs 11,973 million and exports at Rs 7,371 million (Table 37). The main supplier was the Republic of South Africa (85.5%). Our main buyers were Madagascar (48.7%) and Republic of South Africa (34.6%).

6. Trade in Freeport Zone

During the year 2009, total imports of the Freeport Zone amounted to Rs 5,800 million and re-exports were valued at Rs 7,325 million. It is worth noting that trade in the freeport has dropped significantly compared to 2008 on account of a decrease in the imports and re-exports of cellular phones (Tables 12 and 21).

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2007). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

(4) Terms of trade

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports to imports price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power.
