The basic data for the preparation of this publication are obtained from bills of entry filed in electronically at the Customs Department of the Mauritius Revenue Authority. The Mauritius Sugar Syndicate, Air Mauritius and the State Trading Corporation provide supplementary information. Grateful acknowledgement is expressed here to all these departments and organisations for their continued co-operation.

It is hoped that data given in this report will prove useful to the public in general and to users of external trade statistics in particular.

Overview of External Trade – Year 2011


Introduction

Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone, should be accounted for.

It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. For the year 2011, it is estimated that some 25.0% of Freeport exports were sourced locally.

1. Trade balance

Total exports for the year 2011 reached R 73,586 million compared to total imports of R 147,815 million, resulting in a trade deficit of R 74,229 million.



2. Terms of trade (base year: 2007 = 100)

The terms of trade index for 2011, which shows price changes of exports relative to those of imports (based on the Imports and Exports price indices – base year 2007=100), declined by 2 percentage points to 83 from 85 in 2010 (Table 4). This was due to increases of 6.0% in import prices and 4.0% in export prices.

Details of price changes for exports and imports are given in Tables 5 and 6.

Note that the new series are not strictly comparable with previously published series worked out using 2003 as base year.

3. Exports

Total exports (including ships' stores and bunkers) were up by 5.8% to reach R 73,586 million in 2011 from R 69,550 million in 2010.

The table below shows the main changes in total exports (excluding ships' stores and bunkers) between 2010 and 2011.



The value of exports of "*Food and live animals*" decreased by 2.0% as a result of a price decrease of 3.0% partly offset by an increase of 1.0% in volume. Export receipts of "*Manufactured goods classified chiefly by materials*" were up by 12.0% in nominal terms, resulting from increases of 2.0% in prices and 10.0% in volume. Exports of "*Miscellaneous manufactured articles*" remained almost at the same level of 2011. The price and volume both increased by 4.0%

For the year 2011, exports of "*Articles of apparel and clothing accessories*" representing 38.3% of total exports, decreased to R 23,866 million from R 23,941 million in 2010, i.e. lower by 0.3%. During the same period, exports of sugar, representing 13.2% of total exports, rose by 6.7% from R 7,708 million in 2010 to reach R 8,226 million (Table 14).

An analysis by country of destination shows that the European countries purchased some 61.5% of our exports for R 38,328 million in 2011. United Kingdom (UK) remained the main buyer with R 12,644 million, or 20.3% of total exports, followed by France with R 8,797 million (14.1%). The other major markets were United States of America (U.S.A) (10.7%), Italy (8.3%), South Africa (8.0%), Spain (6.9%), and Madagascar (6.4%). Compared to 2010, total exports to France and U.K decreased by 16.4% and 5.5% respectively while increases were noted in exports to South Africa (38.3%), Madagascar (11.5%), Spain (10.0%) and USA (7.7%). Table 15 shows further details.



4. Total Imports (including Freeport imports)

Total imports for the year 2011 attained R 147,815 million from R 134,882 million in 2010, higher by 9.6%.

In 2011 imports of “*Mineral fuels, lubricants and related materials*”, “*Manufactured goods classified chiefly by material*”, , and “*Food and live animals*” represented 21.6%, 18.7% and 18.2% of total imports respectively while imports of “*Machinery and transport equipment*” made up for 17.8%.


4.1. Imports (excluding aircraft)

The table below shows the main changes in imports between 2010 and 2011.

With the exception of “*Chemicals and related products*” and “*Machinery & transport equipment*” whose imports were down by 2.8% and 3.2%, all other remaining main SITC sections registered increases in nominal terms, ranging from 6.0% to 52.0% in 2011. In nominal terms the imports value of “*Mineral fuels, lubricants and related materials*” was up by 25.0% as a result of increases of 4.0% and 20.0% in prices and in volume respectively. The other section registering substantial higher prices was “*Animals and vegetable oils & fats*” (+34.0%). Details by section and commodity are given in tables 19 and 20.

Table 23 shows imports by country of origin. During the year 2011, imports from Asia totaled R 79,067 million, representing 53.5% of total imports. Our main suppliers were India (23.5%), China (14.1%), France (8.9%) and Republic of South Africa (7.1%).



5. Trade with Regional Organisations

ACP States

During 2011, total exports to African, Caribbean and Pacific (ACP) States were valued at R 11,146 million and imports, R 15,520 million (Table 35). Imports from South Africa which amounted to R 10,457 million made up for 67.4% of supplies from the ACP states.

COMESA States

For the year 2011, total exports to COMESA countries amounted to R 5,579 million against R 4,565 million worth of imports, resulting in a favorable balance of R 1,014 million for Mauritius (Table 36). Madagascar was the main buyer (71.2%) while Kenya was the main supplier (28.3%).

SADC States

For the year 2011, imports from SADC countries were valued at R 13,534 million and exports at R 10,114 million (Table 37). The main supplier was the Republic of South Africa (77.3%). Our main buyers were Republic of South Africa (49.3%) and Madagascar (39.3%)

6. Trade in Freeport Zone

During the year 2011, total imports of the Freeport Zone amounted to R 8,674 million and re-exports were valued at R 6,425 million.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2007). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

(4) **Terms of trade**

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports to imports price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power.
