

Foreword

External Trade - Year 1995

This report on External Trade Statistics was published on a semester basis as from 1989 up to 1994. As from 1995 an annual report incorporating data for the four quarters is published.

This issue contains quarterly and yearly data on exports and imports relating to the year 1994 and 1995. Data relating to the year 1994 have been revised whilst those for the year 1995 are provisional.

The basic data for the preparation of this publication are obtained from the Bills of entry filed in at the Customs and Excise Department, The Mauritius Sugar Syndicate and The State Trading Corporation provide supplementary information. The Central Information Systems Division (CISD) of the Ministry of Finance is responsible for the processing of the data. Grateful acknowledgement is expressed here to all these departments and organisations for their continued cooperation.

It is hoped that data given in this report proves useful to the public in general and to users of External Trade Statistics in particular.

External Trade

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 3) or SITC Rev. 3. The HS and the SITC Rev. 3 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

4. Terms of trade

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports price index to import price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power

As shown in the table below, volume increases in SITC sections "Mineral fuels, lubricants and related materials(+13%)" and "Chemicals and related products(+2%)" were offset by decreases in volume of "Manufactured goods(-2%)," "Machinery and transport equipment(-4%)."

Imports by country of origin (Table 16) show that during the year 1995 the country's main source of import remained the European union which accounted for 32% of total imports. On a countrywise basis our main suppliers were France (13%), the Republic of South Africa (11%), India, (8%), United Kingdom,(7%), Hong kong, (5%), Japan, (5%) and Germany, (5%).

5. The EPZ Sector

During the year 1995 EPZ exports attained Rs 18,267 million against Rs 16,533 million in 1994. This nominal increase of 10% reflects a 5% increase in volume and a 5% increase in prices.

Imports, on the other hand, reached Rs 10,856 million. Raw materials amounted to Rs 9,869 million, 10% higher than in 1994. On the other hand imports of machinery and transport equipment including spare parts fell by 11% from Rs 1,110 million in 1994 to Rs 987 million in 1995.

Net exports for the year 1995 therefore amounted to Rs 7,411 million, and its ratio to EPZ exports progressed to 41% from 39% in 1994.

External Trade - Year 1995

Introduction

This report presents trade figures for the years 1994 and 1995. Data relating to the year 1994, in particular the unit value price indices, have been revised whilst those for the year 1995 are still provisional.

1. Total value of trade and trade balance

Total exports for the year 1995 reached Rs 27,300 million showing an increase of Rs 2,600 million or 11% over those of 1994. Imports amounted to Rs 34,400 million, almost the same level as in 1994. Thus the balance of visible trade showed a deficit of Rs 7,100 million against Rs 9,850 million in 1994. Exclusive of aircraft, imports increased by 6% from Rs 32,500 million to Rs 34,400 million and the trade deficit works out to Rs 7,100 million against Rs 7,850 million in 1994 (Table 1).

2. Terms of trade (Base year: 1992 = 100)

The terms of trade for the year 1995 remained at previous year's level of 96. Prices have increased by 6% on average for both exports and imports. Prices of EPZ and sugar exports were up by 5% and 8% respectively (Table 4(a)). Details on price changes in imported goods (Table 4(b)) show increases in all product groups ranging from 3% to 15% with the exception of "Mineral fuels, lubricants and related materials" and "Machinery and transport equipment" where price changes were negligible.

3. Exports

Total export proceeds for the year 1995, which comprise domestic exports, re-exports, and ships' stores and bunkers amounted to Rs 27,300 million, showing an increase of Rs 2,600 million or 11% over the year 1994.

Domestic exports were up by 11% to Rs 25,800 million from Rs 23,200 million in 1994. After allowing for price increases of around 6%, domestic exports showed an increase in volume of around 5%.

EPZ exports increased by 10% to Rs 18,260 million from Rs 16,533 million a year ago. Proceeds from sugar amounted to Rs 6,326 million; 524,000 tonnes of sugar were exported against 518,000 tonnes in 1994. Other domestic exports (Table 5) comprised mainly articles of apparel and clothing (Rs 270 million), chemicals and related products (Rs 121 million), molasses (Rs 136 million), cut flowers (Rs 126 million), live animals (Rs 65 million), tea (Rs 50 million) and wheaten flour (Rs 39 million).

Re-exports in 1995 totalled Rs 970 million against Rs 900 million in 1994. Each year's figure includes the sale proceeds of a marine vessel.

Table 10 shows comparative export figures by country of destination for the years 1994 and 1995. Higher exports were registered for U.K (+19%), France (+17%) and Germany (+10%). Consequently the share of our main buyer, the European Union, progressed from 71 to 74% whilst the share of the U.S market dropped from 18 to 15%.

4. Imports

The import bill for the year 1995 was valued at Rs 34,363 million almost the same as the previous year's figure of Rs 34,548 million. However, exclusive of the purchase of the aircraft valued at Rs 2,000 million in 1994, the annual increase works out to 6%. As overall import prices are estimated to have increased by around 6%, in volume terms, import showed no growth.
