External Trade – 1st Quarter 2005

Introduction

This issue of the Social and Economic Indicators presents external trade statistics for the first quarter of 2005 and for the years 2003 and 2004. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Customs Department.

Thus while figures for 2003 published in this indicator are final, those for 2004 and 2005 are subject to revision as and when the Customs Department submits latest amendments to the Central Statistics Office.

Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for. However, it was not possible prior to 2002 to include Freeport transactions in our general trade statistics because of different processing systems at the Customs Department and at the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), thus making it possible to integrate data of the Freeport zone with those of Customs.


Hence, as from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius because it is not possible to distinguish between domestic exports and re-exports of freeport licensees. It is estimated that currently some 28% of freeport exports are sourced locally.

As from the first quarter of 2005, the terms of trade are based on the Exports and Imports Price Indices instead of unit value indices. Thus, as mentioned in previous issues, the Economic and Social Indicator on trade statistics will no longer contain data on terms of trade. Such data will now appear in the Economic and Social Indicator on Import and Export Prices Indices. The analysis of imports and exports in volume terms will henceforth also appear in this publication.

1. Total value of trade and trade balance

Total international trade for the first quarter of 2005 was valued at Rs 31,456 million, a figure which is 14.6% lower than that of the previous quarter but 11.0% higher than that of the corresponding quarter of 2004.

During the first quarter of 2005, total exports reached Rs 13,030 million compared to total imports of Rs 18,426 million, thus resulting in a trade deficit of Rs 5,396 million.



Based on trends for previous years, total exports for the year 2005 are expected to be of the order of Rs 55,100 million, against Rs 83,800 million for imports which would include aircraft worth Rs 115 million. The trade deficit would be around Rs 28,700 million.

2. Exports

2.1 Total exports

Total export proceeds for the first quarter of 2005, including domestic exports, re-exports and ship's stores and bunkers, amounted to Rs 13,030 million, showing a decrease of 13.1% over the previous quarter and an increase of 6.6% over the corresponding quarter of 2004.

Domestic exports, which represented 72% of total exports, went down by 21.1% from the previous quarter to reach Rs 9,439 million. Compared to the first quarter of 2004, domestic exports decreased by 3.4%.

2.2 Exports by SITC sections

Exports of "Food and live animals" for the first quarter were valued at Rs 3,789 million, showing a decrease of 15.4% over the previous quarter but an increase of 30.3% when compared to the first quarter of 2004. Exports of sugar, representing 19% of total exports, registered an increase of 20.7% over the corresponding period of last year to reach Rs 2,363 million.

During the first quarter of 2005, export receipts from "Manufactured goods classified chiefly by material" stood at Rs 1,040 million, showing a drop of 12.6% compared to the previous quarter but an increase of 13.8% over the first quarter of 2004.


Export proceeds from “Miscellaneous manufactured articles”, representing 51% of total exports for the first quarter of 2005 reached Rs 6,178 million. This figure represented a decrease of 18.5% compared to the previous quarter and another of 13.9% when compared to the corresponding period of 2004. In this section, exports of “Articles of apparel & clothing accessories” were valued at Rs 5,255 million, that is 19.1% less than the previous quarter and 17.5% less than the first quarter of last year.

2.3 Exports of EPZ

During the first quarter of 2005, exports of EPZ products went down by 22.7% to Rs 6,546 million. Compared to the first quarter of 2004, these exports showed a decrease of 11.7%. Details on exports of EPZ are presented in the Economic and Social Indicator on the Export Processing Zone.

2.4 Exports by Country of destination

Analysis by country of destination shows that our main buyers, i.e the European countries, purchased some 69% of our exports amounting to Rs 8,375 million. The United Kingdom remained the main buyer with Rs 4,213 million, or 35% of total exports, followed by France with Rs 1,980 million (16%). The other major markets were U.S.A (11%), Malagasy Republic (6%), Italy (5%) and Belgium (3%). Compared to the first quarter of 2004, total exports to UK went up by 4% while those to U.S.A and France fell by 20% and 11% respectively. Table 6 shows further details.



3 Imports

3.1 Total imports

Total imports for the first quarter of 2005 reached Rs 18,426 million, showing a decrease of 15.6% over the previous quarter but an increase of 14.3% over the corresponding quarter of 2004.

3.2 Imports by SITC sections

Imports of “*Food and live animals*” for the first quarter of 2005 decreased by 11.1% compared to the previous quarter to reach Rs 2,966 million. However, this figure shows an increase of 19.4% over the corresponding quarter of 2004.

Import bill of “*Mineral fuels, lubricants, & related products*” was Rs 2,876 million, showing a drop of 14.6% compared to the previous quarter but an increase of 27.6% over the corresponding period of last year.

During the first quarter of 2005, imports of “*Manufactured goods classified chiefly by material*” declined by 21.8% compared to the previous quarter to attain Rs 4,050 million. This figure also shows a slight drop of 1.4% when compared to the corresponding period of 2004.

Imports of “*Machinery & transport equipment*”, representing 25% of total imports for the first quarter of 2005, decreased by 8.2% compared to the previous quarter to reach Rs 4,665 million but increased by 22.9% when compared to the corresponding period of 2004.

Further details by section and commodity are given in tables 9 and 10.

3.3 Imports by country of origin




Table 11 shows imports by country of origin. During the first quarter of 2005, imports from Asia totalled Rs 8,827 million, representing 48% of total imports for that period.

On a countrywise basis, our main supplier countries were China (9%), India (9%), Republic of South Africa (9%), France (9%), Bahrain (5%), UAE (4%), Japan (4%), Germany (4%), Australia (3%) and United Kingdom (3%).

4. Trade with Regional Organisations

Total exports to African, Carribean and Pacific (ACP) States during the first quarter of 2005 amounted to Rs 1,144 million, while imports stood at Rs 2,299 million (Table 12).

During the first quarter of 2005, Mauritius exported goods to a value of Rs 909 million to COMESA countries. Imports from these countries amounted to Rs 441 million, resulting in a favourable balance of Rs 468 million for Mauritius. Madagascar was the main buyer (78%) and Egypt was the main supplier (26%). The main products exported to Madagascar were: cotton fabrics, yarn of carded wool, preparations used in animal feeding, wheat flour and fertilisers. Bars and rods of iron, napkins for babies, ceramic tiles, sanitary towels, medicaments, oranges, frozen potatoes and fruit juices were the main products imported from Egypt.

Trade with SADC countries for the first quarter of 2005 showed a deficit of Rs 1,710 million, resulting from imports to a value of Rs 1,992 million and exports amounting to Rs 282 million (Table 14). The main supplier was the Republic of South Africa (84%). Our main buyers were Republic of South Africa (52%) and Seychelles (28%).

5. Trade in Freeport Zone

During the first quarter of 2005, total imports of the Freeport Zone from overseas amounted to Rs 1,972 million, a figure which is 91% higher when compared to the previous quarter and 130% higher than the corresponding quarter of 2004. Re-exports to overseas markets were valued at Rs 2,019 million, that is 22% higher than those of the previous quarter and 30% higher than the corresponding quarter of 2004 (Table 2).

External Trade

Notes

(1) **Coverage**

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) **Valuation**

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) **Classification**

(i) **Commodity Code**

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS 2002). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 3) or SITC Rev. 3. The HS and

the SITC Rev. 3 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

4. **Terms of trade**

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports price index to import price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power
