## **PRODUCER PRICE INDEX - MANUFACTURING (PPI-M)**

**4th Quarter 2005**

### **1. Introduction**

The Producer Price Index (PPI-M) measures changes in the effective prices received by producers for that part of their output, which is sold on the domestic market. It reflects the price trends of a constant basket of goods, representative of the output of the manufacturing industries.

The Central Statistics Office first published a Producer Price Index for the Manufacturing sector (Non-EPZ) in March 1994, with 1993 as reference period, but the coverage was then limited to the "Manufacture of food products, beverages and tobacco". The index has been revised in June 2002 to cover all relevant industry groups of the Non-EPZ manufacturing sector. However, figures according to this revision have been compiled since the base year, i.e. 1998.

This issue of the "Economic and Social Indicators" presents the Producer Price Indices for the Non-EPZ manufacturing sector from 1998 to 2005, broken down by 14 Divisions (2-digits level of the National Standard Industrial Classification of Economic Activities, NSIC). Producer Price Indices for the Divisions 15 and 16, "Manufacture of food products, beverages and tobacco", have been further subdivided by product group level and are given separately in Tables 5 to 8. Table 9 summarises the monthly indices for the manufacturing sector and Table 10, monthly sub-indices for the group "Manufacture of food products, beverages and tobacco". The methodology used for the calculation of the index is given in annex.

### **2. Producer Price Index (Year 1998 = 100)**

#### **2.1 Monthly index**

The Producer Price Index, which stood at 140.7 in September 2005 increased by 2.2% to 143.8 in December 2005 following increases of 0.7% in October and November, and 0.8% in December (Table 1).

The 0.7% increase in the overall index in October was mainly due to increases in the sub-indices for "Manufacture of basic metals" (+9.8%) and "Manufacture of food products, beverages and tobacco" (+0.4%), partially offset by a decrease in the sub-index for "Manufacture of rubber and plastic products" (-6.6%). The increase in the sub-index for "Food products, beverages and tobacco", which accounts for nearly 50% of the overall weight, was mainly the effect of price increases of bakery products (+7.6%).

The 0.7% rise in the overall index in November was mainly due to an increase in the sub-index for "Manufacture of food products, beverages and tobacco" (+1.4%), mostly explained by higher prices of spirits (+11.0%), and meat and meat products (+2.0%).

In December, the index increased by 0.8% following increases in the sub-indices for "Manufacture of other non-metallic mineral products" (+3.8%), "Publishing, printing and reproduction of recorded media" (+5.8%), and "Manufacture of food products, beverages and tobacco" (+0.1%). The 0.1% increase in the latter sub-index was mainly due to higher prices of spirits (+1.1%).

The evolution of the monthly index by NSIC group for the period 1998 to 2004 is shown in Tables 2, 3, 6 and 7.

## 2.2 *Quarterly Index*

Table 4 gives the evolution of the Producer Price Index on a quarterly basis, the quarterly index being computed as the arithmetic mean of the monthly indices. The index, which worked out to 141.0 for the third quarter, increased to 142.7 for the fourth quarter of 2005. This 1.2% growth was mainly due to increases in the sub-indices for "Manufacture of food products, beverages and tobacco" (+1.3%), "Publishing, printing and reproduction of recorded media" (+3.5%) and "Manufacture of basic metals" (+6.0%), partly offset by a decrease in the sub-index for "Manufacture of rubber and plastic products" (-6.3%).

Within "Food products, beverages and tobacco", "Beverages and tobacco" went up by 1.9% mainly due to higher prices of spirits (7.8%). "Food products" increased by 0.8% mostly explained by higher prices of bakery products (+7.6%), meat and meat products (+1.9%), partly offset by lower prices of oils and fats (-1.2%). Details of changes are shown in Table 8.

Compared to the corresponding quarter of 2004, the overall index for the fourth quarter of 2005 went up by 6.7%, mainly attributable to increases in the sub-indices for the following industry groups: "Manufacture of food, beverages and tobacco" (+7.1%), "Manufacture of chemicals and chemical products" (+9.2%), "Manufacture of other non-metallic mineral products" (+8.3%), and "Manufacture of fabricated metal products" (+10.2%).

Within "Manufacture of food products, beverages and tobacco", "Food products" increased by 5.1% and "Beverages and tobacco" by 9.8%. At a more detailed level, significant increases were noted in the prices of tobacco products (+38.8%), spirits (+12.2%), prepared animal feeds (+10.5%), meat and meat products (+9.6%) and dairy products (+13.4%). These increases were partly offset by lower prices of grain mill products (-3.8%) and oils and fats (-1.6%). Other details on changes that have occurred during that period are given in Tables 4 and 8.

## ANNEX

### **Methodology used in the computation of the Producer Price Index (PPI-M)**

#### **1 Scope**

The PPI-M covers all large establishments (that is those employing 10 or more persons) whose output is mainly sold on the domestic market, that is divisions 15 to 37 of the National Standard Industrial Classification of Economic Activities (NSIC).

#### **2 Weighting Scheme**

The weights have been calculated from the gross output figures derived from the 1997 Census of Economic Activities. Gross output is valued at basic prices, and thus excludes all taxes on products, namely excise duties and value added tax. The weight of a product group represents the share of its gross output out of the total output of the manufacturing sector.

In the case of sugar, only the sale on the local market has been taken into consideration in establishing the weights.

#### **3 Reference Year**

The reference year for the calculation of price relatives is 1998. The base price for a particular product is the arithmetic mean of the 12 monthly prices in 1998.

#### **4 Index Calculation**

The PPI-M is calculated at the 5-digits level of NSIC. Indices at the Division level (2 digits NSIC) are then derived as a weighted average of the indices of the products falling within each division. Finally, the overall index for manufacturing is obtained as a weighted average of the Division indices.

The PPI is calculated according to a modified Laspeyre's formula, which is the weighted average of price relatives.

where  $I_c$  = Index for current month

$W_i$  = Weight associated with product  $i$

$P_{ci}$  = Price of product  $i$  for the current month

$P_{oi}$  = Price for product  $i$  for the reference period (1998)
