

External Trade – 3rd Quarter 2009

Introduction

This issue of the Economic and Social Indicators presents external trade statistics for the first three quarters of 2009 and for the years 2007 and 2008. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

Thus while figures for 2008 published in this indicator are final, those for 2009 are subject to revision as and when the MRA - Customs Department submits latest amendments to the Central Statistics Office.


Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for. However, it was not possible prior to 2002 to include Freeport transactions in our general trade statistics because of different processing systems at the Customs Department and at the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), thus making it possible to integrate data of the Freeport zone with those of Customs.

Hence, as from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius because it is not possible to distinguish between domestic exports and re-exports of freeport licensees. It is estimated that for the third quarter of 2009 some 42% of freeport exports were sourced locally.

1. Total value of trade and trade balance

Total international trade for the third quarter of 2009 was valued at Rs 45,123 million, i.e 4.4% higher than the previous quarter but 13.6% lower than the corresponding quarter of 2008.

During the third quarter of 2009, total exports were valued at Rs 16,211 million against imports of Rs 28,912 million. This resulted in a trade deficit of Rs 12,701 million, when compared to deficits of Rs 13,784 million (-7.9%) for the previous quarter and Rs 16,113 million (-21.2%) for the corresponding quarter of 2008.



Based on past trends and actual data for 2009 till September, total exports for the year 2009 are expected to be of the order of Rs 63,000 million, against Rs 116,000 million for imports. The trade deficit would be around Rs 53,000 million.

2. Exports

2.1 Total exports (Table 1)

Total export proceeds for the third quarter of 2009, including domestic exports¹, re-exports² and ships' stores and bunkers amounted to Rs 16,211 million, showing an increase of 10.2% compared to the previous quarter but a decrease of the same percentage, i.e 10.2% with respect to the corresponding quarter of 2008.

Domestic exports, which accounted for 76.5% of total exports, went up by 13.0% from Rs 10,976 million in the previous quarter to Rs 12,398 million in the third quarter of 2009. Compared to the corresponding quarter of 2008, domestic exports were higher by 3.2%. For the third quarter of 2009 re-exports stood at Rs 2,680 million i.e higher by 4.1% compared to the previous quarter but lower by 28.3% as regard to the corresponding quarter of 2008 respectively. This fall in re-exports is attributable to a decrease in re-exports of cellular phones.

Total exports for the first nine months of 2009 reached Rs 45,187 million, showing a decrease of 6.1% over the first nine months of 2008.

2.2 Exports by SITC section - (First nine months 2009)

Exports of "Food and live animals" for the first nine months of 2009 amounted to Rs 13,937 million showing an increase of 15.9% over the corresponding period of 2008. Exports of sugar went up by 6.6% while those of "Fish and fish preparations" went up by 19.4% (Table 3).

For the first nine months of 2009, exports of "Manufactured goods classified chiefly by material" were valued at Rs 3,780 million, lower by 4.0% when compared to exports for the first nine months of 2008, valued at Rs 3,936 million.

Total exports of "Machinery and transport equipment" for the first nine months of 2009 registered a significant fall of 71.2% compared to the corresponding nine months of 2008 as a result of a large decrease in re-exports of mobile phones to the United Arab Emirates (UAE) during the third quarter.

Export proceeds from "Miscellaneous manufactured articles", contributing 49.6% of total exports from January to September 2009, increased slightly by 0.5% compared to the first nine months of 2008 to reach Rs 20,659 million. For the period under review, exports of "Articles of apparel & clothing accessories" representing 85.2% of exports of this section showed an increase of 1.0%.

2.3 Exports of Export Oriented Enterprises(EOE) - (First nine months 2009)

During the first nine months of 2009, exports of the EOE amounted to Rs 26,655 million showing an increase of 3.8% compared to the corresponding period of 2008 (Table 1). Details on exports of these enterprises will be presented in the Economic and Social Indicators on the Export Oriented Enterprises, which will be released on 16 December 2009 on website.


¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

2.4 Exports by Country of destination - (First nine months 2009)

Analysis of exports figures by country of destination for the first nine months of 2009 shows that the European countries purchased some 66.9% of our exports for an amount of Rs 27,866 million. The United Kingdom remained our main market with Rs 11,138 million, 26.8% of total exports. The other major destinations for our exports were France (16.2%), U.S.A (8.6%), Madagascar (6.5%), Italy (5.5%) and Spain (4.8%) - (Table 7).

Compared to the first nine months of 2008, total exports to UK went down by 16.1%, while those from U.S.A, France and Madagascar went up by 22.1%, 13.4% and 2.7% respectively. A decrease of 90.5% was recorded in total exports to the United Arab Emirates as a consequence of the decrease in re-exports of cellular phones. Further details are given in Table 7.



3. Imports

3.1 Total imports - (Table 1)

Total imports for the third quarter of 2009 reached Rs 28,912 million, showing an increase of 1.5% over the previous quarter but a decrease of 15.4% compared to the corresponding quarter of 2008.

Total imports for the first nine months of 2009 amounted to Rs 82,802 million, showing a decrease of 14.5% with respect to the corresponding nine months of 2008.

3.2 Imports by SITC section - (First nine months 2009)

Imports of “*Food and live animals*” for the first nine months of 2009 were valued at Rs 16,560 million, i.e 8.4% lower than those of the corresponding period of last year. The most significant decreases were noted in imports of rice (-21.3%), fish and fish preparations (-19.7%) and dairy products (-14.3%) – (Table 10).

The import bill of “*Mineral fuels, lubricants, & related products*” stood at Rs 12,697 million, representing a fall of 43.4% over the corresponding nine months of last year.

Imports of “*Manufactured goods classified chiefly by material*” for the first nine months declined by 12.3% to reach Rs 15,525 million.

For the first nine months of 2009, imports of “*Machinery & transport equipment*” which were valued at Rs 18,039 million went down by 2.0%, the most important decrease being in “*Telecommunications and sound recording and reproducing apparatus and equipment*” (-36.1%).


3.3 Imports by country of origin – (First nine months 2009)

During the first nine months of 2009, imports from the Asian continent, our major supplier, amounted to Rs 41,131 million with a share of 49.7% of total imports.

Our imports originated mainly from the following countries: India (18.8%), China (12.3%), France (9.6%), South Africa (9.0%), Japan (3.3%), Australia (3.2%) and Malaysia (3.0%) . (Table 13).

4. Trade with Regional Organisations – (First nine months 2009)

Total exports to African, Caribbean and Pacific (ACP) States during the first nine months of 2009 stood at Rs 5,889 million, against imports of Rs 9,836 million (Table 14). The trade deficit with ACP countries worked out to Rs 3,947 million.

During the first nine months of 2009 our exports to COMESA countries attained Rs 3,662 million, while imports from these countries amounted to Rs 2,292 million resulting in a favourable trade balance of Rs 1,370 million for Mauritius. Madagascar was the main buyer with a share of 74.1%. The main products exported to Madagascar were preparations used in animal feed and wheat or meslin flour. Our main suppliers were Kenya (35.2%), Egypt (26.0%), Madagascar (18.3%) and Swaziland (10.0%). Our imports from Kenya consisted

mainly of live bovine animals other than pure-bred breeding animals while urea, cleaning preparations and iron bars constituted the main products imported from Egypt. (Table 15).

Trade with SADC countries for the first nine months of 2009 showed a deficit of Rs 3,700 million, resulting from imports of a value of Rs 8,490 million and exports worth Rs 4,790 million. The main supplier was South Africa (87.8%) and our main buyers were Madagascar (56.7%) and South Africa (39.2%) - (Table 16).

5. Trade in Freeport Zone - (First nine months 2009)

During the first nine months of 2009, total imports of the Freeport Zone stood at Rs 4,219 million, a figure which is higher by 10.8% compared to the corresponding period of last year. The main items imported through the Freeport were “Fish and fish preparations”, “Chemicals and related products” and “Textile yarn, fabrics and made up articles” (Table 12).

Re-exports to overseas markets were valued at Rs 5,282 million, showing a decrease of 19.9% when compared to the first nine months of 2008. The main items re-exported through the Freeport were “Fish and fish preparations”, “Articles of apparel and clothing accessories” and “Chemicals and related products” (Table 6).

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2007). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
