

External Trade – 1st Quarter 2012

1. Introduction

This issue of the Economic and Social Indicators presents external trade statistics for the first quarter of 2012 and for the years 2010 and 2011. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

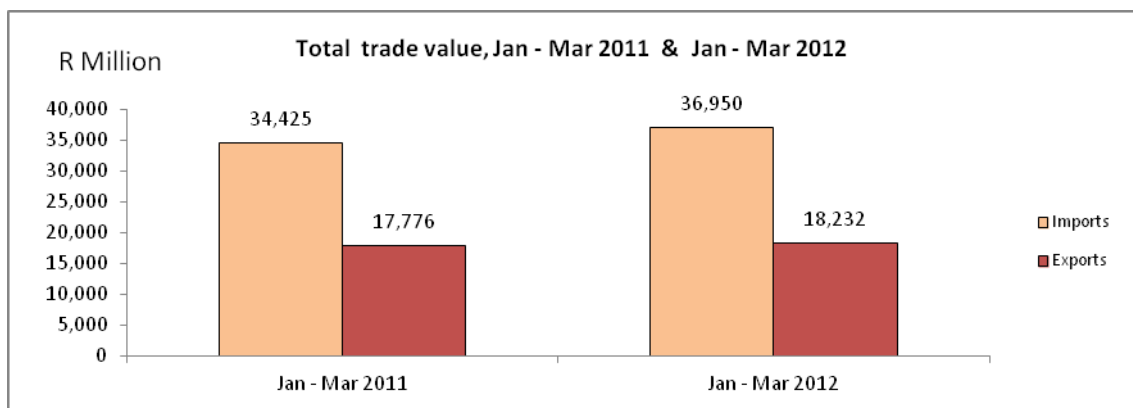
Thus while figures for 2010 published in this indicator are final, those for 2011 are subject to revision as and when the MRA - Customs Department submits latest amendments to the Statistics Mauritius.

Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. It is estimated that for the first quarter of 2012 some 20% of Freeport exports were sourced locally.

2. Total value of trade and trade balance

Total international trade for the first quarter of 2012 was valued at R 55,182 million, i.e. 11.0% lower than the previous quarter but 5.7% higher when compared to the corresponding quarter of 2011.

During the first quarter of 2012, total exports stood at R 18,232 million against imports of R 36,950 million. The resulting trade deficit for the first quarter 2012 worked out to R 18,718 million, 12.4% higher than the deficit of R 16,649 million in the first quarter of 2011.



3. Exports

3.1 Total exports (Table 1)

Total export proceeds for the first quarter of 2012, including domestic exports¹, re-exports² and ships' stores and bunkers, amounted to R 18,232 million, showing a decrease of 7.3% compared to the previous quarter and a rise of 2.6% the corresponding quarter of 2011 respectively.

Domestic exports, which accounted for 70.8% of total exports, went down by 5.9% from R 13,731 million in the previous quarter to R 12,916 million in the first quarter of 2012. Compared to the corresponding quarter of 2011, domestic exports were higher by 1.4%. For the first quarter of 2012, re-exports stood at R 2,604 million, higher by 1.7% compared to the previous quarter but lower by 4.1% compared to the corresponding period of last year.

3.2 Exports by SITC section (Table 3)

Exports of "Food and live animals" for the first quarter of 2012 amounted to R 5,447 million showing a decrease of 2.9% over the previous quarter. Compared to the corresponding quarter of 2011, total exports of this section increased by 9.5%, mostly explained by an increase of 33.9% in the exports of fish and fish preparations partly offset by a drop of 18.6 % in sugar.

During the first quarter of 2012, exports of "Manufactured goods classified chiefly by material" were valued at R 1,479 million, showing a slight increase of 0.2% compared to the previous quarter but a decrease of 10.5% compared to the corresponding quarter of 2011. The 10.5% decrease is explained mainly by lower export of "textile yarns, fabrics and made-up articles" (-12.5%) and "pearls and precious stones" (-10.7%).

Export proceeds from "Miscellaneous manufactured articles", amounted to R 7,191 million, representing decreases of 5.8% compared to the fourth quarter of 2011 and 2.2% compared to the first quarter of 2011. These articles represented 46.3% of total exports in the first quarter of 2012.

3.3 Exports of Export Oriented Enterprises (Table 1)

During the first quarter of 2012, exports of the EOE amounted to R 10,880 million showing a decrease of 2.1% compared to the previous quarter and an increase of 3.9% compared to the corresponding period of 2011. Details on transactions of these enterprises will be presented in the Economic and Social Indicators on the Export Oriented Enterprises, to be released on 28 June 2012.

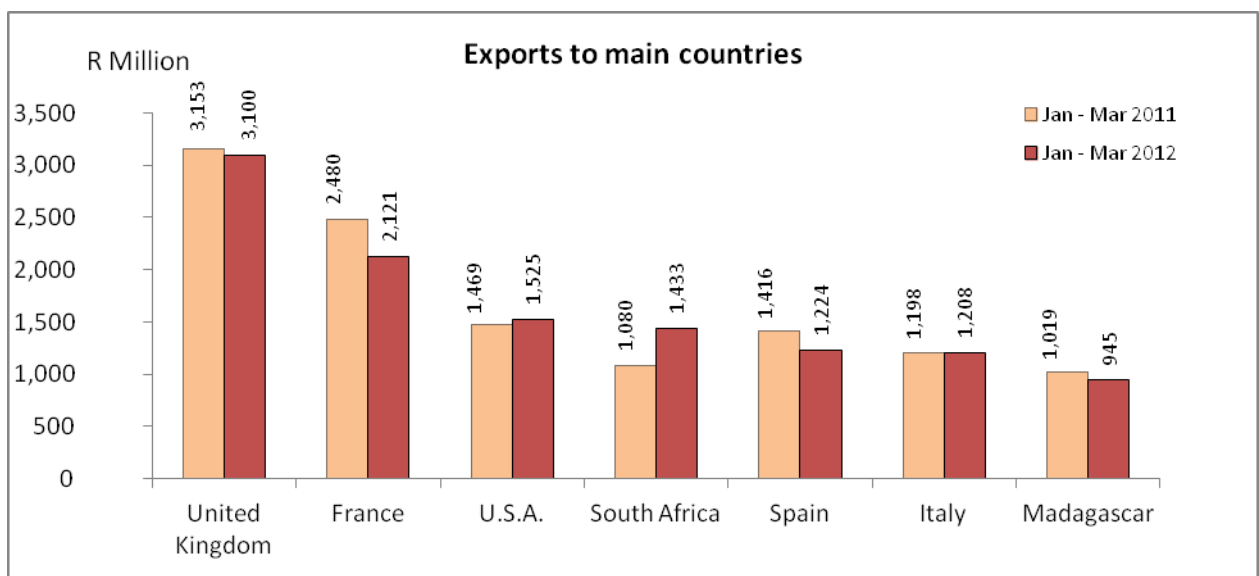
¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

3.4 Exports by country of destination (Table 7)

Analysis by country of destination for the first quarter of 2012 shows that the European countries were the main buyers, purchasing 60.7% of our exports for a value of R 9,427 million. The United Kingdom remained our main client with R 3,100 million, representing 20.0% of total exports. The other major destinations for our exports were France (13.7%), U.S.A (9.8%), South Africa (9.2%), Spain (7.9%), and Italy (7.8%).

Compared to the first quarter of 2011, total exports to our major markets, namely France, Spain and UK fell by 14.5%, 13.6% and 1.7% respectively. However, increases were noted in our exports to South Africa (+32.7%) and USA (+3.8%). Further details are given in Table 7.



4. Imports

4.1 Total imports (Table 1)

Total imports for the first quarter of 2012 dropped by 12.8% from R 42,365 million in the previous quarter to R 36,950 million but increased by 7.3% compared to the corresponding quarter of 2011.

4.2 Imports by SITC section (Table 10)

Imports of “*Food and live animals*” for the first quarter of 2012 amounted R 6,251 million, showing a decrease of 21.9% over the previous quarter and an increase of 7.4% over the corresponding quarter of 2011. Decreases were noted mainly in imports of “*Fish and fish preparations*”, (41.3%) compared to the previous quarter and (4.8%) compared to the corresponding quarter of 2011.

The import bill of “*Mineral fuels, lubricants, & related products*” stood at R 8,814 million for the first quarter of 2012, representing a rise of 7.9% over the previous quarter. Compared to the corresponding period of 2011, it fell by 4%.

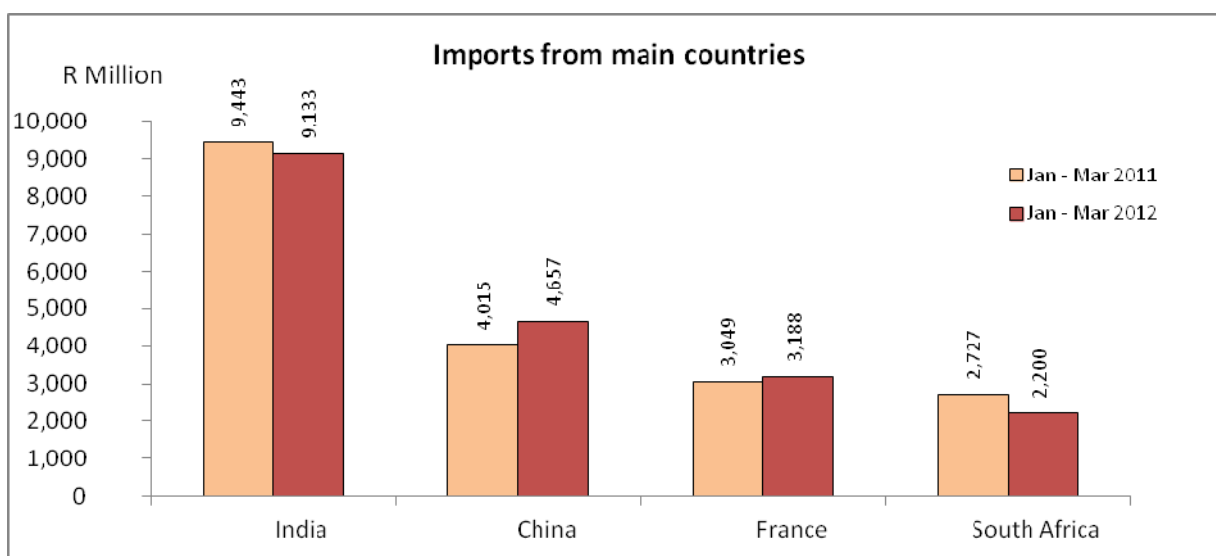
Imports of “*Manufactured goods classified chiefly by material*” declined by 17.8% compared to the previous quarter and by 3.1% compared to the first quarter of 2011.

For the first quarter of 2012, imports of “*Machinery & transport equipment*” stood at R 8,336 million. Imports of this section rose by 0.9% compared to the previous quarter and by 46.4% with respect to the corresponding quarter of 2011.

4.3 Imports by country of origin (Table 13)

During the first quarter of 2012, imports from the Asian continent, our major supplier, amounted to R 20,363 million with a share of 55.1% of total imports.

Our imports originated mainly from the following countries: India (24.7%), China (12.6%), France (8.6%) and South Africa (6.0%). The high share of India in our import bill is explained by the fact that India is our main supplier of petroleum products since the last quarter of 2006. Compared to the first quarter of 2011, the following changes were noted: China (+16.0%), France (+4.6%) and India (-3.3%).



5. Trade with Regional Organisations (Tables 14-16)

Total exports to African, Caribbean and Pacific (ACP) States during the first quarter of 2012 stood at R 2,930 million, against imports of R 3,535 million (Table 14). The trade deficit with ACP countries worked out to R 605 million.

During the first quarter of 2012 our exports to COMESA countries attained R 1,359 million, while imports from these countries amounted to R 955 million resulting in a positive trade balance of R 404 million for Mauritius. Madagascar was the main buyer with a share of 69.5%. The main products exported to Madagascar were coloured plain cotton weave

and yarn of carded wool. Our main suppliers were Egypt (31.2%), Kenya (27.2%) and Madagascar (20.6%). The main products imported from Egypt were iron and steel bars while cigarettes containing tobacco constituted the main product imported from Kenya.

Trade with SADC countries for the first quarter of 2012 showed a deficit of R 511 million, resulting from imports of a value of R 3,183 million and exports worth R 2,672 million. The main supplier was South Africa (69.1%) and our main buyers were South Africa (53.6%) and Madagascar (35.4%).

6. Trade in Freeport Zone (Table 2)

During the first quarter of 2012, total imports of the Freeport Zone stood at R 2,623 million, higher by 2.5% compared to the previous quarter and by 33.3% compared to the first quarter of 2011. The main items imported through the Freeport were “Fish and fish preparations” and “Chemicals & related products” (Table 12).

Re-exports to overseas markets were valued at R 1,555 million, registering decreases of 11.2% and 8.4% compared to the previous quarter and the corresponding quarter of 2011 respectively. The main items re-exported by the Freeport were “Fish and fish preparations”, “Chemicals and related products” and “Articles of apparel and clothing accessories”, sourced mainly from Export Oriented Enterprises (Table 6).

7. Forecast 2012

Based on recent past trends and indicative information from various sources, total exports including ships’ stores and bunkers for the year 2012 are expected to be of the order of R 80,000 million, against R 165,000 million for imports. The trade deficit would be around R 85,000 million.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2012). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
