

External Trade – 3rd Quarter 2012

1. Introduction

This issue of the Economic and Social Indicator presents external trade statistics for the first three quarter of 2012 and for the year 2010 and 2011. These statistics are compiled from declarations lodged at Customs by importer and exporter. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

Thus while revised figures for 2011 are published in this indicator those for 2012 are provisional and subject to revision by mid July 2013, when the MRA - Customs Department submits latest yearly amendments to Statistics Mauritius.


Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. It is estimated that for the third quarter of 2012 some 27% of Freeport exports were sourced locally.

2. Total value of trade and trade balance

Total international trade for the third quarter of 2012 was valued at R 58,683 million, i.e. 3.5% lower than the previous quarter but 5.1% higher than the corresponding quarter of 2011.

During the third quarter of 2012, total exports were valued at R 19,751 million against imports of R 38,932 million. The resulting deficit for the third quarter of 2012 worked out to R 19,181 million, 3.7% lower than the deficit of R 19,918 million the previous quarter. Compared to the corresponding quarter of the last year, the deficit was higher by 11.0% (R 17,283 million).



3. Exports

3.1 Total exports (Table 1)

Total export proceeds for the third quarter of 2012, including domestic exports¹, re-exports² and ship's stores and bunkers amounted to R 19,751 million, showing a decrease of 3.3% compared to the previous quarter but an increase of 2.5% compared to the corresponding period of 2011.

Domestic exports, which accounted for 72.6% of total exports, went up by 4.4% from R 13,738 million in the previous quarter to R 14,343 million in the third quarter of 2012. Compared to the corresponding quarter of 2011, domestic exports were higher by 6.2%. In the third quarter of 2012 re-exports stood at R 2,921 million, i.e. lower by 8.4% compared to the previous quarter but higher by 13.3% compared to the corresponding quarter of 2011.

Total exports for the first nine months of 2012 reached R 58,587 million, showing an increase of 8.6% over the first nine months of 2011.

3.2 Exports by SITC section (Table 3) - (First nine months 2012)

Exports of “Food and live animals” for the first nine months of 2012 amounted to R 17,506 million, showing a rise of 19.9% over the corresponding period of 2011. Export of “Fish and fish preparations” and “sugar” rose by 35.1% and 1.2% respectively.

For the first nine months of 2012, exports of “Manufactured goods classified chiefly by material” were valued at R 4,565 million, lower by 10.0% when compared to exports of R 5,070 million for the first nine months of 2011. This 10.0% decrease is explained by lower exports of “textile yarn, fabrics, made up articles” and “Pearls, precious and semi-precious stones”.

Total exports of “Machinery and transport equipment” for the first nine months of 2012 increased by 57.0% from R 1,112 million in the first nine months of 2011 to R 1,746 million in the first nine months of 2012. This increase is attributable to higher re-exports of “Machinery and transport equipment”

Export proceeds for the first nine months of 2012 from “Miscellaneous manufactured articles” increased by 3.6% compared to the corresponding period of 2011, to reach R 22,804 million from R 22,021 million. These articles represent 45.7% of total exports during the first nine months of 2012. Exports of “Articles of apparel & clothing accessories” representing 80.0% of exports of this section increased by 2.0% compared to the first nine months of 2011.

3.3 Exports of Export Oriented Enterprises (EOE) - (First nine months 2012)

During the first nine months of 2012, exports of the EOE amounted to R 34,031 million, up by 5.9% compared to the corresponding period of 2011 (Table 1). Details on exports of these enterprises will be presented in the Economic and Social Indicator on the Export Oriented Enterprises, which will be released by the Statistics Unit based at the Ministry of Industry on 17 December 2012 on website.


¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

3.4 Exports by country of destination (Table 7) - (First nine months 2012)

Analysis of exports figures by country of destination for the first nine months of 2012 shows that the European countries were our main buyers, purchasing some 58.9% of our exports for a value of R 29,392 million. The United Kingdom remained our main market with R 9,602 million, 19.2% of total exports. The other major destinations for our exports were France (13.4%), U.S.A (9.9%), South Africa (9.5%), Spain (8.1%), and Madagascar (6.7%).

Compared to the first nine months of 2011, total exports to USA fell by 2.6% while those to South Africa, Spain, Madagascar and UK went up by 28.7%, 20.9%, 12.1% and 4.5% respectively.



4. Imports

4.1 Total imports - (Table 1)

Total imports for the third quarter of 2012 reached R 38,932 million, showing a decrease of 3.5% over the previous quarter of 2012 but increased by 6.5% when compared to the corresponding quarter of 2011.

Total imports for the first nine months of 2012 amounted to R 116,234 million, showing an increase of 10.0% over the corresponding period of 2011.

4.2 Imports by SITC section (Table 10) - (First nine months 2012)

Imports of “*Food and live animals*” for the first nine months of 2012 were valued at R 20,665 million, higher by 9.2% compared to the corresponding period of last year. Increases were noted in imports of “fish and fish preparations” (+19.4%), “wheat” (+18.5%), “rice” (+6.1%) and “meat and meat preparations” (+5.3%).

The import bill of “*Mineral fuels, lubricants, & related products*” stood at R 25,732 million, representing an increase of 8.2% over the corresponding nine months of last year.


Imports of “*Manufactured goods classified chiefly by material*” for the first nine months rose by 1.2% to reach R 20,613 million. While imports of “*Cement*” increased by 41.4%, decreases were noted in “*Textile yarn*” (-30.6%), “*Paper, paperboard & articles thereof*” (-11.4%) and “*Cotton fabrics*” (-5.0%).

For the first nine months of 2012, imports of “*Machinery & transport equipment*” which were valued at R 24,393 million rose by 32.8% compared to the same period of last year.

4.3 Imports by country of origin – (First nine months 2012)

During the first nine months of 2012, imports from the Asian continent, our major supplier, amounted to R 65,846 million, representing 56.6% of total imports.

Our imports originated mainly from the following countries: India (23.5%), China (15.9%), France (8.0%) and South Africa (6.4%) - (Table 13).



5. Trade with Regional Organisations – (First nine months 2012)

Total exports to African, Caribbean and Pacific (ACP) States during the first nine months of 2012 stood at R 9,933 million, against imports of R 11,042 million (Table 14). The trade deficit with ACP countries worked out to R 1,109 million.

During the first nine months of 2012 our exports to COMESA member states attained R 4,699 million, while imports from these countries amounted to R 3,160 million resulting in a favourable trade balance of R 1,539 million for Mauritius. Madagascar was the main buyer with a share of 70.8%. Our main suppliers were Kenya (35.4%) and Egypt (26.1%) – (Table 15).

Trade with SADC countries for the first nine months of 2012 showed a deficit of R 286 million, resulting from imports value of R 9,461 million against exports worth

R 9,175 million. The main supplier was South Africa (80.0%) and our main buyers were South Africa (51.7%) and Madagascar (36.2%) - (Table 16).

6. Trade in Freeport Zone - (First nine months 2012)

During the first nine months of 2012, total imports of the Freeport Zone stood at R 7,148 million, higher by 17.1% compared to the corresponding period of last year. The main items imported through the Freeport were “Machinery and transport equipment”, “Fish and fish preparations”, “Beverages and tobacco” and “Chemicals and related products” (Table 12).

Re-exports to overseas markets valued at R 5,549 million, rose by 18.6% when compared to the first nine months of 2011. The main items re-exported through the Freeport were “Fish and fish preparations”, “Chemicals and related products” and “Machinery and transport equipment” (Table 6).

7. Forecast 2012

Based on past trends and indicative information from various sources, total exports (including ship's stores and bunkers) for the year 2012 are expected to be of the order of R 82,000 million, against R 163,000 million for imports. The trade deficit would be around R 81,000 million.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunker are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2012). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
