

External Merchandise Trade Statistics – 4th Quarter and Year 2018

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the years 2017 and 2018. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

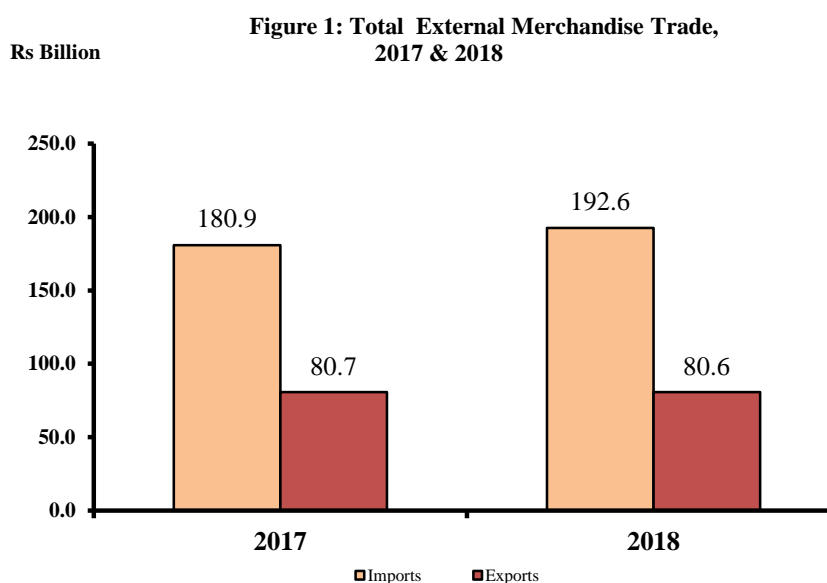
Thus, while revised figures for 2017 are published in this indicator, those for 2018 are provisional and subject to revision as and when MRA - Customs Department submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the fourth quarter of 2018 was valued at Rs 76,269 million, i.e. 6.8% higher than the previous quarter and 5.9% higher compared to the corresponding quarter of 2017.

During the fourth quarter of 2018, total exports (including ship's stores & bunkers) were valued at Rs 21,295 million against imports of Rs 54,974 million. The resulting trade deficit worked out to Rs 33,679 million, 14.0% higher than the deficit of Rs 29,540 million of the previous quarter and 5.3% higher than the deficit of Rs 31,999 million of the corresponding quarter of 2017.



3. Exports

3.1 Total exports (Tables 1 & 3) – 4th Quarter 2018

Total export proceeds for the fourth quarter of 2018, including domestic exports¹, re-exports² and ship's stores and bunkers amounted to Rs 21,295 million, showing an increase of 1.7% compared to the previous quarter. This is mainly explained by an increase in the exports of "Food and live animals" (+19.6%), partly offset by decreases in exports of "Manufactured goods classified chiefly by material" (-9.2%), "Miscellaneous manufactured goods" (-6.4%) and "Ship's stores and bunkers" (-1.1%).

Compared to the corresponding quarter of 2017, total exports for the fourth quarter of 2018 increased by 6.4%. This is mainly explained by increases in exports of "Ship's stores and bunkers" (+30.7%), "Food and live animals" (+9.9%), "Manufactured goods classified chiefly by material" (+2.8%) and "Miscellaneous manufactured goods" (+2.0%), partly offset by a decrease in export of "Chemicals and related products, n.e.s." (-0.4%).

Domestic exports amounting to Rs 12,832 million, accounted for 60.3% of total exports in the fourth quarter of 2018. Compared to a value of Rs 13,320 million recorded in the third quarter of 2018, domestic exports fell by 3.7%. When compared to the corresponding quarter of 2017, a decrease of 0.4% was observed.

In the fourth quarter of 2018, re-exports stood at Rs 5,039 million, i.e. higher by 21.3% compared to the previous quarter and by 11.9% compared to the corresponding quarter of 2017. (Table 5)

3.2 Exports by SITC section (Tables 1 & 3) – Year 2018

Around 40.4% of exports for the year 2018 consisted of "Miscellaneous manufactured goods" (Rs 27,294 million), 35.1% of "Food and live animals" (Rs 23,707 million), 11.9% of "Manufactured goods classified chiefly by material" (Rs 8,015 million) and 4.8% "Chemicals and related products, n.e.s." (Rs 3,247 million).

Compared to the year of 2017, the main changes by section are as follows:

- "Manufactured goods classified chiefly by material" registered an increase of 5.0%, mainly explained by an increase in exports of "Pearls, precious & semi-precious stones" (+24.2%).
- "Miscellaneous manufactured goods" increased by 2.7% mainly due to increases in the exports of "Articles of apparel & clothing accessories" (+1.3%).
- "Food and live animals" fell by 12.2%, due to a decrease of 40.3% in exports of "Cane Sugar" and 9.0% in exports of "Live primates".

¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

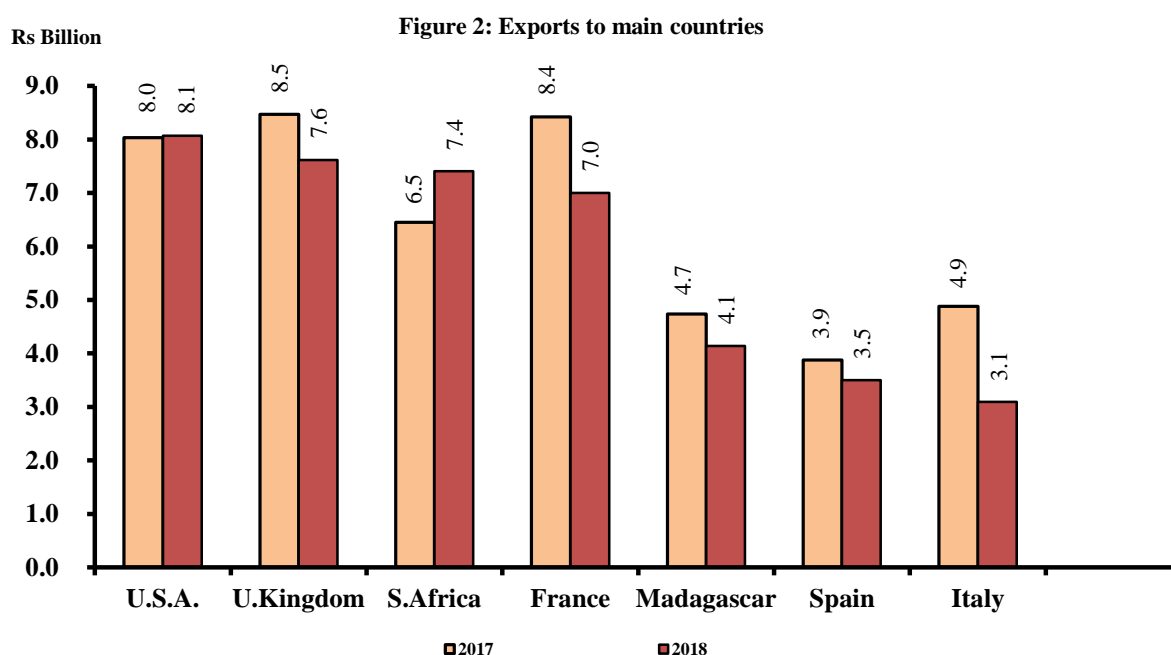
3.3 Exports of Export Oriented Enterprises (EOE) – Year 2018

During the year of 2018, exports of EOE amounted to Rs 43,518 million, compared to Rs 43,027 million in 2017 (Table 1). Further details on these transactions will be presented in the issue of the Economic and Social Indicators on Export Oriented Enterprises, to be released on 28 March 2019.

3.4 Exports by country of destination (Table 7) – Year 2018

Analysis of exports figures by country of destination for the year 2018 shows that the European countries were our main buyers, purchasing some 44.7% of our exports for a value of Rs 30,165 million. Among countries, the major destinations for our exports were U.S.A (12.0%), U.K (11.3%), South Africa (11.0%), France (10.4%), Madagascar (6.1%), Spain (5.2%) and Italy (4.6%).

Compared to the year 2017, exports to South Africa and U.S.A went up by 14.8% and 0.4% respectively. On the other hand, exports to Italy, France, Madagascar, UK and Spain dropped by 36.6%, 16.9%, 12.6%, 10.1% and 9.7% respectively.



4. Imports

4.1 Total imports (Table 10) – 4th Quarter 2018

Total imports for the fourth quarter of 2018 amounted to Rs 54,974 million, showing an increase of 8.9% over the previous quarter. This is mainly due to increases in imports of “Miscellaneous manufactured articles” (+34.4%), “Food and live animals” (+14.5%) “Mineral fuels, lubricants and related products” (+9.0%) and “Machinery and transport equipment” (+5.2%), partly offset by decreases in “Manufactured goods classified chiefly by materials” (-4.8%) and “Crude materials, inedible, except fuels” (-2.8%).

Compared to the corresponding quarter of 2017, imports in the fourth quarter of 2018 rose by 5.7%. This is mainly due to increases in imports of “Mineral fuels, lubricants and related products” (+21.8%), “Miscellaneous manufactured goods” (+8.1%) and “Machinery &

transport equipment” (+7.3%), partly offset by a decrease in “Food and live animals” (-4.2%).

4.2 Imports by SITC section (Table 10) – Year 2018

Around 22.9% of imports in the year of 2018 consisted of “Machinery and transport equipment” (Rs 44,135 million), 20.0% of “Mineral fuels, lubricants and related materials” (Rs 38,457 million), 18.1% of “Food and live animals” (Rs 34,811 million), 15.5% of “Manufactured goods classified chiefly by materials” (Rs 29,905 million).

Compared to 2017, total imports increased by 6.5%. Main changes by section are as follows:

- “Mineral fuels, lubricants, & related products” increased by 26.1%, mainly due to an increase of 32.5% in the imports of “Refined petroleum products”.
- “Manufactured goods classified chiefly by material” went up by 9.1%, mainly due to increases in the imports of “Pearls, precious & semi-precious stones” (+34.8%), “Iron and steel” (+28.4%) and “Manufactures of metal, n.e.s” (+5.2%), partly offset by decreases in imports of “Other textile fabrics” (-7.4%) and “Textile yarn” (-6.5%).
- “Chemicals and related products, n.e.s.” rose by 9.0%, mainly due to increases in the imports of “Plastics in primary forms” (+19.8%) and “Medicinal & pharmaceutical products” (+12.2%).
- “Miscellaneous manufactured articles” increased by 7.0%, mainly due to increases in “Articles n.e.s., of plastic” (+12.7%), “Footwear” (+12.2%) and “Articles of apparel and clothing” (+1.6%).
- “Machinery and transport equipment” increased by 5.2%, mainly due to increases in “Telecommunications and sound recording apparatus and reproducing apparatus and equipment” (+22.3%), “Electrical machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (+14.9%) and “Road vehicles” (+7.2%), partly offset by decreases in imports of “General industrial machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (-8.7%).

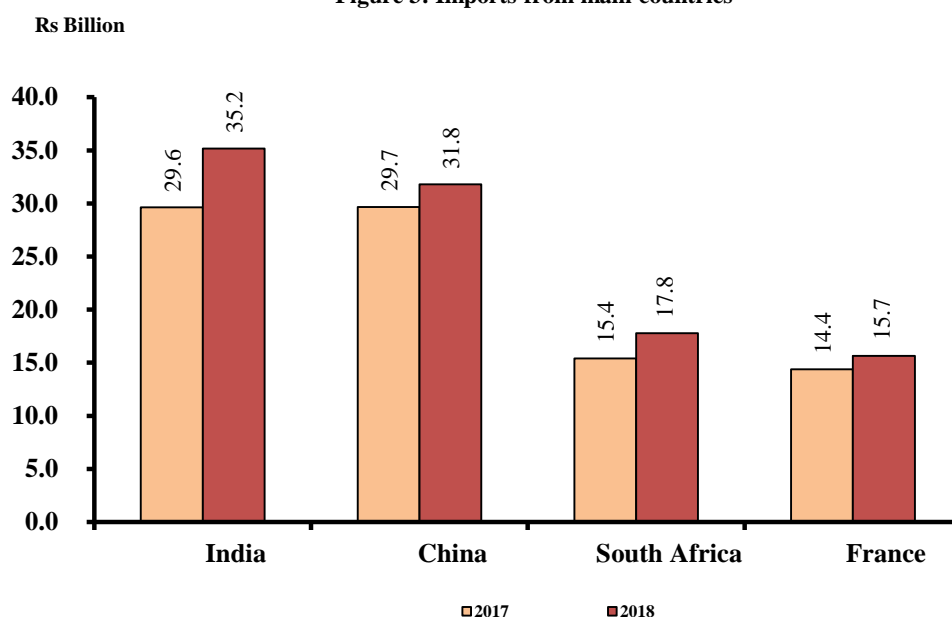
4.3 Imports by country of origin – Year 2018

During the year 2018, more than half of our imports originated from four main countries, namely: India (18.3%), China (16.5%), South Africa (9.2%) and France (8.1%) (Table 13).

Among continents Asia was our main supplier with a share of Rs 103,322 million, representing 53.6% of total imports.

Compared to 2017, total imports from India, South Africa, France and China rose by 18.6%, 15.5%, 8.9% and 7.2% respectively.

5. Trade with Member States of Regional Organisations – Year 2018

During the year of 2018, total exports to African, Caribbean and Pacific (ACP) States stood at Rs 16,124 million against imports of Rs 24,539 million (Table 14). The trade deficit with ACP countries worked out to Rs 8,415 million.

Exports to COMESA member states attained Rs 7,914 million while imports from these countries amounted to Rs 7,104 million, resulting in a trade surplus of Rs 810 million. Madagascar was the main buyer with a share of 52.3%. Our main suppliers were Seychelles (26.6%), Madagascar (25.4%) and Kenya (19.6%) - (Table 15).

Trade with SADC countries showed a deficit of Rs 9,415 million, resulting from imports of Rs 22,799 million against exports worth Rs 13,384 million. The main supplier was South Africa (78.0%) and our main buyers were South Africa (55.3%) and Madagascar (30.9%) - (Table 16).

6. Trade in Freeport Zone – Year 2018

During the year 2018, total imports of the Freeport Zone stood at Rs 11,426 million, lower by 8.3% compared to 2017 – (Table 12). Re-exports were valued at Rs 12,874 million, representing a decrease of 3.6% compared to 2017 (Table 6). The main items imported and re-exported were “Food and live animals” and “Miscellaneous manufactured goods”.

7. Forecast 2019

Based on recent trends and information from various sources, total imports (including one-off items such as aircraft, wind turbines and metro trains) are forecasted at around Rs 212,000 million and total exports will be at around Rs 83,000 million for the year 2019. The trade deficit is therefore expected to be around Rs 129,000 million in 2019.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2012)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the **Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the **Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
