

External Merchandise Trade Statistics – 3rd Quarter 2019

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the first three quarters of 2019 and the years 2017 and 2018. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.

Thus, while revised figures for 2017 & 2018 are published in this indicator, those for 2019 are still provisional and subject to revision as and when MRA - Customs Department submits latest amendments to Statistics Mauritius.

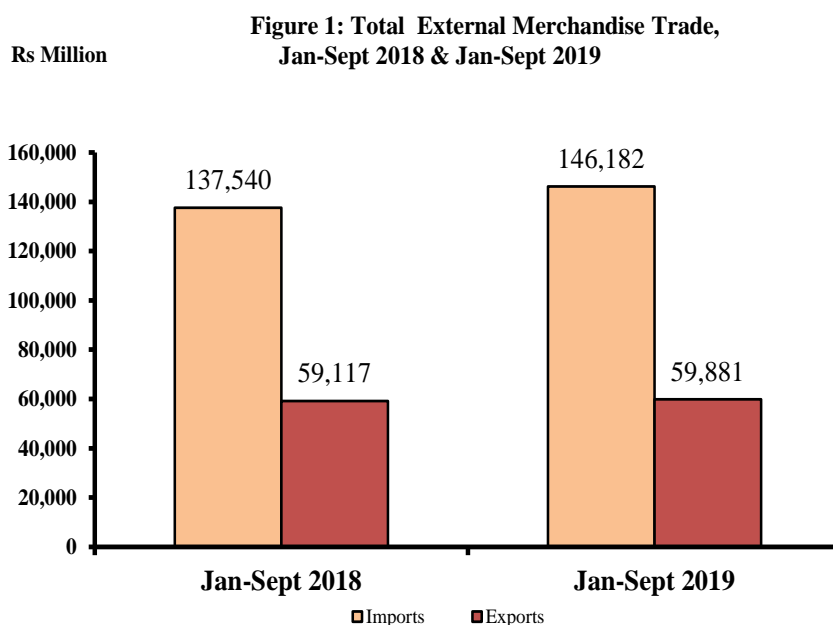
Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the third quarter of 2019 was valued at Rs 71,432 million, i.e. 3.5% higher than the previous quarter and 0.2% higher compared to the corresponding quarter of 2018.

During the third quarter of 2019, total exports (including ship's stores & bunkers) were valued at Rs 20,056 million against imports of Rs 51,376 million. The resulting trade deficit worked out to Rs 31,320 million, 11.6% higher than the deficit of Rs 28,062 million of the previous quarter and 5.8% higher than the deficit of Rs 29,605 million of the corresponding quarter of 2018.

For the first nine months of 2019, total exports worked out to Rs 59,881 million and total imports to Rs 146,182 million. Total exports and total imports for January to September 2018 were Rs 59,117 million and Rs 137,540 million respectively as illustrated in figure 1.



3. Exports

3.1 Total exports (Tables 1 & 3) – 3rd Quarter 2019

Total export proceeds for the third quarter of 2019, including domestic exports¹, re-exports² and ship's stores and bunkers amounted to Rs 20,056 million, showing a decrease of 2.0% compared to the previous quarter. This is mainly explained by decreases in exports of "Machinery and transport equipment" (-25.3%), "Food and live animals" (-12.9%), "Manufactured goods classified chiefly by material" (-7.0%) and "Miscellaneous manufactured goods" (-5.9%) partly offset by increases in exports of "Ship's stores and bunkers" (+42.4%) and "Chemicals & related products, n.e.s" (+18.1%).

Compared to the corresponding quarter of 2018, total exports for the third quarter of 2019 decreased by 3.8%. This is mainly explained by decreases in exports of "Machinery and transport equipment" (-18.6%), "Miscellaneous manufactured goods" (-10.7%) and "Food and live animals" (-8.3%) partly offset by increases in exports of "Ship's stores and bunkers" (+15.4%), "Manufactured goods classified chiefly by material" (+6.3%) and "Chemicals and related products, n.e.s" (+0.5%).

Domestic exports amounting to Rs 12,753 million, accounted for 63.6% of total exports in the third quarter of 2019. Compared to a value of Rs 13,896 million recorded in the previous quarter, domestic exports decreased by 8.2% and showed a decrease of 3.8% compared to the corresponding quarter of 2018.

In the third quarter of 2019, re-exports stood at Rs 3,305 million, i.e. lower by 12.1% compared to the previous quarter, mainly due to decreases in re-exports of "Machinery and transport equipment" (-25.0%), "Food and live animals" (-17.5%) and "Miscellaneous manufactured articles" (-4.9%), partly offset by increases in re-exports of "Chemicals & related products, n.e.s" (+20.9%) and "Manufactured goods classified chiefly by material" (+11.2%). Compared to the corresponding quarter of 2018 re-exports were lower by 20.1%, mainly due to decreases in the re-exports of "Food and live animals" (-33.1%), "Machinery and transport equipment" (-20.3%), "Miscellaneous manufactured goods" (-15.7%) and "Chemicals and related products, n.e.s" (-6.7%) partly offset by an increase in the re-exports of "Manufactured goods classified chiefly by material" (+11.6%) (Table 5).

3.2 Exports by SITC section (Tables 1 & 3) – Jan to Sept 2019

Around 32.6% of total exports for the first nine months of 2019 consisted of "Miscellaneous manufactured goods" (Rs 19,531 million), 29.1% of "Food and live animals" (Rs 17,437 million), and 12.1% of "Manufactured goods classified chiefly by material" (Rs 7,227 million).

Compared to the first nine months of 2018, the main changes by section are as follows:

- "Manufactured goods classified chiefly by material" rose by 22.0%, mainly explained by increases in exports of Pearls, precious and semi-precious stones" (+28.2%) and "Textile yarns, fabrics, made up articles" (+23.1%).
- "Food and live animals" registered an increase of 2.8%, mainly due to increases in exports of "Cane sugar" (+36.7%) and "Live primates" (35.7%).

¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

- “Machinery and transport equipment” dropped by 4.3%.
- “Miscellaneous manufactured goods” decreased by 3.6% mainly due to decreases in the exports of “Jewellery, goldsmiths & silver smith wares” (-14.1%) and “Articles of apparel & clothing accessories” (-5.6%).

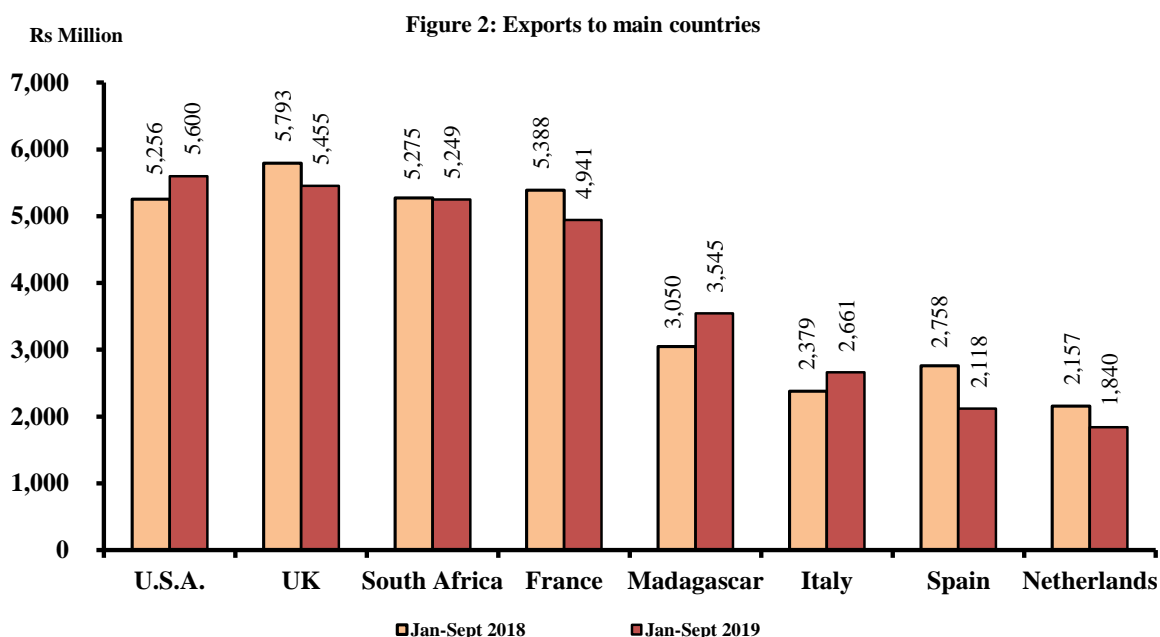
3.3 Exports of Export Oriented Enterprises (EOE) – Jan to Sept 2019

During the first nine months of 2019, exports of EOE amounted to Rs 32,368 million, compared to Rs 32,700 million in the corresponding period of 2018 (Table 1). Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 23 December 2019.

3.4 Exports by country of destination (Table 7) – Jan to Sept 2019

Analysis of exports figures by country of destination for the first nine months of 2019 shows that the European countries were our main buyers, purchasing 44.5% of our exports for a value of Rs 22,297 million. Among countries, the major destinations for our exports were USA (11.2%), UK (10.9%), South Africa (10.5%), France (9.9%), Madagascar (7.1%), Italy (5.3%) and Spain (4.2%).

Compared to the corresponding period of 2018, exports to Madagascar, Italy and USA went up by 16.2%, 11.9% and 6.5% respectively. On the other hand, exports to Spain, Netherlands, France, UK and South Africa dropped by 23.2%, 14.7%, 8.3%, 5.8% and 0.5% respectively.



4. Imports

4.1 Total imports (Table 10) – 3rd Quarter 2019

Total imports for the third quarter of 2019 amounted to Rs 51,376 million, showing an increase of 5.9% over the previous quarter. This is mainly due to increases in imports of “Machinery and transport equipment” (+13.4%), “Mineral fuels, lubricants and related

products” (+10.6%), “Miscellaneous manufactured articles” (+10.5%) and “Food and live animals” (+2.4%), partly offset by a decrease in the imports of “Manufactured goods classified chiefly by material” (-3.6%),

Compared to the corresponding quarter of 2018, imports in the third quarter of 2019 rose by 1.8%. This is mainly due to increases in imports of “Miscellaneous manufactured articles” (+20.7%), “Chemicals and related products” (+5.8%) and “Machinery and transport equipment” (+5.3%), partly offset by decreases in the imports of “Manufactured goods classified chiefly by materials” (-5.1%), “Food and live animals” (-1.5%) and “Mineral fuels, lubricants and related products” (-1.0%).

4.2 Imports by SITC section (Table 10) – Jan to Sept 2019

Around 23.4% of imports in the first nine months of 2019 consisted of “Machinery and transport equipment” (Rs 34,136 million), 19.0% of “Mineral fuels, lubricants and related materials” (Rs 27,770 million), 17.7% of “Food and live animals” (Rs 25,933 million) and 16.5% of “Manufactured goods classified chiefly by materials” (Rs 24,084 million).

Compared to the corresponding period of 2018, total imports increased by 6.3%. Main changes by section are as follows:

- “Miscellaneous manufactured articles” went up by 12.4%, mainly due to increases in the imports of “Articles of apparel and clothing” (+32.0%), “Footwear” (+19.3%) and “Articles n.e.s., of plastic” (+10.1%).
- “Manufactured goods classified chiefly by material” increased by 9.9%, mainly due to increases in the imports of “Manufactures of metals, n.e.s.” (+40.3%), “Cement” (+36.7%) and “Iron and steel” (+8.8%), partly offset by decreases in the imports of “Cotton fabrics” (-13.3%) and “Other Textile Fabrics” (-3.4%).
- “Chemicals & related products” increased by 9.1%, mainly due to higher imports of “Medicinal & pharmaceutical products” (+13.5%).
- “Machinery and transport equipment” rose by 8.8%, mainly due to increases in the imports of “General industrial machinery & equipment, n.e.s., & machine parts, n.e.s.” (+23.1%) and “Road vehicles” (+9.8%), partly offset by decreases in the imports of “Telecommunications & sound recording & reproducing apparatus & equipment” (-3.1%) and “Electrical machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (-2.9%).
- “Food and live animals” rose by 4.9%, mainly due to increases in the imports “Meat and meat preparations” (+4.6%), “Vegetables and fruits” (+2.8%), “Dairy products and bird's eggs” (+1.8%) and “Fish and fish preparations” (+1.2%).

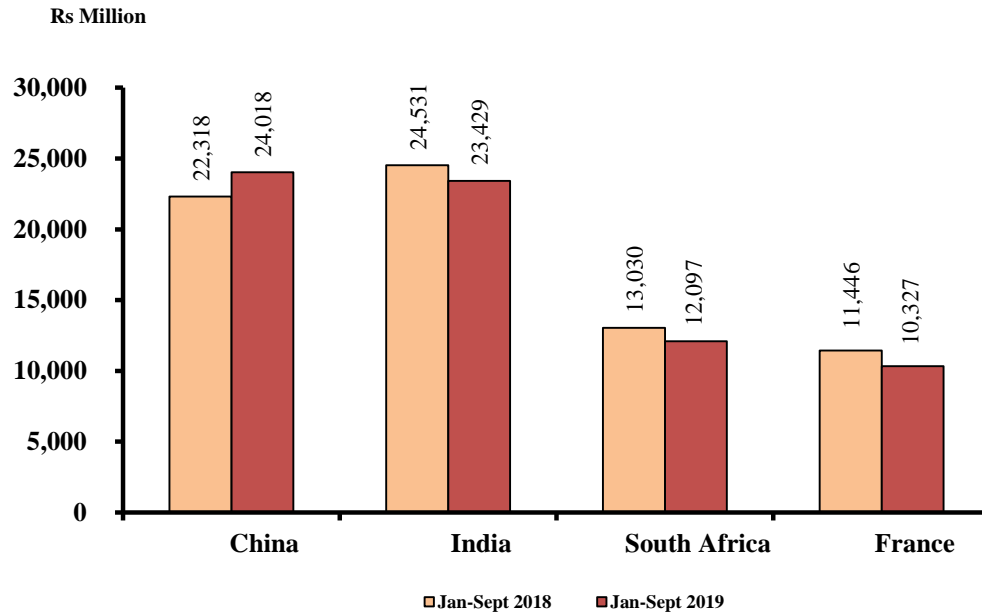
4.3 Imports by country of origin – Jan to Sept 2019

During the first nine months of 2019, our imports originated from four main countries, namely: China (16.4%), India (16.0%), South Africa (8.3%) and France (7.1%) (Table 13).

Among continents, Asia was our main supplier with a share of Rs 79,338 million, representing 54.3% of total imports.

Compared to the corresponding period of 2018, total imports from China rose by 7.6%, while imports from France, South Africa and India decreased by 9.8%, 7.2% and 4.5% respectively.

5. Trade with Member States of Regional Organisations – Jan to Sept 2019

During the first nine months of 2019, total exports to African, Caribbean and Pacific (ACP) States stood at Rs 12,230 million against imports of Rs 17,189 million (Table 14). The trade deficit with ACP countries worked out to Rs 4,959 million.

Exports to COMESA member states attained Rs 6,304 million while imports from these countries amounted to Rs 5,436 million, resulting in a trade surplus of Rs 868 million. Madagascar was the main buyer with a share of 56.2%, followed by Kenya (23.3%). Our main suppliers were Seychelles (28.1%), Egypt (19.0%) and Kenya (18.5%) - (Table 15).

Trade with SADC countries showed a deficit of Rs 5,701 million, resulting from imports of Rs 15,817 million against exports worth Rs 10,116 million. The main supplier was South Africa (76.5%) and our main buyers were South Africa (51.9%) and Madagascar (35.0%) - (Table 16).

6. Trade in Freeport Zone – Jan to Sept 2019

During the first nine months of 2019, total imports of the Freeport Zone stood at Rs 7,905 million, lower by 0.5% compared to the corresponding period of 2018 – (Table 12). Re-exports were valued at Rs 8,047 million, representing a decrease of 7.3% compared to the corresponding period of 2018 (Table 6). The main items imported and re-exported were “Food and live animals”, “Miscellaneous manufactured articles” and “Chemicals & related products, n.e.s”.

7. Forecast 2019

Based on trends and information from various sources, the forecast of total exports for 2019 will be around Rs 82,500 million lower than the previous exports forecast figure of Rs 83,000 million. Total Imports for 2019 is forecasted around Rs 206,600 million, lower than the previous forecast figure of Rs 207,800 million. To note that the forecast includes one – off items such as tugs, linear accelerator for cancer treatment and metro trains.

The trade deficit for 2019 is forecasted to be around Rs 124,100 million, compared to Rs 112,100 million in 2018.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the **Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
