

External Merchandise Trade Statistics

4th Quarter and Year 2021

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the years 2020 and 2021. These statistics are compiled from declarations lodged at the Customs Department of the Mauritius Revenue Authority (MRA), by importers and exporters. Some of these declarations are usually revised at a later period and corrections are made accordingly on the computerised database at the Customs Department.

Thus, while revised figures for 2020 are published in this indicator, those for 2021 are still provisional and subject to revision as and when the Customs Department of the MRA submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

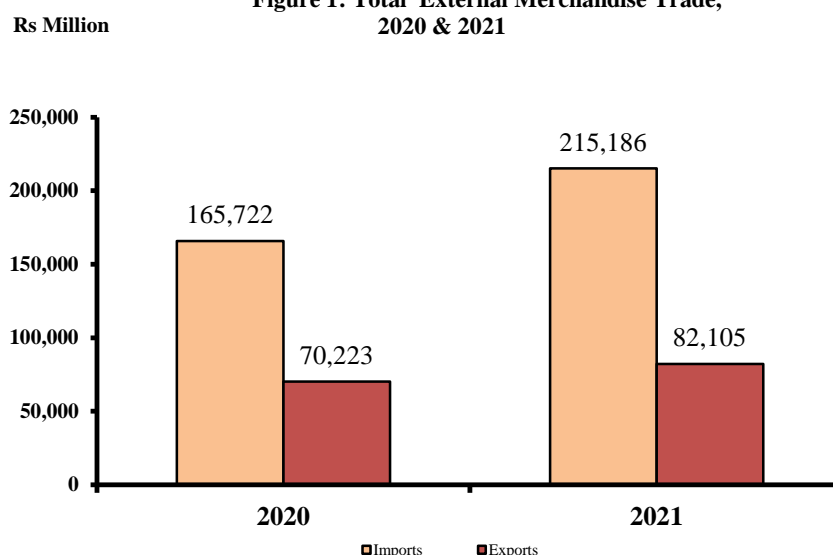
2. Total value of trade and trade balance

Total external merchandise trade for the fourth quarter of 2021 was valued at Rs 90,708 million, i.e. 17.6% higher than the value of Rs 77,115 million of the previous quarter and 35.8% higher than the value of Rs 66,786 million of the corresponding quarter of 2020.

For the fourth quarter of 2021, total exports (including ship's stores & bunkers) were valued at Rs 23,031 million against imports of Rs 67,677 million. This resulted in a trade deficit of Rs 44,646 million, 37.1% higher than the deficit of Rs 32,567 million of the previous quarter and 60.4% higher than the deficit of Rs 27,838 million of the corresponding quarter of 2020.

Total export proceeds for the year 2021 stood at Rs 82,105 million, representing an increase of 16.9% over the 2020 figure of Rs 70,223 million. Total imports for the year 2021 amounted to Rs 215,186 million, representing an increase of 29.8%, compared to Rs 165,722 million in 2020. The trade deficit for year 2021 worked out to Rs 133,081 million, around 39.4% higher than the deficit of Rs 95,499 million for the year 2020.

3. Exports

3.1 Total exports (Tables 1 and 3) - 4th Quarter 2021

Total exports for the fourth quarter of 2021, including domestic exports¹, re-exports² and ship's stores and bunkers, amounted to Rs 23,031 million, showing an increase of 3.4% compared to the previous quarter. This is explained by increases in the exports of "Crude materials, inedible, except fuels" (+23.8%), "Food and live animals" (+16.6%), "Manufactured goods classified chiefly by material" (+9.8%) and "Ship's stores and bunkers" (+4.3%), partly offset by decreases in the exports of "Machinery and transport equipment" (-23.1%), "Miscellaneous manufactured articles" (-6.6%) and "Chemicals and related products, n.e.s." (-6.5%).

Compared to the corresponding quarter of 2020, total exports for the fourth quarter of 2021 increased by 18.3%. This is mainly explained by increases in exports of "Crude materials, inedible, except fuels" (+141.6%), "Ship's stores and bunkers" (+83.9%), "Chemicals and related products, n.e.s." (+21.1%), "Manufactured goods classified chiefly by material" (+19.3%), "Miscellaneous manufactured articles" (+11.2%) and "Food and live animals" (+3.1%), partly offset by a decrease in the exports of "Machinery and transport equipment" (-8.5%).

3.2 Domestic Exports

Domestic exports for the fourth quarter of 2021 amounting to Rs 14,240 million accounted for 61.8% of total exports. Compared to a value of Rs 13,625 million recorded in the third quarter of 2021, domestic exports increased by 4.5%. When compared to the corresponding quarter of 2020 an increase of 0.9% was observed (*Table 4*).

3.3 Re-exports

In the fourth quarter of 2021, re-exports stood at Rs 5,243 million i.e lower by 0.1% compared to previous quarter, and higher by 52.5% compared to the corresponding quarter of 2020. (*Table 5*)

3.4 Exports by SITC sections (Tables 1 and 3) - Year 2021

Total export proceeds for the year 2021 stood at Rs 82,105 million, representing an increase of 16.9% over the 2020 figure of Rs 70,223 million. Around 31.1% of total exports consisted of "Miscellaneous manufactured articles" (Rs 25,534 million), 28.8% of "Food and live animals" (Rs 23,607 million), 14.8% of "Ship's stores and bunkers" (Rs 12,112 million) and 13.4% of "Manufactured goods classified chiefly by material" (Rs 10,970 million).

Compared to the year of 2020, the main changes by section were as follows:

- "Manufactured goods classified chiefly by material" increased by 27.5% mainly as a result of increases in the exports of "Pearls, precious & semi-precious stones" (+40.7%) and "Textile yarns, fabrics, made-up articles" (+22.2%)".
- "Miscellaneous manufactured articles" registered an increase of 24.0%, mainly explained by an increase in exports of "Articles of apparel & clothing accessories" (+12.3%).

¹ Domestic exports are defined as goods of national origin.

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

- “Food and live animals” increased by 1.9%, mainly due to an increase of 56.9% in exports of “Live Primates”, partly offset by decreases in the exports of “Cane sugar” (-3.4%) and “Fish & fish preparations” (-3.1%).

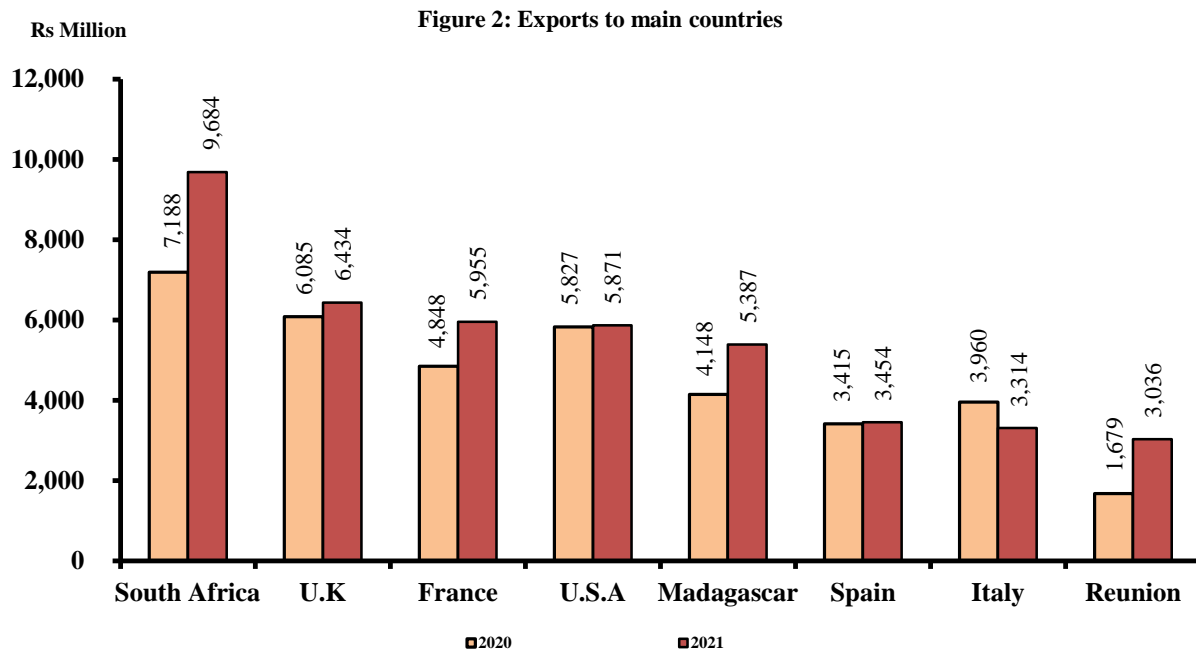
3.5 Exports of Export Oriented Enterprises (EOE)

For the year 2021, exports of EOE amounted to Rs 42,743 million, compared to Rs 37,289 million in 2020, representing an increase of 14.6%.

Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 30 March 2022.

3.6 Exports by country of destination (Table 7) –Year 2021

Analysis of exports figures by country of destination for the year 2021 shows that the European countries were our main buyers, purchasing around 40.4% of our exports excluding Ship’s stores and Bunkers, for a value of Rs 28,295 million. Among countries, the major destinations for our exports were South Africa (13.8%), United Kingdom (9.2%), France (8.5%), U.S.A. (8.4%), Madagascar (7.7%), Spain (4.9%), Italy (4.7%) and Reunion (4.3%).



Compared to the year 2020, exports to Reunion, South Africa, Madagascar, France, United Kingdom, Spain and U.S.A increased by 80.8%, 34.7%, 29.9%, 22.8%, 5.7%, 1.1% and 0.8% respectively. On the other hand, exports to Italy decreased by 16.3%.

4. Total Imports (Table 10) - 4th Quarter 2021

Total imports for the fourth quarter of 2021 amounted to Rs 67,677 million, showing an increase of 23.4%, compared to the previous quarter. This is due to increases in imports of “Miscellaneous manufactured articles” (+35.0%), “Mineral fuels, lubricants, & related products” (+34.2%), “Chemicals and related products, n.e.s.” (+32.6%), “Machinery & transport equipment” (+29.1%), “Manufactured goods classified chiefly by materials” (+8.4%) and “Food and live animals” (+7.2%).

Compared to the corresponding quarter of 2020, total imports for the fourth quarter of 2021 increased by 43.0%. This rise is due to increases in imports of “Mineral fuels, lubricants, & related products” (+119.4%), “Chemicals and related products” (+54.3%), “Manufactured goods classified chiefly by material” (+47.3%), “Machinery & transport equipment” (+23.6%), “Miscellaneous manufactured articles” (+22.2%) and “Food and live animals” (+18.6%).

4.1 Imports by SITC section (Table 10) – Year 2021

Total imports, for the year 2021 amounted to Rs 215,186 million, an increase of 29.8%, compared to Rs 165,722 million in 2020. Around 19.6% of imports in year 2021 consisted of “Machinery & transport equipment” (Rs 42,089 million), 18.5% of “Food and live animals” (Rs 39,878 million), 17.5% of “Manufactured goods classified chiefly by material” (Rs 37,717 million), 17.2% of “Mineral fuels, lubricants, & related products” (Rs 37,029 million), 11.5% of “Chemicals and related products, n.e.s.” (Rs 24,810 million) and 9.9% of “Miscellaneous manufactured articles” (Rs 21,255 million).

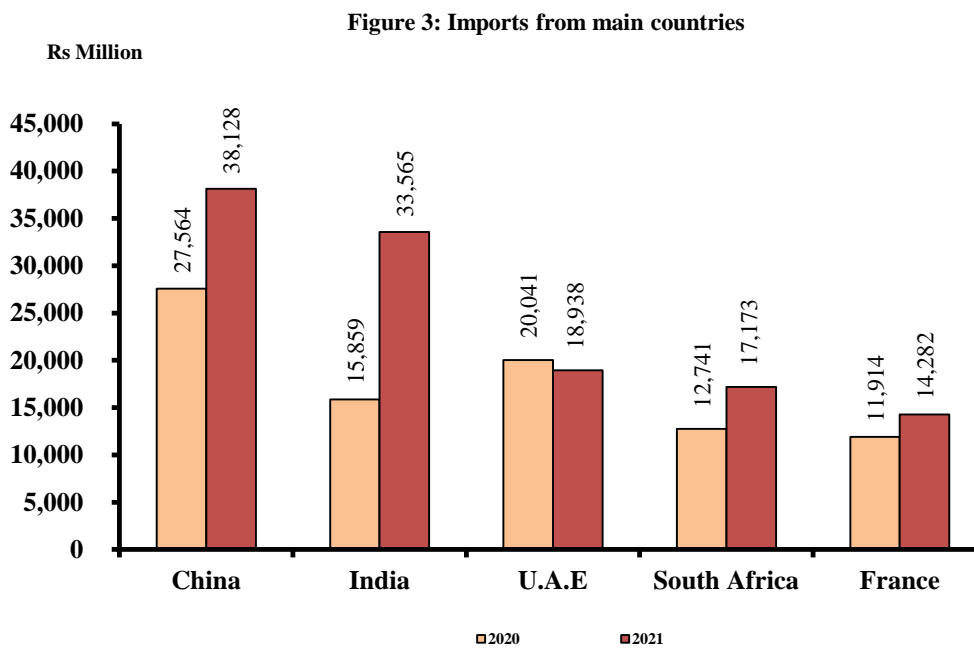
Compared to the year 2020, total imports for 2021 increased by 29.8%. Main changes by section were as follows:

- “Mineral fuels, lubricants, & related products” (+50.7%), mainly due to increases in imports of “Gas, natural and manufactured” (+48.7%) and “Refined petroleum products” (+47.5%).
- “Chemicals and related products, n.e.s.” (+49.0%), mainly due to increases in imports of “Plastics in primary forms” (+76.8%) and “Medicinal & pharmaceutical products” (+66.8%).
- “Manufactured goods classified chiefly by material” (+40.5%), mainly due to increases in imports of “Pearls, precious & semi-precious stones” (+83.9%), “Textile yarn” (+74.0%), “Iron and steel” (+64.2%), “Other textile fabrics” (+23.4%) and “Manufactures of metal, n.e.s.” (+20.6%).
- “Miscellaneous manufactured articles” (+35.0%), mainly due to increases in imports of “Articles of apparel and clothing” (+37.5%), “Footwear” (+30.1%), “Professional, scientific & controlling instruments & apparatus, n.e.s.” (+25.2%) and “Articles n.e.s, of plastic” (+18.1%).
- “Machinery & transport equipment” (+15.0%), mainly due to increases in imports of “Electrical machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (+21.6%), “Road vehicles” (+20.8%), “Telecommunications & sound recording & reproducing apparatus & equipment” (+20.7%) and “General industrial machinery & equipment, n.e.s., & machine parts, n.e.s.” (+9.6%).
- “Food and live animals” (+11.4%), due to increases in imports of “Meat and meat preparations” (+10.1%), “Vegetables and fruits” (+5.5%), “Fish and fish preparations” (+2.8%) and “Dairy products and bird’s eggs” (+0.2%).

4.2 Imports by country of origin – Year 2021

For the year 2021, our imports originated from five main countries, namely: China (17.7%), India (15.6%), United Arab Emirates (8.8%), South Africa (8.0%) and France (6.6%). Among continents, Asia was our main supplier with a share of Rs 119,787 million, representing 55.7% of total imports. (Table 13)

Compared to 2020, total imports from India, China, South Africa and France went up by 111.6%, 38.3%, 34.8% and 19.9% respectively, while imports from United Arab Emirates fell by 5.5%.



5. Trade with Member States of Regional Organizations – Year 2021

Total exports to African, Caribbean and Pacific (ACP) States stood at Rs 20,116 million against imports of Rs 24,226 million. The trade deficit with ACP countries worked out to Rs 4,110 million. South Africa is the main supplier and buyer, with a share of 70.9% and 48.1% respectively. (Table 14)

Exports to COMESA member states attained Rs 9,230 million while imports from these countries amounted to around Rs 7,660 million, resulting in a trade surplus of Rs 1,570 million. Madagascar was the main buyer with a share of 58.4% followed by Kenya (22.9%). Our main suppliers were Seychelles (35.8%), Kenya (23.9%), Egypt (17.8%) and Madagascar (15.1%). (Table 15)

Trade with SADC countries showed a deficit of Rs 5,018 million, resulting from imports of Rs 21,813 million against exports worth Rs 16,795 million. The main buyers were South Africa (57.7%) and Madagascar (32.1%) and the main suppliers were South Africa (78.7%) and Seychelles (12.6%). (Table 16)

6. Trade in Freeport Zone – Year 2021

For the year 2021, total imports of the Freeport Zone stood at Rs 13,532 million, higher by 96.4% compared to 2020 – (Table 12).

The main imports of the Freeport zone were “Chemicals and related products, n.e.s.” and “Food and live animals” with a share of 37.7% and 14.6% respectively.

Freeport re-exports were valued at Rs 10,890 million, representing an increase of 24.1% compared to 2020 – (Table 6). “Miscellaneous manufactured articles” and “Food and live animals” with a share of 30.4% and 23.7% respectively, were the main exports.

7. Forecast 2022

Based on trends and information from various sources, the forecast of total exports for year 2022 will be around Rs 90,000 million and total imports including one off items such as helicopter and machinery for metro terminals will be around Rs 250,000 million.

The trade deficit for 2022 is forecasted to be around Rs 160,000 million, compared to Rs 133,081 million in 2021.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis, whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to **the Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six- and five-digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
