1. INTRODUCTION

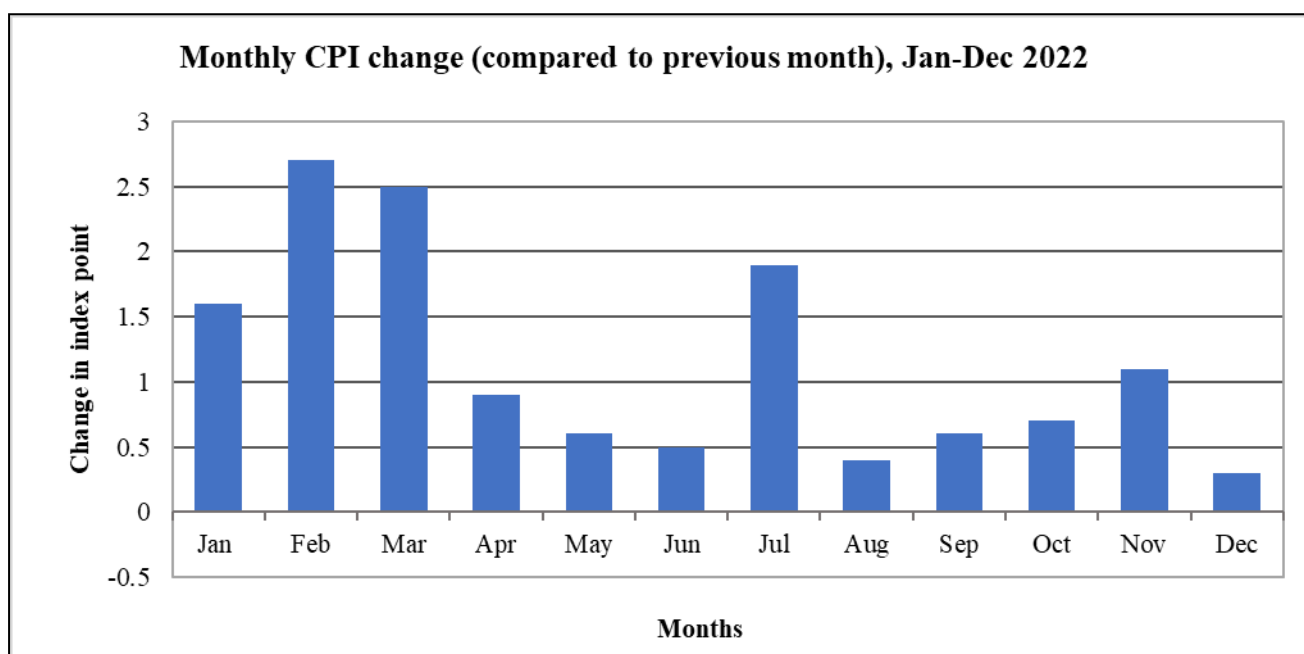
This issue of Economic and Social Indicators presents the Consumer Price Index (CPI) for the year 2022. The methodology used for computing the CPI and the inflation rate is given in the technical note at Annex.

2. KEY POINTS

2.1 Overall CPI

The Consumer Price Index, which stood at 113.3 in December 2021, registered a net increase of 13.8 points (or +12.2%) to reach 127.1 in December 2022 (Table 1A).

The monthly CPI changes in 2022 are shown in the chart below. Increases ranging from 0.3 point to 2.7 points were noted during the whole year 2022, with the highest increase in February 2022.



2.2 Overview of CPI movements

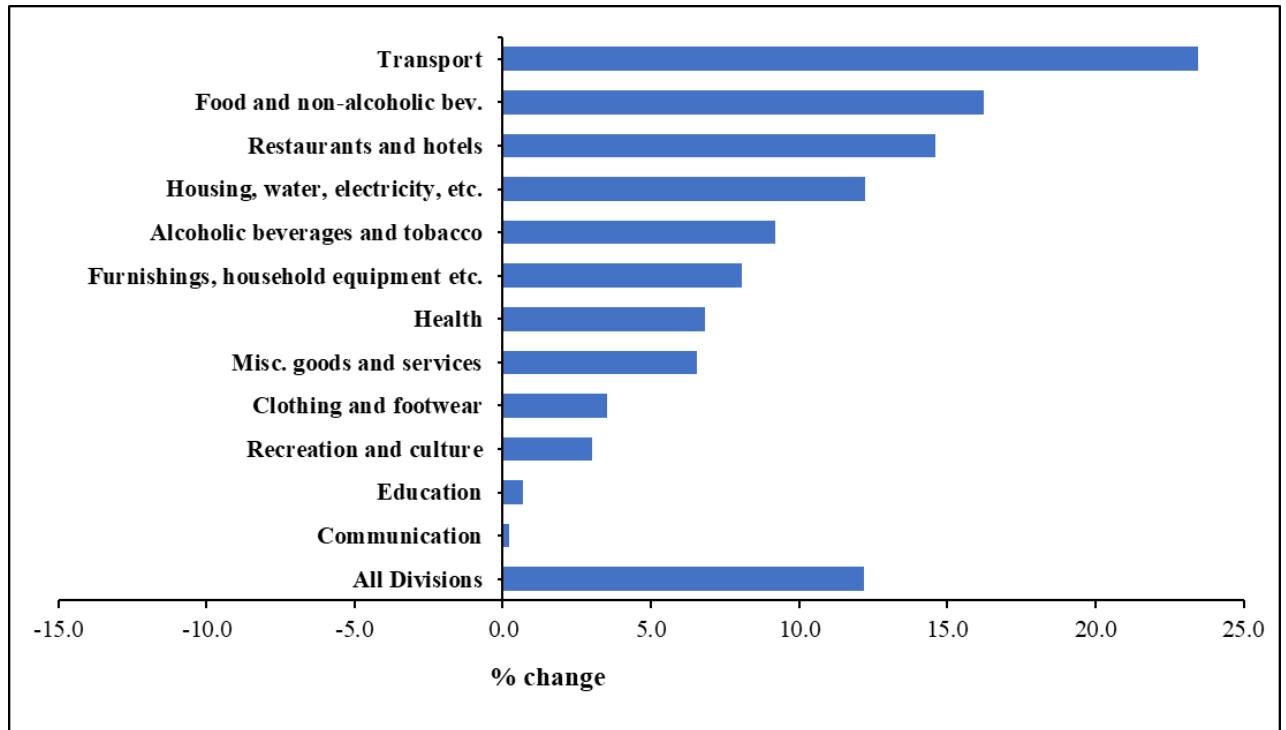
The main reasons for the net increase in CPI during the year 2022 (Table 2) were:

- (a) higher prices of meat, vegetables, powdered milk, cooking oil, trader's rice, fish, fruits, milk preparations, frozen semi-prepared foods, biscuits, sugar, eggs, pulses, some other prepared foods, soft drinks, ice cream and sweets, cheese and other food products;
- (b) higher prices of cigarettes, beer and stout, rum and other cane spirits, and wine;
- (c) higher prices of ready-made clothing;
- (d) higher interest rates on housing loan, higher workman's wages; higher prices of cooking gas and, materials for maintenance and repair of dwellings;
- (e) higher prices of washing materials and softeners, major household appliances and furniture;
- (f) higher doctor's fees;
- (g) higher bus fares, taxi fares and motor vehicles servicing charges; higher prices of gasoline, motor vehicles, diesel and air tickets;
- (h) higher prices of stationery;

- (i) higher expenditure in bar; higher prices of prepared foods, cakes and snacks and, soft drinks in restaurants;
- (j) higher prices of goods for personal care and, other goods and services; partly offset by
- (k) lower electricity rates.

3. MOVEMENT OF CPI SUB INDICES

Percentage change in CPI sub-indices for year 2022



The changes in the sub-indices (Table 3) for the twelve divisions of consumption expenditure during the year 2022 were as follows:

Division of consumption expenditure

Food and non-alcoholic beverages (+16.2%)

Main contributors to change

Higher prices of meat (+21.2%), vegetables (+13.9%), powdered milk (+25.1%), cooking oil (+52.8%), trader's rice (+26.6%), fish (+13.7%), fruits (+8.7%), milk preparations (+28.7%), frozen semi-prepared food (+10.8%), biscuits (+14.9%), sugar (+26.0%), eggs (+22.2%), pulses (+25.7%), some other prepared food (+8.8%), soft drinks (+7.4%), ice cream and sweets (+17.7%), cheese (+11.5%), concentrated juice and syrups (+8.2%), fruit juice (+12.7%), ginger (+26.2%), cereals (+5.4%) and coffee (+20.1%).

<i>Alcoholic beverages and tobacco (+9.2%)</i>	Higher prices of cigarettes (+8.2%), beer and stout (+11.3%), rum and other cane spirits (+10.4%), wine (+9.8%) and whisky (+5.0%).
<i>Clothing and footwear (+3.5%)</i>	Higher prices of ready-made clothing (+3.9%) and footwear (+2.1%).
<i>Housing, water, electricity, gas and other fuels (+12.2%)</i>	Higher interest rates on housing loan (+45.5%), higher workman's wages (+7.4%) and, higher prices of cooking gas (+33.3%), materials for maintenance of dwelling (+10.5%), partly offset by lower electricity rates (-4.7%).
<i>Furnishings, household equipment and routine household maintenance (+8.1%)</i>	Higher prices of washing materials and softeners (+18.7%), major household appliances (+9.6%), furniture (+6.5%), and higher charges for domestic services (+4.3%), partly offset by lower prices of other non-durable supplies (-6.6%).
<i>Health (+6.8%)</i>	Higher doctors' fees (+15.3%) and higher prices of medicinal products (+3.0%).
<i>Transport (+23.5%)</i>	Higher prices of gasoline (+44.8%), motor vehicles (+14.4%), diesel (+44.8%), air tickets (+2.9%) and higher charges for bus fares (+25.4%), taxi fares (+18.8%) and motor vehicles servicing charges (+11.1%).
<i>Communication (+0.2%)</i>	Higher prices of mobile phone equipment (+2.3%).
<i>Recreation and culture (+3.0%)</i>	Higher prices of stationery (+14.1%), newspapers and magazines (+9.3%) and pet foods (+9.1%), partly offset by lower prices of audio-visual equipment (-3.4%).
<i>Education (+0.7%)</i>	Higher university fees (+0.7%).
<i>Restaurants and hotels (+14.6%)</i>	Higher prices of prepared foods (+16.5%), cakes and snacks (+23.8%), soft drinks in restaurants (+12.9) and higher expenditure in bar (+7.7%).
<i>Miscellaneous goods and services (+6.6%)</i>	Higher prices of goods for personal care (+13.8%) and higher charges for religious and funerary services (+10.5%).

4. INFLATION RATE

The headline inflation rate increased from 4.0% in year 2021 to 10.8% in year 2022 (Table 5).

The headline inflation rate excluding 'Alcoholic beverages and tobacco' increased from 3.7% in year 2021 to 11.0% in year 2022.

5. INTERNATIONAL COMPARISON OF INFLATION RATE

The table below compares the inflation rate (as measured by the percentage change in the average CPI for a given year relative to the previous year) of Mauritius with those of our main trading partners and some countries in the region for year 2021. It is to be noted that inflation rates for 2022 for the selected countries are not yet available.

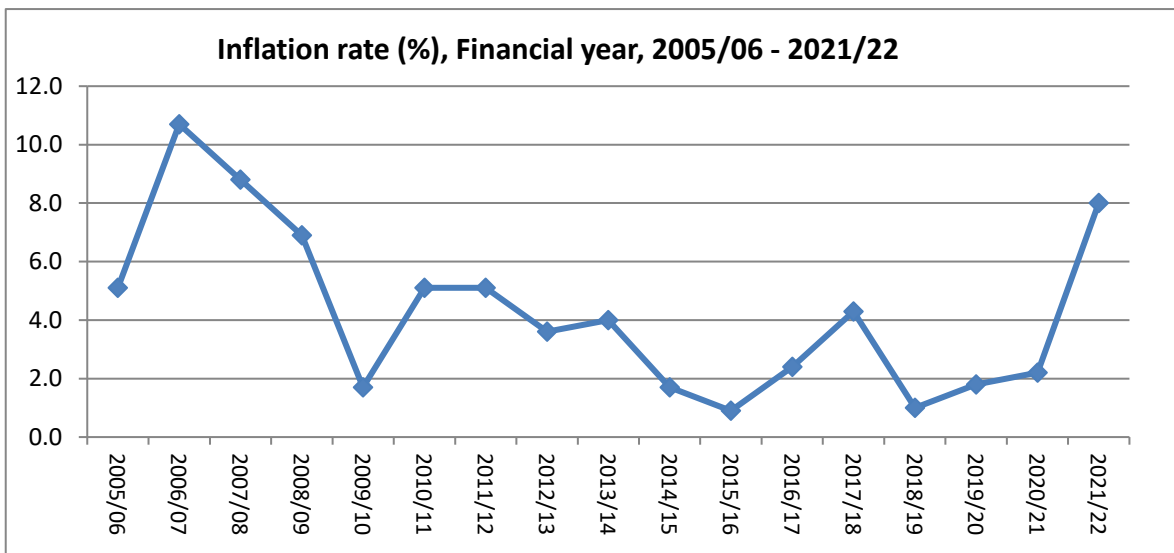
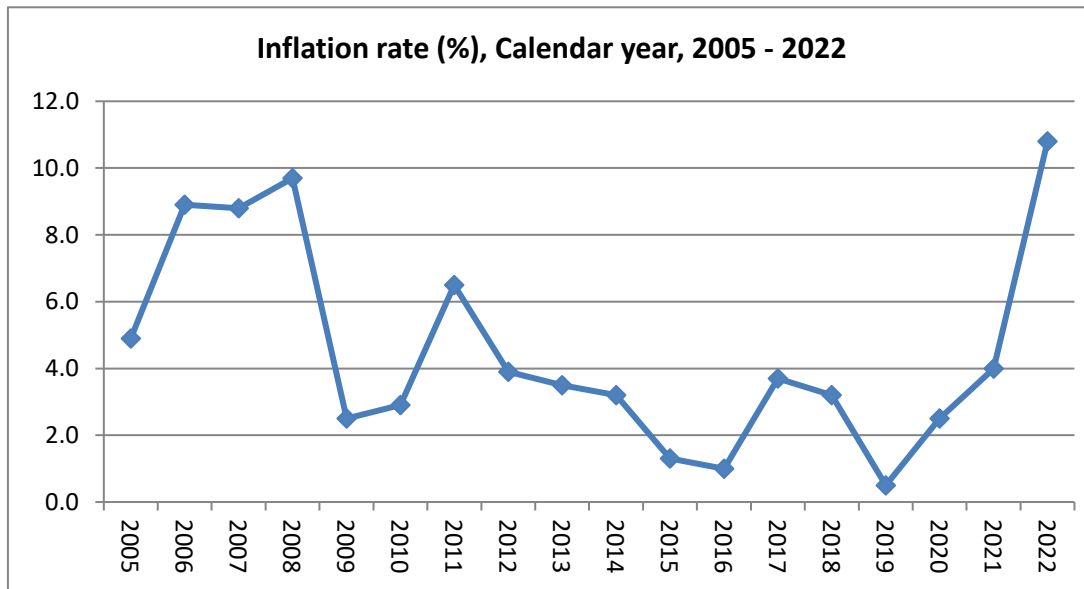

Technical note

1. Methodology used for computation of Consumer Price Index

(Base period: January - December 2017 = 100)

(a) Definition

The **Consumer Price Index** (CPI) is an indicator of changes over time in the general level of prices of goods and services acquired by Mauritian consumers.

(b) Measurement of CPI

The CPI measures price change by comparing, through time, the cost of a fixed basket of goods and services. As prices vary over time, the total cost of the basket also changes and thus the CPI measures the change in the cost of this basket. It provides a way to compare what this basket costs at a given period relative to a reference or base period.

The cost of the CPI basket is assigned a value of 100 in the base period and the costs in other periods are expressed as percentage changes compared to the base period. For example, if the CPI is 110, this means that there has been an increase of 10% in the cost of the basket since the base year; similarly, an index of 90 means a 10% decrease in the cost of the basket.

(c) CPI basket

The CPI basket is based on the expenditures of private households in a reference period, currently January to December 2017. The composition of the current CPI basket has been derived from the 2017 Household Budget Survey (HBS) data. It has been determined in accordance with latest ILO and SADC recommendations.

The items constituting the basket have been selected on the basis of the importance of household consumption expenditure on them. The basket includes all important items on which consumption expenditure is significant, i.e. accounting for around 0.1% or more of total household consumption expenditure. Each item's relative importance, which is called the "weight" (usually expressed on a total of 1000), is the expenditure share of the item. Non-consumption items such as income tax, social security contributions, purchase of land, shares and life insurance are excluded.

The commodities in the basket are classified according to the UN COICOP (Classification of Consumption Expenditure according to Purpose) with 12 divisions, 42 groups and 80 classes.

(d) Price coverage

The prices used in the CPI calculation are those that any member of the public would have to pay to purchase the specified goods or services. Any taxes on products attached to the goods are included.

Price collection is done on a regular basis. Each month, around 8,000 price quotations are collected in respect of 1,093 item indicators from some 520 outlets selected to be representative of regions across the islands of Mauritius and Rodrigues.

Prices of non-perishable items are collected monthly in the nine geographical districts of the island of Mauritius and in Rodrigues.

Prices of fresh fruits, vegetables, meat and fish are collected on a weekly basis from 9 markets in Port Louis, Rose Hill, Quatre Bornes, Vacoas, Mahebourg, Flacq, Goodlands, Pamplemousses and Port Mathurin.

Information on rent is obtained from a quarterly rent survey of some 100 rented dwellings.

(e) Formula for computation of CPI

The CPI is computed according to the Laspeyres Formula as a weighted average of price relatives of individual items. The weights are fixed and correspond to the base period expenditures. The Laspeyres Index measures the cost of a basket of goods and services at different points in time, relative to the cost of the same basket in the base period.

The formula used for computing the CPI at time t is

$$I_t = \frac{\sum W_i (P_{it} / P_{i0})}{\sum W_i} \times 100$$

where,

I_t : CPI for period t with reference to a base period 0

P_{i0} : Price of item i at time 0, i.e. during base period

P_{it} : Price of item i at time t

W_i : Weight of item i

The base period is January to December 2017, the period during which the latest HBS was conducted.

2. Inflation

(a) Definition of Inflation

Inflation is the percentage change in the level of prices (as measured by the CPI) from one period to another.

(b) Calculating the Inflation Rate

The headline inflation rate in Mauritius, like in many other countries, is calculated by using the annual average method, i.e. by comparing the average level of prices during a twelve-month period with the average level during the corresponding previous twelve-month period. This type of inflation rate is more appropriate for adjusting wages, salaries and pensions to compensate for loss of purchasing power. *All inflation rates presented in this publication relate to the headline inflation.*

Another commonly used method of calculating the inflation rate is the so called ‘year-on-year’ method. The year-on-year inflation rate is calculated as the percentage change in the CPI for a given month with respect to the CPI for the corresponding month of the previous year. It is generally used by central banks for monetary policy decisions. Year-on-year inflation rates are not presented in this publication but can be easily calculated through the available monthly CPI.
