Export Oriented Enterprises (EOE) 3rd Quarter 2025

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of September 2025.

It also includes provisional figures on EOE imports and exports for the third quarter of 2025 as well as figures for the years 2023 and 2024. Table 1 shows the main indicators of the EOE sector for the period 2016 to 2024.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the ex-Board of Investment.

2. Employment

2.1 Employment – 3rd Quarter 2025

Compared to the second quarter of 2025, employment in EOE decreased by 298 (-1.0%) from 28,732 to 28,434. Male employment decreased by 24 from 16,272 to 16,248 and female employment dropped by 274 from 12,460 to 12,186 (Table 2).

The number of Mauritians employed in the EOE sector fell by 289 (-1.9%) (-53 males and -236 females) from 15,224 to 14,935 and the number of foreign workers decreased by 9 (-0.1%) (+29 males and -38 females) from 13,508 at the end of June 2025 to 13,499 at the end of September 2025 (Table 2).

The decrease of 298 in employment in the EOE sector during the third quarter of 2025 is the net result of 776 jobs lost and 478 jobs created. The job losses were due to some contraction of workforce in existing enterprises whilst jobs created were due to expansion in existing enterprises.

2.2 Evolution of employment from September 2024 to September 2025

From September 2024 to September 2025, total employment in EOE decreased by 3,770 (-11.7%) from 32,204 to 28,434. The number of Mauritian workers decreased by 2,595 (-926 males and -1,669 females). Employment of foreign workers decreased by 1,175 (-699 males and -476 females) (Tables 2 and 5).

Job losses occurred mainly in enterprises engaged in the manufacture of "Wearing apparel" with a decrease of 2,504 jobs (Table 4).

Details of employment by product group and sex are given in Table 3 and changes in employment by product group in Table 4.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2023 are final, those for 2024 and for the first three quarters of 2025 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 3rd Quarter 2025

3.1.1 Exports (f.o.b)

Provisional figures show that EOE exports during the third quarter of 2025 amounted to R 10,971 million, that is, R 90 million (+0.8%) higher compared to R 10,881 million in the second quarter of 2025 (Table 6). That was mainly the result of increases observed in exports of "Articles of apparel and clothing" (+R451 million or +18.3%) and "Fish and fish preparations" (+R 102 million or +3.2%) partly offset by decreases in exports of "Textile yarn, fabrics, made up articles" (-R 138 million or -9.7 %) and "Watches and clocks" (-R 120 million or -40.5%).

Compared to the corresponding quarter of 2024, EOE exports decreased by R 960 million (-8.0%).

Details on EOE exports by section are given in Table 7.

South Africa, United States of America (USA), United Kingdom (UK), France, Spain and Madagascar remain the principal EOE markets in the third quarter of 2025, together accounting for R 8,280 million (75.5%) of total EOE exports (Table 9). The table below highlights the changes in our main EOE exports markets.

Compared to the previous quarter, EOE exports to our main markets showed increases as follows: United Kingdom (+11.2%), South Africa (+10.7%) and USA (+6.7%) whilst Spain, France and Madagascar registered decreases of 15.7%, 14.3% and 3.4% respectively.

When compared to the third quarter of 2024, Spain showed an increase of 16.7% whilst France, South Africa, Madagascar, United Kingdom and USA showed decreases of 13.4%, 11.5%, 9.6%, 7.2% and 2.8% respectively.

Further details are given in Table 9.

3.1.2 <u>Imports (c.i.f)</u>

EOE imports during the third quarter of 2025 were estimated at R 5,915 million, representing a decrease of R 394 million (-6.2%) compared to R 6,309 million in the second quarter of 2025. This decrease is mainly due to lower imports of "Raw materials" by R 507 million (-8.4%) offset by an increase in imports of "Machinery" by R 113 million (+45.9%) (Table 6).

Compared to the corresponding quarter of 2024, EOE imports decreased by R 10 million (-0.2%), mainly due to decreases in imports of "Textile yarn and fabrics" by R 376 million (-28.1%) and "Chemicals and related products, n.e.s" by R 123 million (-19.5%) partly offset by increases in imports of "Fish and fish preparations" by R 646 million (+45.4%) and "Cotton" by R 112 million (+30.2%).

Details on EOE imports by section are given in Table 8.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 5,056 million in the third quarter of 2025 and its ratio to total exports worked out to 46.1% compared to 50.3% in the corresponding quarter of 2024 (Table 6).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport, considered as local sales, were valued at R 5 million in the third quarter of 2025 compared to R 4 million in the third quarter of 2024. These sales are included in exports of Freeport, as and when the goods leave the country.
