## **Business Activity Statistics, July 2001 - June 2002**

### **Introduction**

**Business Activity Statistics** are compiled mainly from the administrative records of the local authorities, professional councils, government departments and other organisations responsible for the delivery of licences and registration certificates. Thus only licensed and registered activities are covered. Currently all agricultural activities, except those in the manufacture of food products, are not covered.

It must also be pointed out that the statistics on business activity refer to the total number of licensed or registered activities and not to the total number of operation units or establishments. For example, a general retailer may hold three licences: one for trading in foodstuffs, a second for selling tobacco and a third for selling liquor. An analysis of the data on licences and registrations provides useful information on trends in business activities.

### **2. Licences issued and cessations between July 2001 and June 2002**

As for the past years, the trend was maintained with the majority (67.5%) of the 4,579 new licences issued during the period July 2001 to June 2002, being attributed to activities classified under 'wholesale & Retail Trade; Repair of motor vehicles, motorcycles and personal & household goods'. As 2,043 licences were cancelled during the same period, the total number of licences as at June 2002 stood at 66,565, which compared to the previous year figure, represents an increase of 2,536 (4.0%) (Table 1.1).

### **3. Licences and registrations as at June 2002**

Table 3 indicates the net changes in both licensed and registered activities by industrial sector as at June 2002. The total number of such activities was 82,304 showing an increase of 3,653 (4.6%) over the figures for June 2001 (78,651). The highest number of activities was in the sector 'Wholesale and Retail trade; Repair of motor vehicles, motorcycles and personal and households goods', totalling 44,824 (54.5%), followed by the sector 'Transport, Storage & Communications', 16,534 (20.1%). It is also to be noted that following government decision to ban activities of sand quarries in October 2001, all the 336 licences for such activity have been cancelled.

#### 4. Distribution by urban and rural region

The distribution of licences and registrations by industry sector and region (urban and rural) is outlaid in Table 4.1 and shows that 42,540 activities (51.7%) were in the rural area. A further analysis reveals that activities in the sector 'Hotels and Restaurants' are mostly found in the rural areas (64.8%) while those pertaining to sectors 'Real estate, renting and business activities' and 'Financial intermediation' occur predominantly in the urban areas.

## Technical Notes

### 1. Concepts and coverage

Data compiled in this publication pertain to all activities licensed at the local authorities (Municipal and District Councils) as well as those registered with the relevant authorities. All activities carried out without a licence or registration are therefore excluded. Currently all agricultural activities, except those in the manufacture of food products, are not covered.

An operator is required to obtain a licence from the Municipal or District Councils for each type of activity or to register with the appropriate Ministry or Organisation (e.g. Ministry of Education, Medical Council etc.). In some cases an operator may hold both a licence and a registration certificate and to avoid double counting, such activities have been accounted for in either registration or licence only. For example the owner of a bus, besides registering his vehicle with the National Transport Authority may also hold a licence issued by a district council. In the table giving figures for both licences and registrations, the activity of the bus owner is accounted for in registration only.

### 2. Classification and presentation of data

To cater for the wide range and diverse business activities and for classification purposes, each activity has been assigned an activity code according to the **National Standard Industrial classification of Economic Activities (NSIC)**, which is an adapted version of the International Standard Industrial Classification (ISIC), Rev. 3, 1990.

The NSIC consists of 5 levels of classification namely:

Level 1	<b>Section:</b>	17 sections identified by one of the letters A to Q
Level 2	<b>Division:</b>	56 divisions identified by the first 2 digits
Level 3	<b>Group:</b>	151 groups identified by the first 3 digits
Level 4	<b>Classes:</b>	302 classes identified by the first 4 digits
Level 5	<b>Sub-classes:</b>	546 sub-classes identified by the first digits

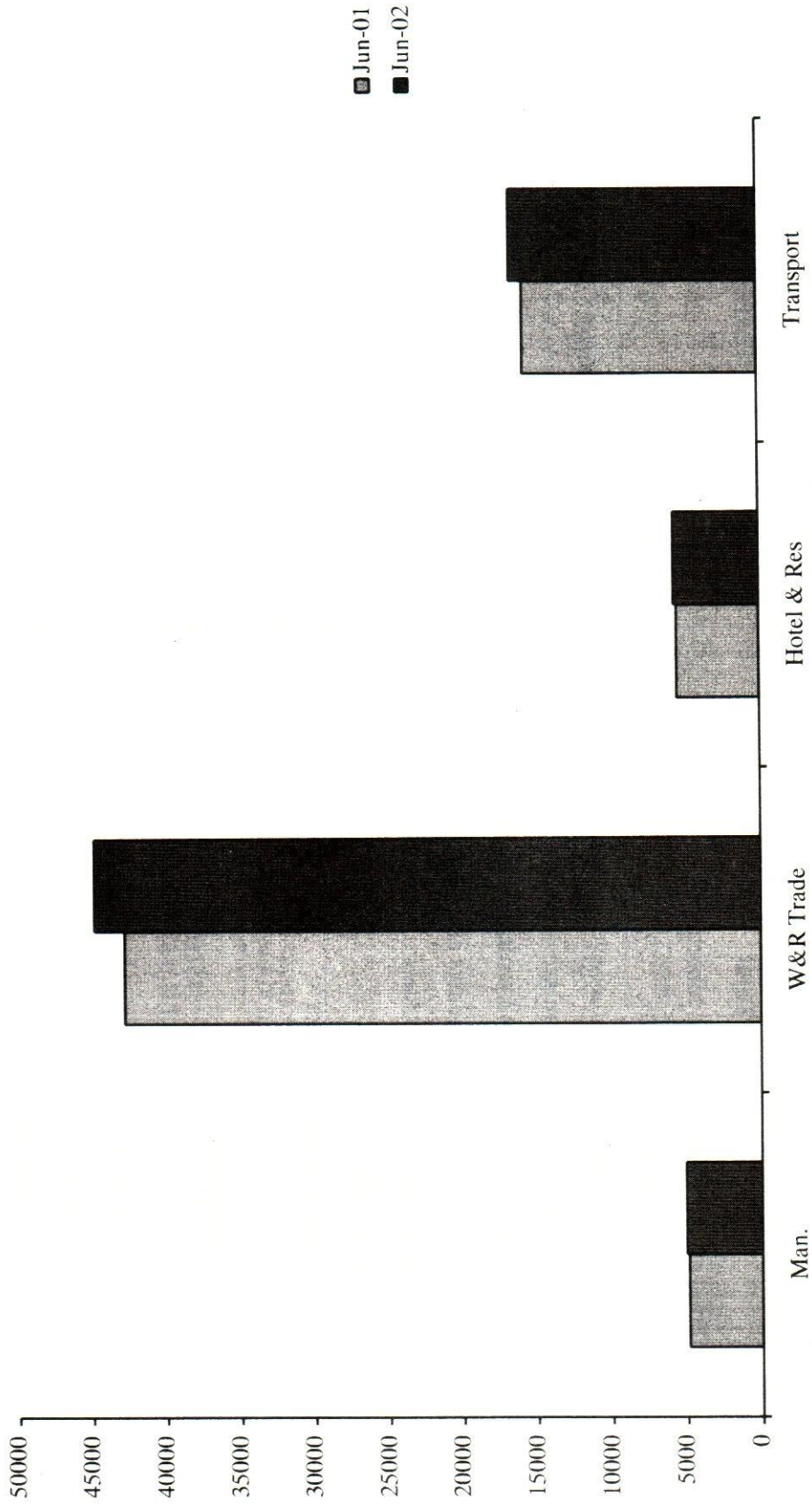

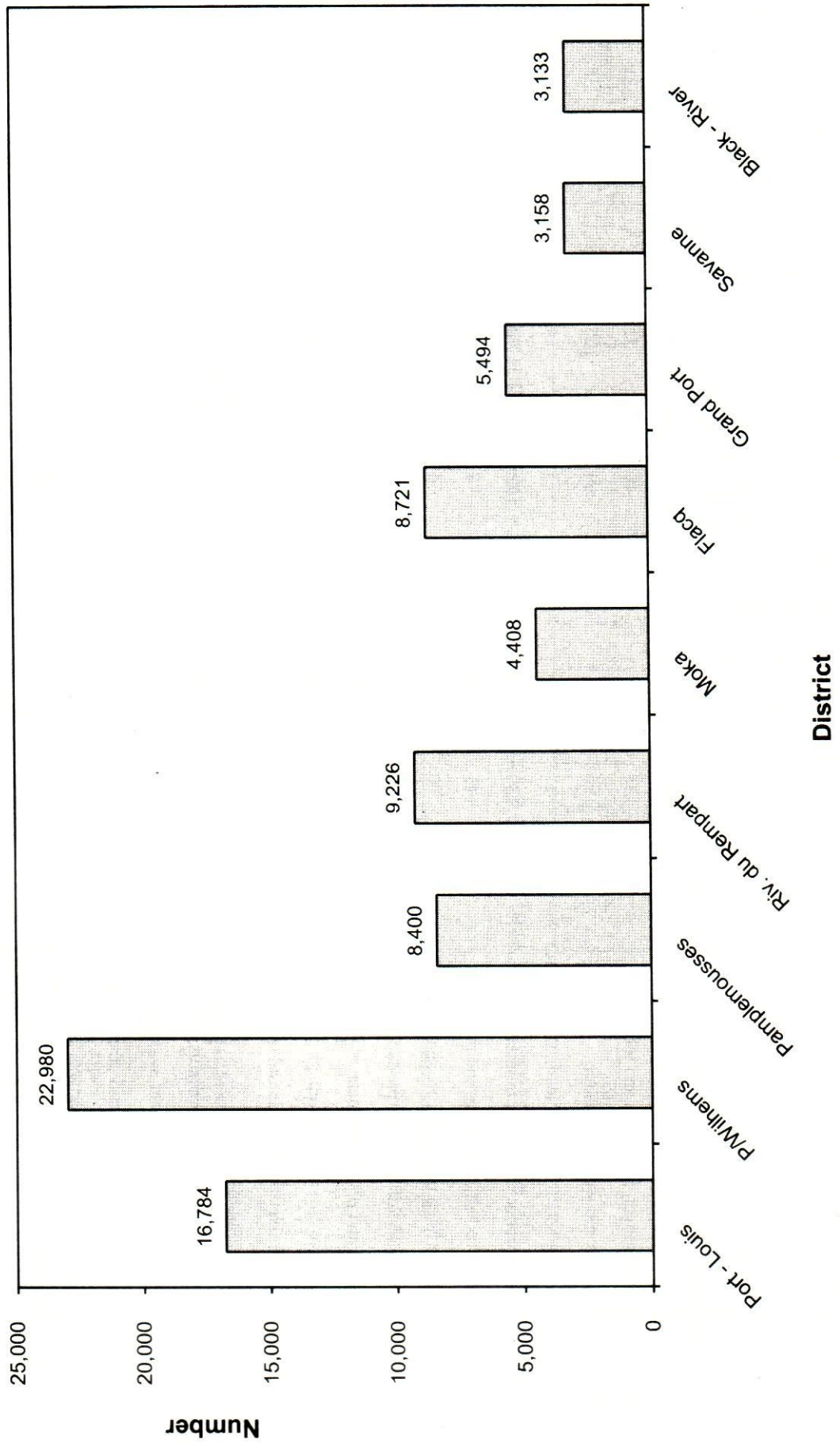
