This report on external trade statistics was published on a semester basis from 1989 up to 1994. As from 1995 an annual report incorporating data for the four quarters is published.

This issue contains quarterly and yearly data on exports and imports relating to the year 2009 and 2010.

The basic data for the preparation of this publication are obtained from bills of entry filed in electronically at the Customs Department of the Mauritius Revenue Authority. The Mauritius Sugar Syndicate, Air Mauritius, Airports of Mauritius and the State Trading Corporation provide supplementary information. Grateful acknowledgement is expressed here to all these departments and organisations for their continued co-operation.

It is hoped that data given in this report will prove useful to the public in general and to users of external trade statistics in particular.

Overview of External Trade – Year 2010

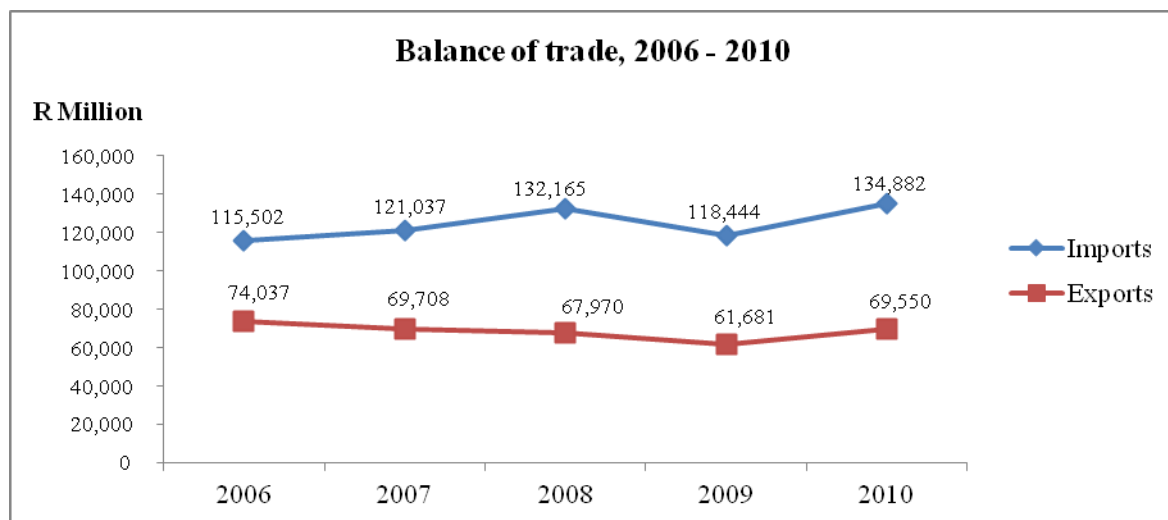
Introduction

Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone, should be accounted for. However, it was not possible prior to the year 2002 to include Freeport transactions because of different processing systems at the Customs Department and the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), making it possible to integrate data of the Freeport zone with those of Customs.

As from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius. For the year 2010, it is estimated that some 29% of Freeport exports were sourced locally.

1. Trade balance

Total exports for the year 2010 reached R 69,550 million compared to total imports of R 134,882 million, resulting in a trade deficit of R 65,332 million.



2. Terms of trade (base year: 2007 = 100)

The terms of trade index for 2010, which shows price changes of exports relative to those of imports (based on the Imports and Exports price indices – base year 2007=100), declined by 10 percentage point to 85 from 94 in 2009 (Table 4). This was due to an increase of 7.0% in import prices and 3.0% fall in export prices.

Details of price changes for exports and imports are given in Tables 5 and 6.

Note that the new series are not strictly comparable with previous ones published because different base periods and changes in concepts as well. The indices published in this issue are inclusive of re-exports and Freeport imports.

3. Exports

Total exports (including ships' stores and bunkers) were up by 12.8% to reach R 69,550 million in 2010 from R 61,681 million in 2009.

The table below shows the main changes in total exports (excluding ships' stores and bunkers) between 2009 and 2010.

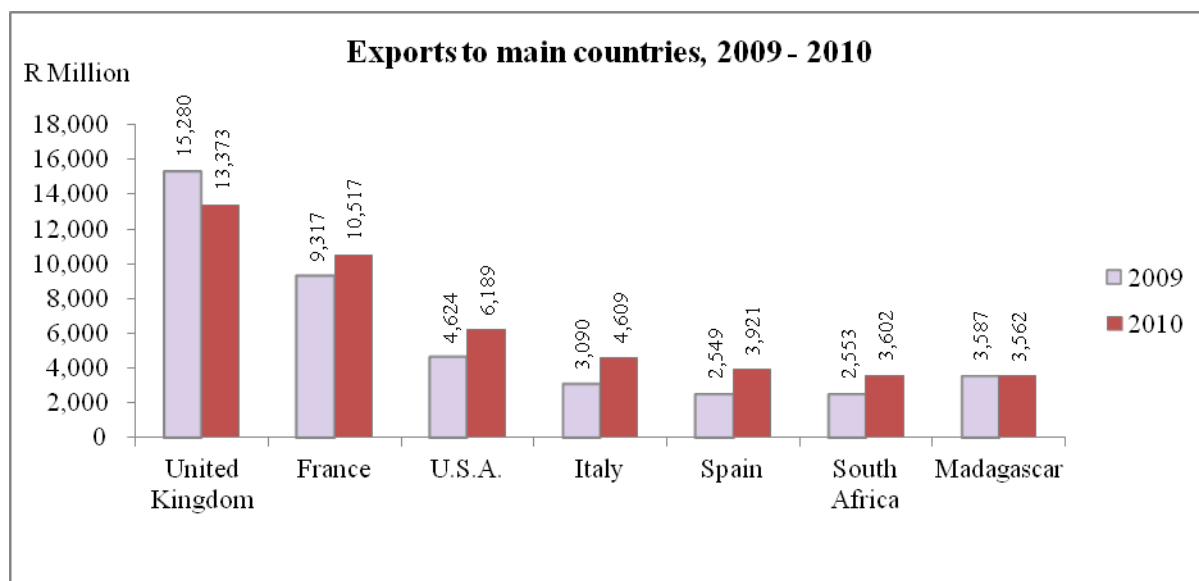

The value of exports of “*Food and live animals*” increased by 12% as a result of 15% increase in volume offset by a price decrease of 3%. Export receipts of “*Manufactured goods classified chiefly by materials*” were up by 14% in nominal terms, resulting from increases of 1% in prices and 13% in volume. Exports of “*Miscellaneous manufactured articles*” rose by 6% in value as a result of an increase of 10% in volume and a 4% fall in price.

For the year 2010, exports of “*Articles of apparel and clothing accessories*” representing 38.6% of total exports, increased to R 23,941 million from R 23,360 million in 2009, i.e. higher by 2.5%. During the same period, exports of sugar, representing 12.4% of total exports, rose by 12.9% from R 6,828 million in 2009 to reach R 7,708 million (Table 14).

An analysis by country of destination shows that the European countries purchased some 63.4% of our exports for R 39,281 million in 2010. United Kingdom (UK) remained the main buyer with R 13,373 million, or 21.6% of total exports, followed by France with R 10,517 million (17.0%). The other major markets were United States of America (U.S.A) (10.0%), Italy (7.4%), Spain (6.3%), South Africa (5.8%) and Madagascar (5.7%). Compared to 2009, total exports to U.K fell by 12.5% while increases were noted in Spain (53.8%), Italy (49.2%), South Africa (41.1%), and USA (33.8%) . Table 15 shows further details.



4. Total Imports (including Freeport imports)

Total imports for the year 2010 attained R 134,882 million from R 118,444 million in 2009 (includes aircraft valued at R 2, 862 million), higher by 13.9%.

In 2010 imports of “*Machinery and transport equipment*”, “*Manufactured goods classified chiefly by material*” and “*Food and live animals*” and represented 20.2%, 18.6% and 18.2% of total imports respectively while imports of “*Mineral fuels, lubricants and related materials*” made up for 19.0%.

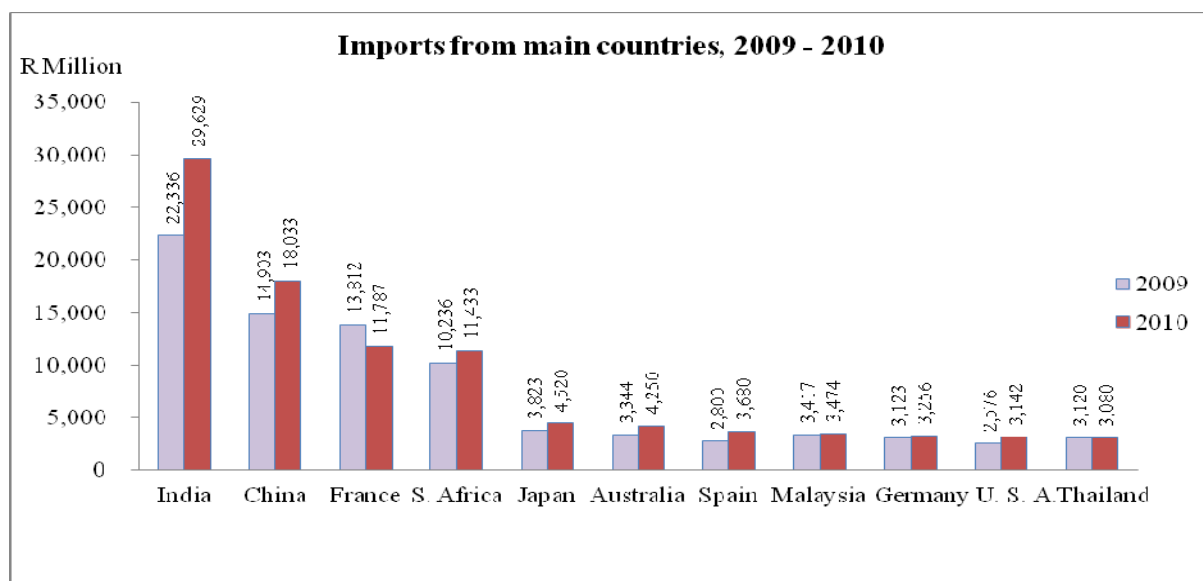
4.1. Imports excluding aircraft

The table below shows the main changes in imports between 2009 and 2010.

With the exception of “*Animals and vegetable oils & fats*” whose imports were down by 11.0%, all other remaining SITC sections registered increases in nominal terms, ranging from 4% to 38% in 2010. The highest increase in nominal terms was registered in “*Mineral fuels, lubricants and related materials*” whose imports value was up by 38% as a result of increases of 26% and 10% in prices and in volume respectively. The other sections registering substantial higher prices were “*Manufactured goods classified chiefly by material*”, and “*Chemicals & related products*” whose prices rose by 17% and 16% respectively. Details by section and commodity are given in tables 19 and 20.

Table 23 shows imports by country of origin. During the year 2010, imports from Asia totaled R 71,189 million, representing 52.8% of total imports. Our main suppliers were India (22.0%), China (13.4%), France (8.7%) and Republic of South Africa (8.5%).



5. Trade with Regional Organisations

ACP States

During 2010, total exports to African, Caribbean and Pacific (ACP) States were valued at R 9,336 million and imports, R 15,592 million (Table 35). Imports from South Africa which amounted to R 11,433 million made up for 73.3% of supplies from the ACP states.

COMESA States

For the year 2010, total exports to COMESA countries amounted to R 4,967 million against R 3,966 million worth of imports, resulting in a favorable balance of R 1,001 million for Mauritius (Table 36). Madagascar was the main buyer (71.7%) while Kenya was the main supplier (33.2%).

SADC States

For the year 2010, imports from SADC countries were valued at R 13,517 million and exports at R 8, 217 million (Table 37). The main supplier was the Republic of South Africa (84.6%). Our main buyers were Republic of South Africa (43.8%) and Madagascar (43.3%)

6. Trade in Freeport Zone

During the year 2010, total imports of the Freeport Zone amounted to R 8,642 million and re-exports were valued at R 7,888 million.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2007). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) or SITC Rev. 4. The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.

(4) **Terms of trade**

The terms of trade index measures the price movements of exports relative to imports. It is the ratio of exports to imports price index. A rise in this ratio indicates that the real purchasing power of exports has increased whilst a decrease indicates a drop in the purchasing power.
