Business Activity Statistics, 1997

Introduction

Business activity statistics is a new series of statistics compiled mainly from administrative data sources, namely licences and registrations. Presently, data relate only to non-agricultural activities carried out in the island of Mauritius and refer to June of respective years.

Data series on licences and registrations for the years 1996 and 1997 are being released for the first time through this issue of the Economic and Social Indicators. An analysis of these data provides useful information on trends in business activities.

2. Concept and data sources

For each type of activity carried out at a single location, an operator must satisfy at least one of the following requirements:

- (a) Obtain a licence from the Local Authority (Municipality or District Council)
- (b) Be registered with a Ministry/Department or Organisation such as
 - Ministry of Commerce and Industry - Issue of Export Enterprises (EPZ), Export Services Zone (ESZ) and Pioneer Status Certificates
 - National Transport Authority - Issue of public transport licences (taxi, bus, contract car etc)
 - Ministry of Education - Registration of pre-primary and other private schools
 - Ministry of Social Security - Registration of employers
 - Medical/Bar Council

However, there are cases where a business activity has obtained a licence from the Local Authority and is also registered with a particular organisation. Examples are EPZ and ESZ operators. In order to avoid double counting, such activities have been excluded from licences and included in registrations.

An operator is required to obtain a licence from the Local Authorities for each type of activity carried out at a single location. For example, a general retailer may hold three licences: one for trading in foodstuffs, a second for sale of tobacco and a third for sale of liquor. This operator will therefore be assigned three activities.

It is to be noted that business activity statistics refer to the total number of activities and not to the total number of operators or units.

3. Scope and coverage

Data presented in this report, therefore, refer to all business activities which are licensed and/or registered. Economic activities conducted without a licence or registration but are commercialised (food preparation, tailoring/seamstress, furniture makers, etc.) are excluded. Also not covered are all domestic services rendered to households by paid employees (maids, gardeners, drivers, etc.)

4. Classification

Each activity has been assigned an activity code according to the National Standard Industrial Classification of Economic Activities, NSIC, which is an adapted version of the International Standard Industrial Classification (ISIC), Revision 3, 1990. Details on level of classification are given at Annex.

5. Licences issued by Local Authorities

As shown in Table 1, during the year 1997, 4,316 new licences were issued and 1,518 were surrendered which brought the total number of licences delivered by Local Authorities to 53,416. Compared to 50,618 in 1996, this represents an increase of 2,798 or 5.5%. The highest number of new licences (2,925) was issued in the Wholesale/Retail trade while 903 were cancelled resulting in a net increase of 2,022.

6. Licences and registrations (Tables 2 to 4.7)

As explained at paragraph 2, some activities are both licensed and registered. To avoid double counting such activities have been included under registrations only. Figures given in Tables 2 to 4.7 refer to the adjusted licence data.

7. Distribution by type of activity (Table 2)

In 1997, there were 68,421 different types of economic activities (non agricultural) for which a licence or a registration was issued. Of these, 48,900 were classified under licences and 19,521 under registrations. The largest number of activities was in the Wholesale and retail trade (35,779) representing 52.3% of the total. Transport, Storage and Communication, the second largest, comprised 13,087, or 19.1%. Hotels and restaurants with 6,156 accounted for 9% and Manufacturing with 4,061, or 5.9%. Details on other industry groups are given at Table 2.

8. Net additions, 1997 (Table 3)

The comparison of 1997 figures with those of 1996 shows a net addition of 2,368 activities, representing an increase of 3.6%. With the exception of Transport, Storage & Communication and Health and Social Work, all other industry groups recorded increases ranging from 2% to 10%. The highest percentage increase was in Education, with a net increase of 112, or 10.7%.

9. Distribution by district/local authority (Tables 4.1 to 4.7)

Business activities are more or less equally distributed between the urban and rural districts. There were 33,927 activities in the urban areas and 34,494 in the rural districts. The Plaines Wilhems district had the largest number (19,716) followed by Port Louis (14,211). Moka/Flacq and Pamplemousses/Rivière du Rempart districts had both around 12,000 and Grand Port/Savanne (7,991). The least number was in Black River (2,401).

**National Standard Industrial Classification of Economic Activities (NSIC)
Explanation**

Each type of activity has been classified according to the National Standard classification of Economic Activities, NSIC, which is an adapted version of the International Standard Classification (ISIC) Revisions of 1990.

Structure and coding system of the NSIC:-

The NSIC consists of 5 levels of classification namely:

- Level 1: Section (17 Sections) identified by one of the letters A to Q.
- Level 2: Division (56 divisions) identified by the first 2 digits
- Level 3: Group (151 groups) identified by the first 3 digits
- Level 4: Classes (304 classes) identified by the first 4 digits
- Level 5: Sub class (510 sub classes) identified by the 5 digits

There are 17 sections which are as follows:

An example of the NSIC code for the “Manufacture of bread” is given below:

The code for Manufacture of Bread is 15411 where,

First 2 digits - 15 Indicate the Division - Manufacture of food products and beverages.

First 3 digits - 154 - Indicate the Group - Manufacture of other food products.

First 4 digits - 1541 - Indicate the Class - Manufacture of bakery products.

The 5 digits - 15411 - Indicate the Sub-class - Manufacture of bread.
