The Export Processing Zone and Pioneer Status Enterprises

1st Quarter 2003

Introduction

The Central Statistics Office conducts a "Quarterly Survey of Employment" among the EPZ and Pioneer Status Enterprises to provide up to date data on the evolution of the workforce in the different industry subgroups. This issue of the "Economic and Social Indicators" presents the results of the survey carried out at the end of March 2003. Figures are given separately for the Export Processing Zone and Pioneer Status Enterprises, the latter being "small and medium" enterprises engaged mainly in activities involving the application of high technology.

The Indicator also includes provisional figures of EPZ imports and exports for the 1st quarter 2003 as well as revised figures for previous years. Table 1.1 shows the main indicators of the EPZ sector for the period 1992 to 2002.

2. The Export Processing Zone (EPZ)

2.1 Number of enterprises

The number of EPZ enterprises at the end of the 1st quarter of 2003 stood at 508 compared to 506 at the end of the previous quarter and 514 a year ago.

During the first quarter, 4 enterprises closed down and 6 new enterprises started operation, resulting in a net gain of 2 enterprises. In "Wearing apparel", the most important group in the EPZ, 3 enterprises closed down while 3 new ones came into operation, thus keeping the total number of enterprises in this group to 230. The distribution of enterprises by product group is given in Table 1.2.

2.2 Employment evolution, 1st quarter 2003

At the end of March 2003, employment in the EPZ stood at 84,638 showing a decrease of 2,566 over the previous quarter. The number of male employees dropped by 976 to 27,979 and female employment fell by 1,590 to 56,659 (Table 1.4).

As shown in Table 1.5, during the 1st quarter 2003, a total of 2,814 jobs were created: 2,485 through expansion in 25 existing enterprises and 329 by 6 new enterprises. On the other hand, 5,380 jobs were lost: 3,345 through reduction in 25 existing enterprises and 2,035 following the closure of 4 enterprises.

The "Wearing apparel" group, accouting for 82% of total employment in the EPZ Sector, witnessed a decrease of 2,880 in its workforce, bringing the number of employees to 69,154 at the end of the quarter. Within the group, employment in "Pullovers" and "Other garments" declined by 1,926 and 954, respectively. Details of employment by product group are shown in Tables 1.6 and 1.7.

Foreign workers, who numbered 16,918 at the beginning of the quarter, increased slightly by 34 during the 1st quarter to reach 16,952. Among males, employment went up by 264, whilst the number of females declined by 230. Table 1.8 shows expatriate employment by product group and sex. It will be noted that the majority of foreign workers in the EPZ (15,575 or 92%) are employed in the "Wearing apparel" sector.

2.3 Employment evolution, March 2002 – March 2003

Comparison of March 2002 and March 2003 figures shows a net loss of 6 in the number of enterprises and a decrease of 2,227 in the EPZ workforce. Among males, employment went down by 1,358 and, among females, there was a decrease of 869 (Tables 1.6 and 1.7).

Employment in "Wearing apparel" group fell by 2,232 from 71,386 to 69,154. Within the group, employment in "Pullovers" and "Other garments" fell by 2,018 and 214 respectively. On the other hand, the "Food" sector registered an increase of 180. Details of changes in employment by product group are given in Table 1.7.

2.4 Exports and Imports, 1st Quarter 2003

Provisional figures indicate that EPZ exports for the 1st quarter of 2003 reached Rs. 6,900 million. Compared to the same quarter of last year this represents a decrease of Rs. 35 million.

During the same period, imports fell slightly from Rs. 3,844 million to Rs. 3,738 million. The bill for raw materials dropped by Rs. 212 million to Rs. 3,373 million, whilst imports of machinery increased from Rs. 259 million to Rs. 365 million.

Net exports, i.e. exports minus imports, amounted to Rs. 3,162 million and its ratio to exports works out to around 46% (Table 1.9).

Exports of manufactured articles of apparel and clothing, which stood at Rs. 5,285 million and representing over 75% of EPZ exports, fell by Rs. 95 million compared to the same quarter last year. On the other hand, appreciable increases were noted in exports of "Textile yarn, fabrics and made up articles" (from Rs. 256 million to Rs. 288 million) and "Pearls, precious and semi-precious stones" (from Rs. 187 million to Rs. 247 million). Other details of EPZ exports by section are shown in Table 1.10.

The United Kingdom, the United States of America and France remain our principal EPZ markets, accounting for Rs. 5,276 million or around 76% of total exports in the 1st quarter 2003. Exports towards the United Kingdom increased by Rs. 141 million or 8.3% whilst decreases of Rs. 18 million and Rs. 84 million were noted in exports to France and the U.S.A. respectively. Exports to the Malagasy Republic declined by 12.4% from Rs.121 million in the first quarter of 2002 to Rs.106 million in the first quarter of 2003.

It is to be noted that the above figures do not include the sales of EPZ products to Freeport operators. These goods, valued at Rs. 584 million for the 1st quarter 2003 compared to Rs. 343 million for the corresponding period of 2002, are only included in external trade statistics as exports of the Freeport, as and when they are exported by the Freeport licensees.

3. The Pioneer Status Enterprises (PSE)

3.1 Number of enterprises

At the end of the 1st quarter 2003, the number of PSE enterprises remained at the same level as at the previous quarter (256) following 2 closures and the coming into operation of an equal number of new enterprises. Among the enterprises 91 were "large", that is, having 10 or more employees. The highest number of enterprises was in "Other support services" (62), followed by "Light engineering" (42) and "Informatics" (39). Further details are given in Table 2.1

3.2 Employment

The total workforce in the PSE sector at the end of March 2003 was 3,386 (2,427 males and 959 females) showing an increase of 83 over the previous quarter. The "large" enterprises employed 2,741 as against 2,639 at the end of December 2002.

From Table 2.4 it can be seen that during the 1st quarter 2003, a total of 208 jobs were created: 19 by 2 new enterprises and 189 following expansion in 53 existing enterprises. On the other hand, 47 enterprises reported a total reduction of 118 in their workforce and job losses due to the closure of 2 enterprises numbered 7.

The number of expatriates employed in the PSE stood at 169 at the end of the 1st quarter, 6 less than at the end of the previous quarter.
