## **The Export Processing Zone and Pioneer Status Enterprises**

## 4th Quarter and Year 2003

#### Introduction

The Central Statistics Office conducts a "Quarterly Survey of Employment" among the EPZ and Pioneer Status Enterprises to provide up to date data on the evolution of the workforce in the different industry sub-groups. This issue of the "Economic and Social Indicators" presents the results of the survey carried out at the end of December 2003. Figures are given separately for the Export Processing Zone and Pioneer Status Enterprises, the latter being "small and medium" enterprises engaged mainly in activities involving the application of high technology.

The Indicator also includes provisional figures of EPZ imports and exports for the 4th quarter and year 2003 as well as revised figures for previous years. Table 1.1 shows the main indicators of the EPZ sector for the period 1993 to 2003.

#### 2. The Export Processing Zone (EPZ)

#### 2.1 Number of enterprises

The number of EPZ enterprises at the end of the 4th quarter of 2003 stood at 506, i.e., at the same level as at December 2002 but one less than the previous quarter. During the last quarter, 5 closures were reported whilst 4 new enterprises started operation (Table 1.5).

During the year, 23 enterprises closed down but these were offset by 23 new enterprises. In "Wearing apparel", the most important group in the EPZ, 13 closures were reported and 12 new enterprises came into operation, bringing the total number of enterprises to 229. The distribution of enterprises by product group is given in Table 1.2.

#### 2.2 Employment evolution, 4th quarter 2003

At the end of December 2003, employment in the EPZ stood at 77,623 showing an increase of 585 over the previous quarter. The number of male employees rose by 21 to 26,660 and female employment went up by 564 to 50,963. The ratio of male to female employment in the EPZ workforce is approximately 1 to 2 (Table 1.4).

As shown in Table 1.5, during the 4th quarter 2003, a total of 2,269 jobs were created: 2,177 through expansion in 15 existing enterprises and 92 by the 4 new enterprises. On the other hand, 1,684 jobs were lost: 1,641 through reduction in 22 existing enterprises and 43 following the closure of the 5 enterprises.

The "Wearing apparel" group witnessed a rise of 488 in its workforce, the effect of an increase of 799 in the sub-group "Other garments" partially offset by a decrease of 311 in "Pullovers". "Wearing apparel" still remains the most important group in the EPZ with 62,514 employees over a total of 77,623. Details of employment by product group are shown in Tables 1.6 and 1.7.

Foreign workers, who numbered 15,120 at the beginning of the quarter, increased by 272 during the 4th quarter to reach 15,392. Among males, employment fell by 51, whilst among females there was an increase of 323. Table 1.8 shows expatriate employment by product group and sex.

#### 2.3 Employment evolution, Year 2003

During 2003, employment in the EPZ fell by 9,581 from 87,204 at the end of 2002. Among males, employment went down by 2,295 as against 7,286 among females (Tables 1.6 and 1.7).

In the "Wearing apparel" group, employment declined by 9,520 from 72,034 to 62,514. Within the group, employment fell by 5,163 in "Pullovers" and a decrease of 4,357 was registered in "Other garments". Other significant decreases were registered in the "Other" product group (-270) and "Toys and carnival articles" (-186). On the other hand, "Textile yarn and fabrics", "Food" and "Jewellery and related articles" registered noticeable increases of 201, 147 and 112 respectively. Details of changes in employment by product group are given in Table 1.7.

#### 2.4 Exports and Imports, Year 2003

As mentioned in the introduction, it is to be noted that trade figures for year 2003 are provisional and are therefore liable to subsequent revisions.

EPZ exports for the 4th quarter of 2003 amounted to Rs. 8,515 million, bringing the total for year 2003 to Rs. 32,059 million. Compared to the previous year this represents a decrease of Rs. 624 million.

Imports in 2003, totalled Rs. 15,559 million compared to Rs. 16,909 million for 2002. The bill for raw materials dropped by Rs. 1,190 million to Rs. 14,061 million and imports of machinery and equipment fell by Rs. 160 million to Rs. 1,498 million.

Net exports, i.e. exports minus imports, amounted to Rs. 16,500 million and its ratio to exports works out to around 51% compared to 48% in the previous year (Table 1.12).

Exports of manufactured articles of apparel and clothing, which represent over 75% of EPZ exports, declined by Rs. 611 million. Other details of EPZ exports by section are shown in Table 1.13.

The United Kingdom, the United States of America and France remain our principal EPZ markets, accounting for Rs. 24,057 million or around 75% of total exports. An analysis by country of destination (Table 1.15) shows an increase of Rs. 322 million (+4.2%) in exports to the United Kingdom whilst exports to the United States of America and France fell by Rs. 696 million (-7.3%) and Rs. 322 million (-4.2%) respectively. Exports to the Malagasy Republic increased from Rs. 407 million in 2002 to Rs. 568 million in 2003 showing signs of improvement after the events at the beginning of 2002.

It is to be noted that the above figures do not include the sales of EPZ products to Freeport operators. These goods, valued at Rs.1,987 million for 2003 compared to Rs. 1,722 million for the previous year, are only included in external trade statistics as exports of the Freeport, as and when they are exported by the Freeport licensees.

### **3.** The Pioneer Status Enterprises (PSE)

#### 3.1 Number of enterprises

At the end of the 4th quarter 2003, one new enterprise started operation while 4 existing ones closed down, bringing the total number of PSE's to 259. Among the enterprises 87 were "large", that is, having 10 or more employees. The highest number of enterprises was in "Other support services" (63), followed by "Light engineering" (42) and "Informatics" (41). Further details are given in Table 2.1

#### 3.2 Employment

The total workforce in the PSE sector at the end of December 2003 was 3,353 (2,461 males and 892 females) showing a decrease of 83 over the previous quarter but an increase of 50 when compared to December 2002. The "large" enterprises employed 2,819 as against 2,782 at the end of September 2003.

From Table 2.4 it can be seen that during the 4th quarter 2003, a total of 263 jobs were created of which 262 by 47 existing enterprises. On the other hand, 82 enterprises reported a total reduction of 328 in their workforce and job losses due to the closure of the four enterprises numbered 18.

The number of expatriates employed in the PSE increased by 36 to reach 209 at the end of 2003.
