The Export Processing Zone and Pioneer Status Enterprises

2nd Quarter 2005

1. Introduction

The Central Statistics Office conducts a "Quarterly Survey of Employment" among the EPZ and Pioneer Status Enterprises to provide up-to-date data on the evolution of the workforce in the different industry sub-groups. This issue of the "Economic and Social Indicators" presents the results of the survey carried out at the end of June 2005. Figures are given separately for the Export Processing Zone and Pioneer Status Enterprises, the latter being "small and medium" enterprises engaged mainly in activities involving the application of high technology.

The Indicator also includes provisional figures on EPZ imports and exports for the first two quarters of 2005 as well as revised figures for previous years. Table 1.1 shows the main indicators of the EPZ sector for the period 1994 to 2004.

2. The Export Processing Zone (EPZ)

2.1 Number of enterprises

The number of enterprises at the end of the 2nd quarter 2005 stood at 498 compared to 499 at the end of March 2005 and 497 a year ago.

During the second quarter, 3 enterprises closed down and 2 new ones came into operation resulting in a net loss of one enterprise. In "Wearing apparel", the most important group in the EPZ, two enterprises closed down bringing the number of enterprises to 219 compared to 221 at the end of the previous quarter. The distribution of enterprises by product group is given in Table 1.2.

2.2 Employment evolution, 2nd quarter 2005

During the second quarter of 2005, employment in the EPZ increased by 605 from 66,797 (24,592 males and 42,205 females) at the end of March 2005 to 67,402 (25,043 males and 42,359 females) at the end of June 2005. Male employment went up by 451 and female employment by 154 (Table 1.4).

A total of 2,961 jobs was created: 2,908 through expansion in 18 existing enterprises and 53 by the 2 new enterprises. On the other hand, 2,356 jobs were lost: 2,308 through reduction in 11 existing enterprises and 48 following the closure of 3 enterprises (Table 1.5).

The "Wearing apparel" group registered a decrease of 302 in its workforce from 52,027 at the end of the previous quarter to 51,725. Within the group, employment declined by 274 in "Pullovers" and by 28 in "Other garments". On the other hand, the "Textiles yarn and fabrics" group registered an increase of 230 jobs. Details of employment by product group are shown in Tables 1.6 and 1.7.

Foreign workers increased from 13,441 at the end of March 2005 to 13,615 at the end of June 2005 (Table 1.4). Employment went up by 123 among males and by 51 among females. Nearly 90% of foreign workers was engaged in the "Wearing apparel" group. Table 1.8 shows expatriate employment by product group and sex.

2.3 Employment evolution, June 2004 – June 2005

During the one-year period ending June 2005, the number of enterprises increased by one whilst a decrease of 2,695 in the EPZ workforce was noted. Among males, employment increased by 353 while among females, it decreased by 3,048. Expatriate employment declined by 325 (Tables 1.4 and 1.8).

In the "Wearing apparel" group, employment declined by 3,307 from 55,032 to 51,725. Within the group, employment fell by 3,363 in "Pullovers", but increased by 56 in "Other garments". A significant increase was registered in the "Food" group (+624). Details of changes in employment by product group are given in Table 1.7.

2.4 Exports and Imports, 1st Semester 2005

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Customs Department. Thus while figures for 2003 are final, those for the year 2004 and the first two quarters of 2005 are subject to revision as and when the Customs Department submits latest amendments to the Central Statistics Office.

Provisional figures show that EPZ exports during the 2nd quarter of 2005 amounted to Rs. 7,701 million bringing the total for the 1st semester to Rs. 14,247 million. Compared to the corresponding semester of 2004, this represents a decrease of Rs. 1,628 million or 10.3%.

Exports of manufactured articles of apparel and clothing declined by Rs. 2,090 million during the first semester of 2005 compared to the corresponding period of 2004. The effect of this significant decrease was partially offset by increases in some other product groups of which "Fish and fish preparations" (+Rs. 332 million), "Pearls, precious and semi-precious stones" (+Rs. 156 million) and "Jewellery, goldsmiths and silversmiths wares" (+Rs. 59 million). Other details of EPZ exports by section are shown in Table 1.10.

The United Kingdom, the United States of America and France remain our principal EPZ markets, accounting for Rs. 10,250 million or around 72% of total exports. Compared to the corresponding semester of 2004, decreases in exports were noted in all these markets, with reductions of Rs. 844 million (-24.2%) to the United States of America, Rs. 430 million (-12.1%) to France and Rs. 64 million (-1.4%) to United Kingdom. Exports to the Malagasy Republic increased by 2.5% from Rs. 358 million to Rs. 367 million while a drop of Rs. 23 million (-10.4%) towards the Republic of South Africa was noted (Table 1.12).

EPZ imports for the 1st semester of 2005 amounted to Rs. 7,922 million compared to Rs. 8,736 million for the corresponding period of 2004, representing a decrease of 9.3%. The bill for raw materials decreased by Rs. 455 million (-6.3%) from Rs. 7,206 million to Rs. 6,751 million and that for machinery and equipment by Rs. 359 million (-23.5%) from Rs. 1,530 million to Rs. 1,171 million.

Net exports, i.e. exports minus imports, amounted to Rs. 6,325 million and its ratio to exports works out to around 44% (Table 1.9).

It is to be noted that the above figures do not include transactions of the EPZ with the Freeport. EPZ sales to the Freeport are considered as local sales. It was valued at Rs. 1,133 million for the 1st semester of 2005 compared to Rs. 1,152 million for the corresponding period of 2004. These sales are included in exports of Freeport, as and when the goods leave the country.

3. The Pioneer Status Enterprises (PSE)

3.1 Number of enterprises

During the 2nd quarter 2005, four enterprises closed down, bringing the total number of PSE's to 261. Among the enterprises 83 were "large", that is, having 10 or more employees. The highest number of enterprises was in "Other support services" (61), followed by "Light engineering" (46) and "Informatics" (41). Further details are given in Table 2.1.

3.2 Employment

The total workforce in the PSE sector at the end of June 2005 was 3,997 (2,906 males and 1,091 females) showing an increase of 188 (+4.9%) over the previous quarter. The "large" enterprises employed 3,442 against 3,263 at the end of March 2005.

Table 2.4 shows that during the 2nd quarter 2005, a total of 415 jobs was created following expansion in 41 existing enterprises. On the other hand, 227 jobs were lost: 185 through reduction in 46 enterprises and 42 following the closure of four enterprises.

The number of expatriates employed in the PSE stood at 219 at the end of June 2005 compared to 210 at the end of March 2005 and 222 a year ago.
