

External Trade – 3rd Quarter 2006

Introduction

This issue of the Economic and Social Indicators presents external trade statistics for the third quarter of 2006 and for the years 2004 and 2005. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Customs Department.

Thus while figures for 2004 and 2005 published in this indicator are final, those for 2006 are subject to revision as and when the Customs Department submits latest amendments to the Central Statistics Office. It is to be noted that export figures for the second quarter of 2006 have been revised to include the re-exports of an aircraft worth Rs 230 million.

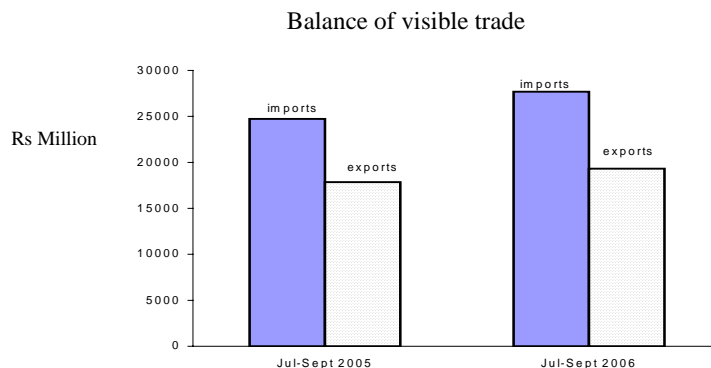
Data on international trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for. However, it was not possible prior to 2002 to include Freeport transactions in our general trade statistics because of different processing systems at the Customs Department and at the Mauritius Freeport Authority. Since mid-October 2001, transactions of the Freeport are being lodged through the Customs Management System (CMS), thus making it possible to integrate data of the Freeport zone with those of Customs.

Hence, as from 2002, data on imports and exports include transactions through the Mauritius Freeport. It is to be noted that all exports of the Freeport are included in re-exports of Mauritius because it is not possible to distinguish between domestic exports and re-exports of freeport licensees. It is estimated that currently some 33% of freeport exports are sourced locally.

1. Total value of trade and trade balance

Total international trade for the third quarter of 2006 was valued at Rs 47,002 million, a figure which is 5.4% higher than the previous quarter and 10.4% higher than the corresponding quarter of 2005.

During the third quarter of 2006, total exports attained Rs 19,305 million and total imports Rs 27,697 million, resulting in a trade deficit of Rs 8,392 million.



Based on trends for previous years and the first nine months of 2006, total exports for the year are expected to be of the order of Rs 73,328 million, against Rs 115,170 million for imports which would include aircraft worth Rs 6,825 million. The trade deficit would be around Rs 41,842 million.

2. Exports

2.1 Total exports (Table 1)

Total export proceeds for the third quarter of 2006, including domestic exports¹, re-exports² and ship's stores and bunkers, amounted to Rs 19,305 million, showing increases of 11.1% over the previous quarter and 8.1% over the corresponding quarter of 2005.

Domestic exports, which accounted for 71% of total exports, went up by 39.5% from the previous quarter to reach Rs 13,768 million in the third quarter of 2006. Compared to the corresponding quarter of 2005, domestic exports rose by 13.5%.

Total exports for January to September 2006 attained Rs 52,484 million, indicating a 15.6% increase over the corresponding period of 2005. During this period domestic exports rose by 9.2% and re-exports by 26.0% as a result of growing transactions of the Freeport.

2.2 Exports by SITC sections (Table 3)

Exports of "Food and live animals" for the first nine months of 2006 expanded by 12.4% to reach Rs 13,668 million. Exports of sugar, representing 14.9% of total exports, fell by 4.0% compared to the corresponding period of last year to reach Rs 7,253 million. This decrease was offset by a substantial rise in the exports of fish and fish preparations (53.3%).

During the first nine months of 2006, export receipts from "Manufactured goods classified chiefly by material" stood at Rs 4,099 million, showing a growth of 12.2% over the corresponding period of 2005.

Export proceeds from "Miscellaneous manufactured articles", representing 42.1% of total exports for the first nine months of 2006 reached Rs 20,500 million. This figure represented an increase of 7.9% when compared to the corresponding period of 2005, being the outcome of a 7.5% increase in the exports of "Articles of apparel & clothing accessories" which were valued at Rs 17,391 million.

2.3 Exports of EPZ (Table 1)

During the third quarter of 2006, exports of EPZ products declined by 3.1% to reach Rs 8,589 million. However, compared to the third quarter of 2005, these exports boosted by 20.2%.

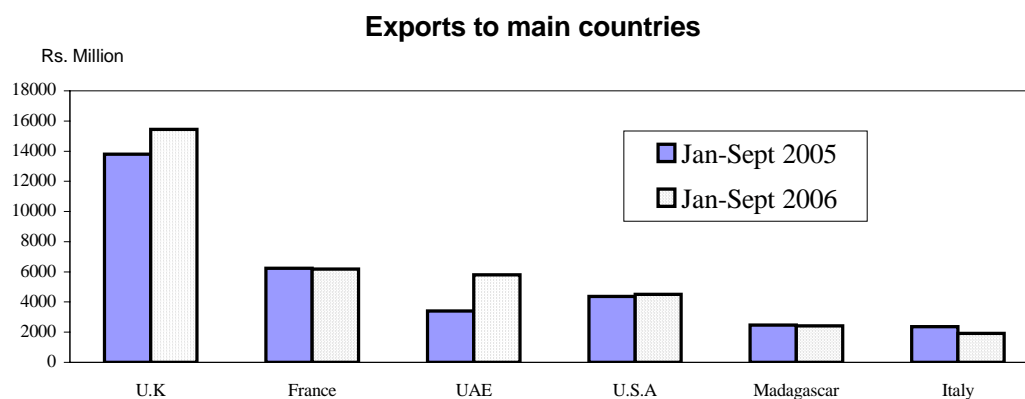
² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

For the first nine months of the year, exports of EPZ sector amounted to Rs 24,079 million, registering an increase of 13.3% over the corresponding period of 2005. Details on exports of EPZ are presented in the Economic and Social Indicator on the Export Processing Zone, which will be released on 18 December 2006.

2.4 Exports by Country of destination (Table 6)

Analysis by country of destination for the first nine months of 2006 shows that our main purchasers, i.e the European countries, acquired some 60.8% of our exports for an amount of Rs 29,647 million. Our major market remained the United Kingdom with Rs 15,437 million, or 31.6% of total exports. The other major destinations for our exports were France (12.7%), UAE (11.9%), U.S.A (9.3%), Madagascar (4.9%) and Italy (3.9%).

Compared to the first nine months of 2005, total exports to UK and U.S.A went up by 11.8% and 3.7% respectively while those to France fell slightly by 0.7%. During this period total exports to the UAE increased from Rs 3,402 million to Rs 5,795 million (+70%) as a result of a 70% increase in re-exports of cellular phones by Freeport operators. It is worth noting that exports to South Africa doubled during that period, from Rs 539 million to Rs 1,080 million, on account of an increase in exports of textile products.



3 Imports

3.1 Total imports (Table 1)

Total imports for the third quarter of 2006 stood at Rs 27,697 million, showing increases of 1.7% over the previous quarter and 12.1% over the corresponding quarter of 2005.

Total imports for the first nine months of 2006 amounted to Rs 78,539 million, moving up by 16.1% over the corresponding period of 2005.

3.2 Imports by SITC sections (Table 9)

Imports of “*Food and live animals*” for the first nine months of 2006 expanded by 22.9% over the corresponding period of last year to attain Rs 12,009 million.

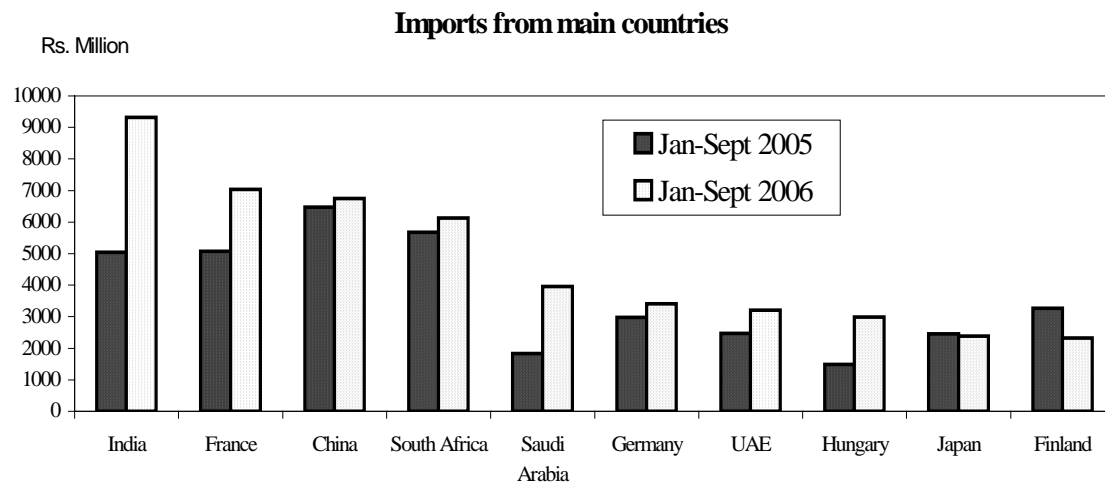
Import bill of “*Mineral fuels, lubricants, & related products*” reached Rs 14,517 million, that is 33.3% higher than the matching period of last year.

From January to September 2006, imports of “*Manufactured goods classified chiefly by material*” stood at Rs 15,466 million, going up by 7.7% in comparison with the same period of 2005. Imports of “*Machinery & transport equipment*”, representing 27.6% of total imports, went up by 11.8% to reach Rs 21,695 million.

3.3 Imports by country of origin (Table 11)

During the first nine months of 2006, imports of goods from Asia reached Rs 37,772 million, with a share of 48.1% of total imports for that period.

Our imports originated mainly from the following countries: India (11.9%), France (9.0%), China (8.6%), South Africa (7.8%), Saudi Arabia (5.0%), Germany (4.3%), UAE (4.1%), Hungary (3.8%), Japan (3.0%) and Finland (3.0%).



3. Trade with Regional Organisations (Tables 12-14)

Total exports to African, Caribbean and Pacific (ACP) States during the third quarter of 2006 stood at Rs 1,536 million, against imports of Rs 2,967 million.

During the first nine months, total exports to these countries were valued at Rs 4,637 million and imports, Rs 8,595 million.

During the third quarter of 2006, Mauritius exported goods to a value of Rs 1,023 million to COMESA countries. Imports from these countries amounted to Rs 813 million, resulting in a favourable balance of Rs 210 million for Mauritius.

For the first nine months, total exports to COMESA countries amounted to Rs 3,062 million and imports, Rs 2,318 million. Madagascar was the main buyer (78.8%) while the main suppliers were Seychelles (32.0%), Egypt (15.7%) and Madagascar (15.4%). The main products exported to Madagascar were yarn of carded wool, preparations used in animal feeding and carded yarn of fine animal hair. The main products imported from Seychelles were frozen yellowfin tunas and frozen skipjack while urea and iron bars constituted the main imports from Egypt.

Trade with SADC countries for the third quarter of 2006 showed a deficit of Rs 1,104 million, resulting from imports to a value of Rs 2,371 million and exports amounting to Rs 1,267 million.

For the first nine months, Mauritius imported Rs 7,236 million worth of goods from SADC countries while exports were of the order of Rs 3,632 million. The main supplier was South Africa (84.7%) while our main buyers were Madagascar (66.4%) and South Africa (29.8%).

5. Trade in Freeport Zone (Table 2)

During the third quarter of 2006, total imports of the Freeport Zone were Rs 2,978 million, a figure which is lower by 25.3% compared to the previous quarter and by 1.7% compared to the corresponding quarter of 2005. Re-exports to overseas markets were valued at Rs 3,511 million, showing a contraction of 27.7% over the previous quarter and another of 15.8% over the corresponding quarter of 2005.

For the first nine months of the year, total imports totalled Rs 10,444 million compared to Rs 12,538 million worth of re-exports.

Notes

(1) Coverage

Trade figures are compiled according to the **General Trade System** as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

- Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses
- Exports cover domestic exports and re-exports which include re-exports from customs bonded warehouses. Domestic exports are defined as goods of national origin. Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.
- Ships stores and bunkers are included in total exports and are shown separately.
- Trade by parcel post is also included in imports and exports

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free On Board) basis.

C.I.F. value is the value in the market at the Customs frontier of a country of her imports of merchandise, other goods, etc. including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft etc. unless it is borne by the carrier.

F.O.B. value is the value in the market at the Customs frontier of a country of her exports of merchandise and other goods, including all costs of transporting the goods to the Customs frontier, export duties and the cost of loading the goods on to the carrier unless the latter cost is borne by the carrier.

(3) Classification

(i) Commodity Code

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2002). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 3) or SITC Rev. 3. The HS and the SITC Rev. 3 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
