AGRICULTURAL AND FISH PRODUCTION

(January - June 2013)

1. Introduction

This issue of Economic and Social Indicators presents data on agricultural and fish production for the Island of Mauritius for the first six months of 2013, as well as revised figures for year 2012. Table 1 shows area harvested and production in respect of the main agricultural crops while Table 2 shows production of the main agro-industrial products. Details on the sugar industry and food crops are given in Tables 3 and 5 respectively.

2. Sugar cane

At the end of June 2013 some 1,810 hectares under sugar cane were harvested, yielding 128,252 tonnes of sugar cane and 12,178 tonnes of sugar. The corresponding figures for the same period in 2012 were 1,000 hectares, 63,070 tonnes of sugar cane and 5,745 tonnes of sugar respectively. The higher figures for 2013 are mainly explained by cane crushing starting on 14 June this year as compared to 22 June last year. The average extraction rate as at end of June 2013 was 9.50% compared to 9.11% as at end of June 2012.

According to the Mauritius Chamber of Agriculture, production of sugar for the crop year 2013 will be around 420,000 tonnes, representing a rise of 2.6% compared to 409,200 tonnes for 2012.

3. Tea

At the end of June 2013, area under tea plantation was 669 hectares, same as the figure for the same period of 2012. However, the production of green tea leaves went down by 9.0%: 4,260 tonnes in first semester of 2013 as compared to 4,683 tonnes during the same period of 2012. This is mainly due to unfavourable climatic conditions prevailing during the first semester of 2013.

Production of manufactured tea decreased by 9.0%, from 922 tonnes in the first semester of 2012 to 839 tonnes in the same period of 2013. Further details on tea production are given in Table 4.

4. Tobacco

An area of only 1 hectare under tobacco cultivation was harvested during the first six months of 2013, that is, 98.6% lower than the 70 hectares harvested in the corresponding period of 2012. Consequently, the production of tobacco leaves decreased by 99.2% from 131 tonnes in the first semester of 2012 to only 1 tonne in the same period of 2013. This is explained by the fact all flue-cured growers have stopped planting as from second season of the 2012/2013 crop given that growing of tobacco will cease in 2015. Only a few air-cured growers will continue to grow tobacco over the next two years.

5. Food crops

Data on food crops (except paddy rice) production, are supplied by the Agricultural Research and Extension Unit. Figures are thereafter adjusted to take into account backyard production of banana, eddoes, manioc and sweet potato. Data on paddy rice was obtained from concerned establishment.

The area under food crops harvested increased by 1.9% from 3,522 hectares in the first semester of 2012 to 3,589 hectares in same period of 2013. However, the production of food crops decreased by 7.8% from 45,439 tonnes to 41,885 tonnes during the same period, mainly explained by unfavourable climatic conditions prevailing during first semester of 2013. It is to be noted that area under rice cultivation harvested declined by 1.6% from 309 hectares in the first semester of 2012 to 304 hectares in the first semester of 2013. The production of paddy rice went down by 22.3% from 831 tonnes to 646 tonnes during the same period explained by the combined effects of unfavourable climatic conditions and of brown spot disease.

6. Livestock

Data on production of beef, goat meat, mutton and pork are supplied by the Mauritius Meat Authority. It is to be noted that this data represents only animals slaughtered by the Central Abattoir, including live animals imported from Rodrigues and other countries for slaughter.

During the first half of 2013, the production of beef from live cattle was 971 tonnes, which is 1.7% lower than the figure of 988 tonnes registered in the corresponding period of 2012. Beef production from the slaughter of imported cattle, accounting for 94.4% of the total production, increased by 7.8%, from 851 tonnes to 917 tonnes. Local beef production went down by 60.6% from 137 tonnes to 54 tonnes.

The production of goat meat and mutton went down by 10.3% from 29 tonnes during the first semester of 2012 to 26 tonnes for the same period of 2013. The share of local production, inclusive of Rodrigues, stood at 76.9%.

The production of pork decreased by 6.0% from 299 tonnes in the first semester of 2012 to 281 tonnes during the same period of 2013.

7. Poultry

The production of poultry was 23,500 tonnes in the first semester of 2013, same as the corresponding period of 2012.

8. Fish

Total fish production went up by 6.7%, from 2,184 tonnes in first six months of 2012 to 2,331 tonnes in the same period of 2013. This increase was attributable to a rise of 26.5% in the production of other catch (tuna, bank etc) from 1,223 tonnes to 1,547 tonnes partly offset by a decrease of 18.4% in the production of fresh coastal fish catch, from 961 tonnes to 784 tonnes.
