

Export Oriented Enterprises (EOE)

3rd Quarter 2014

1. Introduction

This issue of Economic and Social Indicators (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of September 2014.

It also includes provisional figures on EOE imports and exports for the 1st, 2nd and 3rd quarter of 2014 as well as revised figures for the years 2012 and 2013. Table 1 shows the main indicators of the EOE sector for the period 2000 to 2013.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Enterprises

Following the coming into operation of a new enterprise producing bone substitutes for orthopaedic and dental surgery, the total number of export-oriented enterprises operating at the end of September 2014 was 312 (Table 2).

3. Employment

3.1 *Employment – 3rd Quarter 2014*

Compared to the second quarter of 2014, employment in EOE decreased by 222 (-0.4%) from 55,320 (25,409 males and 29,911 females) to 55,098 (25,575 males and 29,523 females). Male employment increased by 166 while female employment decreased by 388 (Table 2).

During the third quarter of 2014, a total of 933 jobs were lost as a result of reduction in workforce. On the other hand, 711 jobs were created: 703 due to expansion of existing enterprises and 8 due to the coming into operation of a new enterprise.

Most of the job losses occurred in enterprises engaged in the production of:-

- (i) "Pullovers", with a decrease of 369 jobs from 3,326 to 2,957 and
- (ii) "Textile yarn and fabrics", with a decrease of 96 jobs from 5,081 to 4,985.

The job losses were partly offset by 465 jobs created in enterprises engaged in the production of "Wearing apparel - garments other than pullovers".

Employment of Mauritians went down by 579 (-1.8%) from 32,801 to 32,222, while employment of foreign workers increased by 357 (+1.6%) from 22,519 at the end of June 2014 to 22,876 at the end of September 2014. Nearly 79% of the foreign workers were engaged in enterprises manufacturing wearing apparels (Tables 2 and 5).

Details on EOE employment by product group are given in Table 4.

3.2 *Evolution of employment from September 2013 to September 2014*

From September 2013 to September 2014, total employment increased by 1,082 (+2.0%) from 54,016 to 55,098. The number of Mauritian workers decreased by 273 (+95 males and -368 females). However, employment of foreign workers increased by 1,355 (+1,255 males and +100 females) (Tables 2 and 5).

Job creations occurred mainly in enterprises engaged in the production of:-

- (i) "Wearing apparel - garments other than pullovers", with an increase of 1,386 jobs from 31,925 to 33,311;
- (ii) "Food", with an increase of 213 jobs from 4,915 to 5,128; and
- (iii) "Jewellery and related articles", with an increase of 100 jobs from 1,215 to 1,315.

Job losses occurred mainly in enterprises engaged in the production of:-

- (i) "Pullovers", with a decrease of 385 jobs from 3,342 to 2,957; and
- (ii) "Wood and paper products", with a decrease of 77 jobs from 931 to 854.

Details on changes in employment by product group are given in Tables 3, 4 and 5.

4. Exports and Imports

Statistics on exports and imports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2012 and 2013 are final, those for 2014 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

4.1 *Exports and Imports – 3rd Quarter 2014*

4.1.1 *Exports (f.o.b)*

Provisional figures show that EOE exports during the 3rd quarter of 2014 amounted to R 12,136 million, that is, R 371 million or 3.0% lower compared to the second quarter of 2014 (Table 6).

That was mainly the result of decreases in the exports of:-

- "Articles of apparel and clothing" (-R 194 million or -3.1%);
- "Food and live animals" (-R 137 million or - 4.7%); and

an increase in the exports of "Chemical and related products" (+R 78 million or +87.6%).

Compared to the corresponding quarter of 2013, EOE exports increased by R 56 million or 0.5%.

Details on EOE exports by section are given in Table 7.

The United Kingdom (UK), the United States of America (USA) and France remain the principal EOE markets, together accounting for R 6,337 million or around 52% of total EOE exports. The Republic of South Africa, Italy and Spain are among the other main destinations of EOE exports.

Compared to the previous quarter, exports to these main markets registered the following changes:-

Exports went up for:

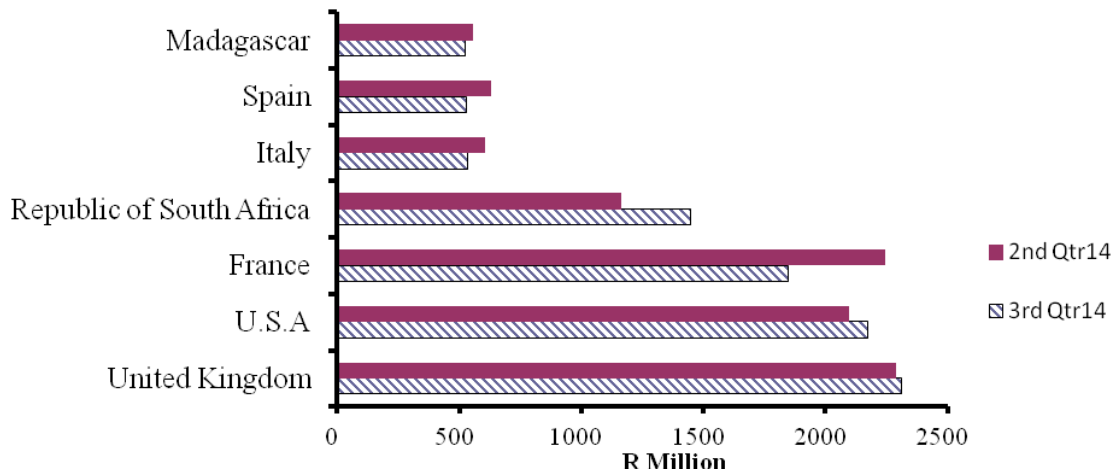
- The Republic of South Africa by R 287 million (+24.7%);
- Netherland by R 126 million (31.3%);
- USA by R 78 million (+3.7%); and
- United Kingdom by R 23 million (+1.0%).

Exports went down for:

- France by R 398 million (-17.7%);
- Belgium by R 98 million (-21.1%); and
- Spain by R 98 million (-15.6%).

Further details are given in Table 9.

4.1.2 Imports (c.i.f)

EOE imports during for the 3rd quarter of 2014 were estimated at R 7,427 million, representing an increase of R 789 million (+11.9%) over the previous quarter (Table 6). This is due to higher imports of raw materials by R 796 million (+12.7%), partly offset by lower imports of machinery and equipment by R 7 million (-1.9%).

Compared to the corresponding quarter of 2013, imports decreased by R 230 million (-3.0%), mainly due to drops in imports of “Fish and fish preparations” by R 264 million (-11.6%), “Textile yarn and fabrics” by 138 million (-9.2%) and “Jewellery, goldsmiths & silversmiths wares” by R 128 million (-48.7%), partly offset by a rise in “Pearls, precious and semi-precious stones” by R 436 million (+70.8%).

Details on EOE imports by section are given in Table 8.

- 4.2 Net exports, i.e. exports minus imports, amounted to R 4,709 million for the third quarter of 2014 and its ratio to total exports worked out to around 39% compared to 37% in the corresponding quarter of 2013 (Table 6).

It is to be noted that the above imports and exports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport are considered as local sales and were valued at R 188 million in the third quarter of 2014 compared to R 43 million in the third quarter of 2013. These sales are included in exports of Freeport, as and when the goods leave the country.
