Export Oriented Enterprises (EOE) 4th Quarter and Year 2014

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among the Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of December 2014.

It also includes provisional figures on EOE imports and exports for the year 2014 as well as revised figures for the years 2012 and 2013. Table 1 shows the main indicators of the EOE sector for the period 2000 to 2014.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Enterprises

The number of export-oriented enterprises decreased from 312 at the end of September 2014 to 309 at the end of December 2014, following the closure of seven enterprises (3 of these taken over by new companies) and resumption of activity by one dormant company.

From December 2013 to December 2014, there has been a net decrease of 8 EOEs following 13 closures and 5 new enterprises which have started operation (Table 2).

3. Employment

3.1 Employment – 4th Quarter 2014

Compared to the third quarter of 2014, employment in EOE decreased by 521 (-0.9%) from 55,098 to 54,577. Male employment decreased by 493 from 25,575 to 25,082 and female employment decreased by 28 from 29,523 to 29,495 (Table 2).

The number of Mauritians employed in the EOE sector went down by 436 (-1.4%) from 32,222 to 31,786 and the number of foreign workers decreased by 85 (-0.4%) from 22,876 at the end of September 2014 to 22,791 at the end of December 2014 (Tables 2 and 5).

The decrease of 521 in employment during the fourth quarter of 2014 is the net result of 1,088 job losses (913 due to reduction in existing enterprises and 175 due to closures) and creation of 567 new jobs (309 due to expansion of existing enterprises and 258 due to the coming into operation of new enterprises).

Highest number of job losses occurred in the sub sector "Wearing apparel – garments other than pullovers" with a decrease of 322 jobs while jobs were created mainly in "Wearing apparel" with 338 additional jobs.

3.2 Evolution of employment from December 2013 to December 2014

From December 2013 to December 2014, total employment increased by 899 (+1.7%) from 53,678 to 54,577. The number of Mauritian workers decreased by 260 (-20 males and -240 females). However, employment of foreign workers, increased by 1,159 (+944 males and +215 females) (Tables 2 and 5).

Job creation occurred mainly in enterprises engaged in the production of "Wearing apparel – garments other than pullovers", with an increase of 1,190 jobs and in "Food", with an increase of 248 jobs, while jobs were lost mainly in enterprises engaged in the production of "Pullovers", with a decrease of 401 jobs.

Details of changes in employment by product group are given in Tables 3, 4 and 5.

4. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2013 are final, those for 2014 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

4.1 Exports and Imports – 4th Quarter 2014

4.1.1 Exports (f.o.b)

Provisional figures show that EOE exports during the 4th quarter of 2014 amounted to R 11,604 million, that is, R 532 million (-4.4%) lower compared to the third quarter of 2014 (Table 8).

That was mainly the result of decreases in the exports of "Fish & fish preparations" (-R 563 million or -21.6%) and "Textile yarn, fabrics, made up articles" (-R 96 million or - 12.5%), partly offset by an increase in the exports of "Pearls, precious & semi-precious stones" (+R 160 million or +18.5%).

Compared to the corresponding quarter of 2013, EOE exports decreased by R 132 million (-1.1%).

Details on EOE exports by section are given in Table 9.

The United Kingdom (UK), the United States of America (USA) and France remain the principal EOE markets, together accounting for R 6,200 million (53%) of total EOE exports. The Republic of South Africa, Malagasy Republic and Netherlands are among the other main destinations of EOE exports.




Fig 1: EOE Exports by country of destination

Compared to the previous quarter, main changes in exports were as follows:

Exports went up for:

- United Kingdom by R 151 million (+6.5%); and
- Switzerland by R 73 million (+45.3%).

Exports went down for:

- Spain by R 206 million (-38.8%),
- USA by R 205 million (-9.4%); and
- Italy by R 199 million (-37.1%).

Further details are given in Table 11.

4.1.2 Imports (c.i.f)

EOE imports during the 4th quarter of 2014 were estimated at R 7,012 million, representing a decrease of R 415 million (-5.6%) compared to the third quarter of 2014 (Table 8). This decrease due to lower imports of raw materials by R 430 million (-6.1%), partly offset by higher imports of machinery and transport equipment by R 15 million (+4.2%).

Compared to the corresponding quarter of 2013, imports decreased by R 608 million (-8.0%), mainly due to drops in imports of "Fish and fish preparations" by R 131 million (-7.9%), "Jewellery, goldsmiths & silversmiths wares" by R 106 million (-38.1%) and "Machinery specialized for particular industries" by R 101 million (-30.0%), partly offset by rises in "Leather" by R 58 million (+39.5%) and "Meat and meat preparations" by R 53 million (+69.7%).

Details on EOE imports by section are given in Table 10.

4.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 4,592 million in the fourth quarter of 2014 and its ratio to total exports worked out to around 40% compared to 35% in the corresponding quarter of 2013 (Table 8).

4.2 Exports and Imports, Year 2013 and 2014

4.2.1 Exports (f.o.b)

EOE exports in 2014 amounted to R 47,215 million, that is R 437 million or (+0.9%) higher compared to 2013 (Table 9).

4.2.2 Imports (c.i.f)

EOE imports in 2014 amounted to R 27,473 million, R 1,867 million (-6.4%) lower compared to 2013 (Table 10). This decrease is mainly due to a decrease in the imports of raw materials (-7.0%), partly offset by a rise in the imports of machinery and transport equipment (+4.6%).

4.2.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 19,742 million for 2014 and its ratio to total exports worked out to around 42% compared to 37% in 2013 (Table 8).

It is to be noted that the above external trade figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport are considered as local sales and were valued at R 369 million in 2014 compared to R 262 million in 2013. These sales are included in exports of Freeport, as and when the goods leave the country.
