Export Oriented Enterprises (EOE) 1st Quarter 2015

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of March 2015.

It also includes provisional figures on EOE imports and exports for the 1st quarter of 2015 as well as revised figures for the years 2013 and 2014. Table 1 shows the main indicators of the EOE sector for the period 2007 to 2014.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Enterprises

The number of export-oriented enterprises decreased from 311 at the end of December 2014 to 304 at the end of March 2015, following the closure of seven enterprises.

3. Employment

3.1 Employment – 1st Quarter 2015

Compared to the fourth quarter of 2014, employment in EOE decreased by 460 (-0.8%) from 54,877 to 54,417. Male employment increased by 11 to reach 25,346, but female employment decreased by 471 from 29,542 to 29,071 (Table 2).

The number of Mauritians employed in the EOE sector went down by 532 (-1.7%) from 31,998 to 31,466 while the number of foreign workers increased by 72 (+0.3%) from 22,879 at the end of December 2014 to 22,951 at the end of March 2015 (Tables 2 and 5).

The decrease of 460 in employment during the first quarter of 2015 is the result of 1,360 job losses (1,158 due to reduction in existing enterprises and 202 due to closures) and creation of 900 new jobs due to expansion of existing enterprises.

Highest number of job losses occurred in the sub sector "Wearing apparel" with a decrease of 568 jobs while jobs were created mainly in "Food" with 192 additional jobs.

3.2 Evolution of employment from March 2014 to March 2015

From March 2014 to March 2015, total employment decreased by 841 (-1.5%) from 55,258 to 54,417. The number of Mauritian workers decreased by 1,464 (-533 males and -931 females). However, employment of foreign workers increased by 623 (+571 males and +52 females) (Tables 2 and 5).

Job creation occurred mainly in enterprises engaged in the production of "Food", with an increase of 265 jobs and in "Leather products and footwear", with an increase of 71 jobs, while jobs were lost mainly in enterprises engaged in the production of "Pullovers", with a decrease of 611 jobs and in "Other garments" with a decrease of 306 jobs.

Details of changes in employment by product group are given in tables 3, 4 and 5.

4. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2013 are final, those for 2014 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

4.1 Exports and Imports – 1st Quarter 2015

4.1.1 Exports (f.o.b)

Provisional figures show that EOE exports during the 1st quarter of 2015 amounted to R 11,202 million, that is, R 947 million (-7.8%) lower compared to the fourth quarter of 2014 (Table 6).

That was mainly the result of decreases in the exports of "Articles of apparel and clothing" of R 787 million (-13.1%) and "Pearls, precious & semi-precious stones" of R 178 million (-17.4%).

Compared to the corresponding quarter of 2014, EOE exports decreased by R 160 million (-1.4%).

Details on EOE exports by section are given in Table 7.

The United Kingdom (UK), the United States of America (USA) and France remain the principal EOE markets, together accounting for R 5,382 million (48.0%) of total EOE exports. The Republic of South Africa, Madagascar and Italy are among the other main destinations of EOE exports.




Fig 1: EOE Exports by country of destination

Compared to the previous quarter, main changes in exports were as follows:

Exports went up for:

- Italy by R 114 million (+30.6%);
- Madagascar by R 163 million (+30.3%)

Exports went down for:

- United Kingdom by R 361 million (-14.5%);
- France by R 330 million (-18.0%); and
- USA by R 227 milion (11.5%).

Further details are given in Table 9.

4.1.2 Imports (c.i.f)

EOE imports during the 1st quarter of 2015 were estimated at R 6,327 million, representing a decrease of R 946 million (-13.0%) compared to the fourth quarter of 2014 (Table 8). This decrease is due to lower imports of raw materials by R 877 million (-12.7%), and machinery and transport equipment by R 69 million (-18.4%).

Compared to the corresponding quarter of 2014, imports decreased by R 325 million (-4.9%), mainly due to drops in imports of "Machinery specialized for particular industries" by R 175 million (-47.7%) and "Fish and fish preparations" by R 87 million (-7.1%).

Details on EOE imports by section are given in Table 8.

4.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 4,875 million in the first quarter of 2015 and its ratio to total exports worked out to around 44% compared to 41% in the corresponding quarter of 2014 (Table 6).

It is to be noted that the above external trade figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport are considered as local sales and were valued at R 80 million in the first quarter of 2015 compared to R 89 million in the first quarter of 2014. These sales are included in exports of Freeport, as and when the goods leave the country.
