# **Quarterly Export and Import Price Indices**

4th Quarter 2015 (Base year: 2013=100)

#### 1. Introduction

The Export Price Index (EPI) provides an overall measure of pure price changes (in Mauritian rupees) of goods exported to other countries. The Import Price Index (IPI), on the other hand, measures pure price changes (in Mauritian rupees) of goods purchased from other countries.

This issue of Economic and Social Indicators presents a series of export and import price indices for the period covering the first quarter of 2014 to the fourth quarter of 2015 with year 2013 as base year. The weights have been derived from exports and imports data for the base year, while the average import and export prices of representative products in 2013 have been used as base prices.

The methodology used and the weight structure are given in the technical notes at Annex.

## 2. Terms of trade (base year: 2013 = 100)

The terms of trade index is the ratio of export price index to import price index. A rise in this ratio indicates that the terms of trade have moved in favour of Mauritius. During the fourth quarter of 2015, export prices rose by 2.0% and import prices dropped by 5.3%, when compared to the previous quarter. Consequently, the terms of trade index went up by 8.7 points from 113.2 in the third quarter to 121.9 in the fourth quarter of 2015. Compared to the corresponding quarter of 2014, the terms of trade increased by 19.3 points.

# 3. Export Price Index (EPI) – (Tables 1 - 4)

#### 3.1 Structure of the EPI

The EPI covers four of the 10 sections of the Standard International Trade Classification (SITC Rev. 4), namely "Food and live animals", "Chemicals and related products", "Manufactured goods classified chiefly by material" and "Miscellaneous manufactured articles". Exports of goods falling under these sections covered 91.0% of total exports in the base year. Sub indices are also available at division and section level of the SITC (Table 1).

# 3.2 Changes in quarterly EPI (4<sup>th</sup> quarter 2015)

#### 3.2.1 Overall Index

The average quarterly EPI increased from 97.7 for the third quarter of 2015 to 99.6 for the fourth quarter of 2015, representing an increase of 2.0%. That was mostly due to increases in the prices of "Food and live animals" (+2.5%) and "Miscellaneous manufactured articles" (+1.5%)

Compared to price levels in the corresponding quarter of 2014, the index rose by 5.4%, mainly explained by a price increase in "Miscellaneous manufactured articles" (+11.8%), partly offset by a decrease in the prices of "Food and live animals" (-1.7%).

#### 3.2.2 Section 0: Food and live animals

"Food and live animals" which carries 49.1% of the total weight, is the most important section covered by the export price index. It consists mostly of "Fish and fish preparations" (50.0%) and "Sugar, sugar preparations and honey" (41.4%).

During the fourth quarter of 2015, the sub-index for "Food and live animals" increased to 86.2 from 84.1 in the previous quarter, representing an increase of 2.5%. That was mainly due to increases of 4.7% in the export prices of "Fish and fish preparations" and 0.5% in the export prices of "Sugars, sugar preparations and honey".

Compared to the corresponding quarter of 2014, the index fell by 1.7%, due to a decrease of 7.4% in the prices of "Fish and fish preparations", partly offset by an increase of 2.2% in the prices of "Sugars, sugar preparations and honey".

#### 3.2.3 Section 5: Chemicals and related products, n.e.s

The export price index for "Chemicals and related products, n.e.s" which stood at 103.7 in the third quarter of 2015, increased to 140.3 in the fourth quarter of 2015, representing a change of +0.6%. That was mainly due to an increase in the prices of "Medicinal and pharmaceutical products" (+0.6%).

Compared to the corresponding quarter of 2014, the index increased by 5.9%.

# 3.2.4 Section 6: Manufactured goods classified chiefly by material

During the fourth quarter of 2015, the index for "Manufactured goods classified chiefly by material" rose from 105.3 to 108.9, when compared to the previous quarter. This rise is mainly explained by an increase of 3.4% in the prices of "Textile yarn and fabrics".

Compared to the corresponding quarter of 2014, the index rose by 9.4%.

#### 3.2.5 Section 8: Miscellaneous manufactured articles

"Miscellaneous manufactured articles" carries about 45.7% of the total weight. It consists mainly of "Articles of apparel and clothing accessories" (92.6%).

During the fourth quarter of 2015, the index for "Miscellaneous manufactured articles" increased by 1.5% compared to the previous quarter. That was due to an increase of 1.7% in the prices of "Articles of apparel and clothing accessories".

Compared to the corresponding quarter of 2014, the index rose by 11.8%, mainly following an increase of 12.6% in the prices of "Articles of apparel and clothing accessories".

#### 4. Import Price Index (IPI) (Tables 5 - 8)

#### 4.1 Structure of the IPI

The IPI covers nine out of the 10 Standard International Trade Classification sections. The only section not covered is "Commodities and transactions not classified elsewhere", because of the heterogeneity of the products and the inherent difficulties in pricing items of a constant quality. Imports of goods falling under the covered sections, make up for 89.0% of total imports in the base year. Sub indices are also available at division and section level of the SITC (Table 5).

# 4.2 Changes in quarterly IPI (4<sup>th</sup> quarter 2015)

# 4.2.1 Overall Index

The Import Price Index (IPI) calculated on a quarterly basis dropped by 5.3% from 86.3 in the third quarter of 2015 to 81.7 in the fourth quarter of 2015. That was mainly the effect of decreases in the prices of "Mineral fuels, lubricants and related materials" (-9.7%), "Food and live animals" (-8.5%) and "Manufactured goods classified chiefly by material" (-1.2%).

Compared to the corresponding quarter of 2014, the index went down by 11.3%, mainly as a result of decreases in the prices of "Mineral fuels, lubricants and related materials" (-31.6%) and "Food and live animals" (-6.4%), partly offset by an increase in the prices of "Manufactured goods classified chiefly by material" (+7.1%).

#### 4.2.2 Section 0: Food and live animals

"Food and live animals" which carries 25.1% of the total weight of the import price index consists mostly of "Fish and fish preparations" and "Cereals and cereal preparations".

The index for this section fell by 8.5% from 98.7 in the third quarter to 90.3 in the fourth quarter of 2015. This fall is mainly attributable to a decrease in the prices of "Fish and fish preparations" (-15.6%).

Compared to the fourth quarter of 2014, the index went down by 6.4%, mainly due to decreases in the prices of "Fish and fish preparations" (-11.6%) and "Cereals and cereal preparations" (-7.2%), partly offset by an increase in the prices of "Miscellaneous edible products and preparations" (+12.6%).

#### 4.2.3 Section 3: Mineral fuels, lubricants and related materials

"Mineral fuels, lubricants and related materials" consisting mainly of "Petroleum, petroleum products and related materials", makes up for 40.0% of the weight of the IPI.

This sub index decreased by 9.7% from 62.4 in the third quarter of 2015 to 56.3 in the fourth quarter of 2015, due to decreases in the prices of "Petroleum, petroleum products and related materials" (-11.2%) and "Coal, coke and briquettes" (-5.9%), partly offset by an increase in the prices of "Gas, natural and manufactured" (+8.5%).

Compared to the corresponding period of 2014, the index fell by 31.6%, mainly as a result of price decreases in "Petroleum, petroleum products and related materials" (-33.5%) and "Gas, natural and manufactured" (-21.5%).

#### 4.2.4 Section 5: Chemical materials & related products, n.e.s

The index for "Chemical materials & related products, n.e.s" decreased by 1.3% from 103.1 in the third quarter of 2015 to 101.8 in the fourth quarter of 2015. That was mainly due to a decrease in the prices of "Plastics in primary forms" (-11.8%).

Compared to the fourth quarter of 2014, the index increased by 3.4% as a result of an increase in the prices of "Medicinal and pharmaceutical products" (+7.2%), partly offset by a decrease in the prices of "Plastics in primary forms" (-17.4%).

#### 4.2.5 Section 6: Manufactured goods classified chiefly by material

The index for "Manufactured goods classified chiefly by material", with 11.2% of the total weight, stood at 106.9 in the fourth quarter of 2015. Compared to the previous quarter figure of 108.2, a decrease of 1.2% is noted; mainly due to decreases in the prices of "Non-ferrous metals" (-9.1%) and "Manufactures of metals, n.e.s." (-6.4%), partly offset by an increase in the prices of "Non-metallic mineral manufactures, n.e.s." (+2.0%).

Compared to the fourth quarter of 2014, the index increased by 7.1%, mainly due to price increases in "Leather, leather manufactures, n.e.s., & dressed furskins" (+38.7%) and "Textile yarn, fabrics, made-up articles, n.e.s" (+13.1%).

#### 4.2.6 Section 7: Machinery and transport equipment

The index for "Machinery and transport equipment" reached 101.6 in the fourth quarter of 2015 from 101.4 in the third quarter of 2015, that is, an increase of 0.2%. That was mainly due to an increase in the prices of "Road vehicles" (+0.7%), partly offset by a decrease in the prices of "General industrial machinery & equipment, n.e.s." (-2.6%).

Compared to the corresponding quarter of 2014, the index increased by 2.1% from 99.5 to 101.6. This rise is mainly explained by an increase in the prices of "Road vehicles" (+3.0%).

#### 5. Past trends

Quarterly figures for EPI and IPI in this publication are not strictly comparable with previously published series worked out using 2007 as base year. Chain linked indices using 2013 as the base year have been worked out using appropriate conversion factors and are given at tables 4 and 8.

# **Export Price Index (EPI)**

#### Methodology for the Construction of the EPI (Base year: 2013=100)

#### **Definition**

The Export Price index (EPI) provides an overall measure of pure price changes in Mauritian Rupees of goods exported to other countries. This index is constructed from the export prices of a "constant" well-defined representative basket of commodities selected from trade data in the base year.

The first series of EPI was calculated with year 1993 as base. It was subsequently rebased to year 1997, 2003, 2007 and the present series has as base period year 2013.

#### Scope and classification

The 2013 index is based on the Nomenclature of the Standard International Trade Classification of the United Nations (SITC Rev 4). Separate sub-indices are produced for each SITC section and division.

The EPI covers total exports (domestic exports and re-exports). The most important commodities in the 2013 EPI are "Articles of apparel and clothing accessories", "Fish and fish preparations" and "Sugar".

However, some commodities were excluded in the computation of the weights because of their heterogeneity and the inherent difficulties in pricing them to a constant quality. Those were precious stones, jewellery, recorded media and free publications, and all products classified within the Sections 1, 3, 7 and 9 of the SITC; together they accounted for around 9% of total exports in 2013.

The index thus covers about 91% of the value of merchandise exported during 2013. Commodities directly represented (i.e, price movements followed) constitute 70% of the total value of exports. For the 21% not directly represented, their prices are considered to move similarly to those represented directly.

#### Selection of products to be priced and outlets

Around 55 exporters (outlets) have been selected from trade declarations submitted to the Customs Department in 2013 for pricing of the commodities through quarterly price surveys. These exporters are the major ones trading on a regular basis.

A total of around 140 products, representing the 34 commodities directly represented in the index, were selected for pricing on the basis of their share in total exports, regularity of trade of exports and also their importance in the trader's exports. There must also be a sustained demand for the product variety.

Specifications of products to be priced (physical and qualitative) were established in collaboration with the selected exporters to ensure that same items are priced at each price

survey. Specifications include: pricing basis, contract basis, country of destination, unit of measurement, mode of transport, terms of payment, currency and any other conditions like quality and quantity of the product, that have a bearing on the price.

# Weighting scheme

Weights, derived from the 2013 exports, for each section, division, group and commodity, were based on their export values. Products selected for pricing purposes represent all commodities that fall within that weight group.

#### Changes in the weights from 2007 to 2013

The changes in weights at section level are shown in the table below.

#### It is noted that the weight for:

- i. "Food and live animals" increased to 49% in 2013 compared to 34% in 2007, mainly due to the growing importance of "Fish and fish preparations";
- ii. "Miscellaneous manufactured articles", however, decreased from 55% in 2007 to 45% in 2007, due to the lower share of exports of "Articles of apparel and clothing accessories";
- iii. Section 2 of the SITC –"Crude materials, inedible, except fuels" and Section 4 "Animal and vegetable oils, fats and waxes" are not in the 2013 basket because of their low values in 2013 total exports.

#### Base period prices

Monthly prices were collected from selected exporters for each month of 2013 and yearly average prices, known as base year prices, were calculated for each commodity. Monthly indices were calculated and averaged to work out quarterly indices for the base year.

#### **Price collection**

A preliminary survey of the selected exporters was conducted in 2014 to gather information on products (specific brand and type) relating to the selected commodities and monthly prices for 2013 were collected. Hereafter, the selected exporters are visited every quarter but prices are collected for each month of the quarter for the computation of quarterly indices. The collected prices are reported on a free on board (F.O.B.) basis and are mostly contract prices.

#### Uses of the EPI

The Export Price Index is an important economic indicator which is used, inter alia, to

- (i) measure changes in prices of exports
- (ii) analyse the effect of export price changes on the various sectors of the economy
- (iii) calculate changes in the volume of exports
- (iv) calculate the terms of trade (that is the ratio of export prices to import prices)
- (v) analyse the effect of exchange rates on export prices.

It also serves as a basis to assess the competitiveness of Mauritian products in relation to price trends of common products of other countries with which Mauritius competes for markets.

#### Calculation of the EPI

The lowest level (SITC 7 digit) indices are calculated as a geometric average of the price relatives of the basic observations (products). A modified Laspeyres formula, based on the weighted average of price relatives, is used to calculate higher level indices. The mathematical form of the formula is shown below:

#### **Import Price Index (IPI)**

# Methodology for the Construction of the IPI (Base year: 2013=100)

#### Definition

The Import Price Index (IPI) provides an overall measure of pure price changes in Mauritian Rupees of goods imported into the country. This index is constructed from import prices of a "constant" well-defined representative basket of commodities selected from imports data in the base year.

The first series of IPI was calculated with year 2002 as base and reference prices for the year 2003. It was subsequently rebased to year 2007 and the present series has as base period year 2013.

#### Scope and classification

The commodities are classified according to the United Nations Standard International Trade Classification (SITC Rev 4). Sub-indices are produced by SITC section and division.

For the computation of the 2013 weights, some commodities accounting for around 11% of total imports in 2013 were excluded because of their heterogeneity and the inherent difficulties in pricing them to a constant quality. Those were: precious stones, jewellery, cellular telephones, recorded media and free publications, aircraft, helicopters and marine vessels, certain machine parts, textile wastes and Section 9 of the SITC described as "Commodities and transactions not classified elsewhere".

Thus, the index covers about 89% of the value of merchandise imported in 2013. Commodities directly represented (price movements followed), constitute around 55% of the total value of imports. For the 34% not directly represented, their prices are considered to move similarly to those represented directly.

#### Selection of items to be priced and outlets

142 importers (outlets) have been selected from trade declarations submitted to the Customs Department in 2013 for the pricing of the commodities. These importers are the major ones importing the selected commodities on a regular basis.

A total of around 260 products, representing the 104 commodities directly represented, were selected for pricing on the basis of regularity of imports and also their importance in the trader's imports. There must also be a sustained demand for the product variety.

Specifications of products to be priced (physical and qualitative) were established in collaboration with the selected importers to ensure that same items are priced every quarter. Specifications include: pricing basis, contract basis, country of origin, unit of measurement, mode of transport, terms of payment, currency and any other conditions like quality and quantity of the product, that have a bearing on the price.

#### Weighting scheme

Weights, derived from the 2013 imports, for each section, division, group and commodity were based on their import values. Products selected for pricing purposes represent all commodities that fall within that weight group.

# Changes in the weights from 2007 to 2013

The changes in weights at section level are shown in the table below.

It is to be noted that the weight for:

- i. "Food and live animals" increased to nearly 25% in 2013 compared to 18% in 2007, mainly due to the growing importance of "Fish and fish preparations" in our imports and;
- ii. "Mineral fuels, lubricants and related materials" increased to nearly 40% in 2013 compared to 20% in 2007, mainly due to the higher value of the commodities within the section;
- iii. "Manufactured goods classified chiefly by material" decreased from 21% in 2007 to 11% in 2013 due to the lower share of imports of "Textile yarn" and;
- iv. "Machinery and transport equipment" decreased due to the removal of heavy machineries (generators, excavators, etc.) from the basket because of non-regularity of imports and hence difficulties to price them.

#### Base period prices

Quarterly prices were collected from selected importers for each quarter of 2013 and yearly average prices, known as base year prices, were calculated for each commodity and thus, quarterly indices were worked out for the base year.

#### Price collection

A preliminary survey of the selected importers was conducted in 2014 to gather information on the products (specific brand and type) relating to the selected commodities and to collect prices for the four quarters of 2013. Hereafter, the selected importers are visited every quarter to collect required prices for updating the index. Given that most imports occur at intervals longer than a month, prices refer to the last consignment of the quarter. The collected prices are reported on a cost, insurance, freight (C.I.F) basis and are mostly contract prices.

#### Petroleum products and rice

It is to be noted that the index for petroleum products is calculated differently given that these products, namely gasoline, gas oil, aviation fuel, fuel oil, LPG are imported more than once during a quarter. All prices available for the quarter are collected and average prices for the quarter are computed for each product. The same pricing system is applicable for rice imported by the State Trading Corporation.

#### **Uses of the Import Price Index**

The Import Price Index is an important economic indicator which is used, inter alia, to:

- (i) measure changes in prices of imports
- (ii) analyse the effect of import price changes on the various sectors of the economy
- (iii) calculate changes in the volume of imports
- (iv) calculate the terms of trade (that is the ratio of export prices to import prices)
- (v) analyse the effect of exchange rates on import prices.

#### **Calculation of the IPI**

The lowest level indices (SITC 7 digit) are determined as a geometric average of the price relatives of the basic observations (products). A modified Laspeyres formula, based on the weighted average of price relatives, is used to calculate higher level indices.

The mathematical form of the formula is shown below:
