Export Oriented Enterprises (EOE) 4th Quarter 2016

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of December 2016.

It also includes provisional figures on EOE imports and exports for the year 2016 as well as figures for the year 2015. Table 1 shows the main indicators of the EOE sector for the period 2008 to 2016.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Employment

2.1 Employment – 4th Quarter 2016

Compared to the third quarter of 2016, employment in EOE decreased by 82 (-0.2%) from 52,393 to 52,311. Male employment increased by 63 from 25,579 to 25,642 and female employment decreased by 145 from 26,814 to 26,669 (Table 2).

The number of Mauritians employed in the EOE sector went down by 110 (-0.4%) from 29,603 to 29,493 whereas the number of foreign workers increased by 28 (+0.1%) from 22,790 at the end of September 2016 to 22,818 at the end of December 2016 (Table 2).

The decrease of 82 in employment during the fourth quarter of 2016 is the net result of 755 job losses and creation of 673 new jobs in existing enterprises.

2.2 Evolution of employment from December 2015 to December 2016

From December 2015 to December 2016, total employment in EOE decreased by 1,290 (-2.4%) from 53,601 to 52,311. The number of Mauritian workers decreased by 1,532 (-434 males and -1,098 females). Employment of foreign workers increased by 242 (+633 males and -391 females) (Tables 2 and 5).

Job losses occurred mainly in enterprises engaged in the manufacture of "Wearing Apparel" and "Jewellery and related articles" with decreases of 622 and 254 jobs respectively. On the other hand, new jobs were created mainly in "Food" with an increase of 51 jobs.

Details of employment by product group and sex are given in Table 3 whereas changes in employment by product group are given in Table 4.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2015 are final, those for 2016 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 4th Quarter 2016


3.1.1 Exports (f.o.b)


Provisional figures show that EOE exports during the 4^{th} quarter of 2016 amounted to R 11,198 million, that is, R 20 million (+0.2%) higher compared to the third quarter of 2016 (Table 8). That was mainly the result of an increase of R 369 million (+15.0%) in the exports of "Fish and fish preparations", partly offset by a decrease of R 366 million (-6.4%) in "Articles of apparel and clothing".

Compared to the corresponding quarter of 2015, EOE exports decreased by R 682 million (-5.7%).

Details on EOE exports by section are given in Table 9.

United Kingdom (UK), France and United States of America (USA) remain the principal EOE markets, together accounting for R 5,107 million (45.6%) of total EOE exports. The Republic of South Africa, Italy and Netherlands are among the other main destinations of EOE exports (Table 11).





Compared to the previous quarter, main changes in exports were as follows: Exports went down for:

• U.S.A by R 544 million (-26.1%).

Exports went up for:

- Italy by R 352 million (+81.3%); and
- Netherlands by R 143 million (+27.6%).

Further details are given in Table 11.

3.1.2 Imports (c.i.f)

EOE imports during the 4th quarter of 2016 were estimated at R 6,127 million, representing a decrease of R 158 million (-2.5%) compared to the third quarter of 2016 (Table 8). This decrease is due to lower imports of raw materials by R 122 million (-2.1%) and machinery by R 36 million (-10.4%).

Compared to the corresponding quarter of 2015, imports decreased by R 1,031 million (-14.4%), mainly due to falls in imports of "Cotton" by R 280 million (-40.2%) and "Pearls, precious and semi-precious stones" by R 268 million (-37.1%), partly offset by an increase in imports of "Fish and fish preparations" of R 166 million (+11.5%). Details on EOE imports by section are given in Table 10.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 5,071 million in the fourth quarter of 2016 and its ratio to total exports worked out to 45.3% compared to 39.7% in the corresponding quarter of 2015 (Table 8).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport, considered as local sales, were valued at R 99 million in the fourth quarter of 2016 compared to R 80 million in the fourth quarter of 2015. These sales are included in exports of Freeport, as and when the goods leave the country.
