External Merchandise Trade Statistics – 1st Quarter 2017

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the first quarter of 2017 and the years 2015 and 2016. These statistics are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are at times revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department.


Thus, while revised figures for 2015 are published in this indicator, those for 2016 are still provisional and subject to revision as and when MRA - Customs Department submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the first quarter of 2017 was valued at Rs 60,880 million, i.e. 8.9% lower than the previous quarter but 4.3% higher compared to the corresponding quarter of 2016.

During the first quarter of 2017, total exports (including ship's stores & bunkers) were valued at Rs 19,687 million against imports of Rs 41,193 million. The resulting trade deficit worked out to Rs 21,506 million, 14.1% lower than the deficit of Rs 25,028 million of the previous quarter and 30.5% higher than the deficit of Rs 16,485 million of the corresponding quarter of 2016.



3. Exports

3.1 Total exports (Tables 1 & 3) – 1st Quarter 2017

Total export proceeds for the first quarter of 2017, including domestic exports¹, re-exports² and ship's stores and bunkers amounted to Rs 19,687 million, showing a decrease of 5.8% compared to the previous quarter. This is mainly explained by decreases in exports of "Chemicals and related products" (-30.2%), "Miscellaneous manufactured goods" (-20.2%) and "Food and live animals" (-7.0%), partly offset by increases in the exports of "Ships' stores & bunkers" (+29.3%), "Machinery and transport equipment" (+27.1%), and "Manufactured goods classified by material" (+8.2%).

Compared to the corresponding quarter of 2016, total exports for the first quarter of 2017 dropped by 6.0%. This is mainly explained by decreases in exports of "Machinery and transport equipment" (-54.6%) and "Miscellaneous manufactured goods" (-22.9%), partly offset by increases in exports of "Ship's stores & bunkers" (+70.9%) and "Food and live animals" (+10.3%).

Domestic exports amounting to Rs 11,945 million, accounted for 60.7% of total exports in the first quarter of 2017. Compared to a value of Rs 13,954 million recorded in the fourth quarter of 2016, domestic exports fell by 14.4%, while comparison against the corresponding quarter of 2016 shows a decrease of 12.7%.

In the first quarter of 2017, re-exports stood at Rs 5,538 million, i.e. higher by 5.5% compared to the previous quarter, mainly due to increases in re-exports of "Mineral fuels, lubricants and related materials" (+99.6%), "Machinery and transport equipment" (+32.3%) and "Food and live animals" (+4.5%), partly offset by a decrease in "Chemicals & related products, n.e.s (-31.5%). Compared to the corresponding quarter of 2016, re-exports were lower by 7.3%, mainly due to decreases in the re-exports of "Telecommunications equipment & accessories" (-91.6%) and "Chemicals & related products, n.e.s" (-5.7%), partly offset by an increase of 48.1% in "Food and live animals" (Table 5).

3.2 Exports by SITC section (Tables 1 & 3) – 1st Quarter 2017

Around 40.6% of total exports for the first quarter of 2017 consisted of "Food and live animals" (Rs7,103 million), 33.5% of Miscellaneous manufactured goods" (Rs 5,856 million) and 10.2% of "Manufactured goods classified chiefly by material" (Rs 1,785 million).

Compared to the first quarter of 2016, the main changes by section are as follows:

- "Machinery and transport equipment" fell by 54.6%, due to a decrease in the re-exports of "Telecommunications equipment & accessories" (-91.6%).
- "Miscellaneous manufactured goods" dropped by 22.9% mainly due to decreases in the exports of "Jewellery, goldsmiths & silversmiths wares" (-61.5%), "Travel goods, handbags & similar containers" (-23.1%), "Articles of apparel & clothing accessories" (-20.9%) and "Optical goods, n.e.s" (-16.7%).
- "Food and live animals" registered an increase of 10.3%, mainly due to increases in exports of "Cane sugar" (+10.0%), partly offset by decreases in "Live primates" (-3.3%) and "Fish and fish preparations" (-2.9%).
- "Manufactured goods classified chiefly by material" increased by 1.5%, mainly explained by an increase in exports of "Textile yarns, fabrics, made up articles" (+3.4%), partly offset by lower exports of "Pearls, precious and semi-precious stones" (-26.3%)".

¹ Domestic exports are defined as goods of national origin

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.


3.3 Exports of Export Oriented Enterprises (EOE) – 1st Quarter 2017

During the first quarter of 2017, exports of EOE amounted to Rs 9,397 million, compared to Rs 10,528 million in corresponding quarter of 2016 (Table 1). Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 29 June 2017.

3.4 Exports by country of destination (Table 7) – 1st Quarter 2017

Analysis of exports figures by country of destination for the first quarter of 2017 shows that the European countries were our main buyers, purchasing some 47.4% of our exports for a value of Rs 8,280 million. Among countries, the major destinations for our exports were U.S.A (12.2%), France (12.1%), U.K (11.0%), South Africa (7.7%), Italy (7.4%), Madagascar (6.7%) and Spain (5.2%).

Compared to the first quarter of 2016, exports to Spain, U.S.A and France went up by 37.2%, 9.1%, and 6.2% respectively. On the other hand, exports to South Africa, UK, Italy and Madagascar dropped by 24.5%, 21.2%, 14.1% and 10.9% respectively.



4. Imports

4.1 Total imports (Table 10) – 1st Quarter 2017

Total imports for the first quarter of 2017 amounted to Rs 41,193 million, showing a decrease of 10.3% over the previous quarter. This is mainly due to decreases in imports of "Miscellaneous manufactured articles" (-36.4%), "Manufactured goods classified chiefly by materials" (-14.9%), "Chemicals & related products" (-14.9%) and "Machinery and transport equipment" (-14.5%), partly offset by increases in imports of "Mineral fuels, lubricants and related products" (+6.2%) and "Food and live animals" (+0.9%).

Compared to the corresponding quarter of 2016, imports in the first quarter of 2017 rose by 10.0%. This is mainly due to increases in imports of "Mineral fuels, lubricants and related products" (+70.5%), "Food and live animals" (+14.1%) and "Miscellaneous manufactured articles" (+4.5%), partly offset by decreases in the imports of "Manufactured goods classified chiefly by materials" (-5.6%) and "Machinery and transport equipment" (-5.0%).

4.2 Imports by SITC section (Table 10) – 1st Quarter 2017

Around 23.3% of imports in the first quarter of 2017 consisted of "Machinery and transport equipment" (Rs 9,609 million), 22.0% of "Food and live animals" (Rs 9,058 million), 19.3% of "Mineral fuels, lubricants and related materials" (Rs 7,967 million) and 13.8% of "Manufactured goods classified chiefly by materials" (Rs 5,667 million).

Compared to the corresponding quarter of 2016, total imports increased by 10.0%. Main changes by section are as follows:

- "Mineral fuels, lubricants, & related products" increased by 70.5%, mainly due to a rise of 80.6% in the imports of "Refined petroleum products".
- "Food and live animals" increased by 14.1%, mainly due to higher imports of "Meat and meat preparations" (+11.4%), "Fish and fish preparations" (+9.3%) and "Dairy products and bird's eggs" (+5.6%), partly offset by decreases in imports of "Rice" (-16.6%) and "Vegetables and fruits" (-12.4%).
- "Miscellaneous manufactured articles" increased by 4.5%, mainly due to increases in "Prefabricated buildings, sanitary plumbing, heating & lighting fixtures & fittings, n.e.s" (+64.1%), "Jewellery, goldsmiths' & silversmiths' wares, n.e.s" (+19.9%), "Professional, scientific & controlling instruments & apparatus, n.e.s" (+13.6%) and "Articles of apparel and clothing" (+1.2%), partly offset by a decrease in "Footwear (-7.8%).
- "Manufactured goods classified chiefly by material" fell by 5.6%, mainly due to decreases in the imports of "Cement" (-33.9%), "Pearls & precious stones" (-33.2%), and "Cotton fabrics" (-25.9%), partly offset by increases in imports of "Iron and steel" (+27.3%) and "Manufactures of metals, n.e.s" (+10.4%).
- "Machinery and transport equipment" decreased by 5.0%, mainly due to decreases in imports of "Telecommunications and sound recording apparatus and reproducing apparatus and equipment" (-56.6%) and "Machinery specialized for particular industries" (-41.0%), partly offset by increases in "Power generating machinery & equipment" (+408.5%), "Electrical machinery, apparatus & appliances, n.e.s & electrical parts thereof" (+30.4%), "Road vehicles" (+15.2%) and "Office machines & automatic data processing machines" (+6.3%).

4.3 Imports by country of origin – 1st Ouarter 2017

During the first quarter of 2017, our imports originated from four main countries, namely: India (17.0%), China (13.4%), South Africa (7.5%) and France (7.4%) - (Table 13).

Among continents Asia was our main supplier with a share of Rs 19,886 million, representing 48.3% of total imports.

Compared to the corresponding period of 2016, total imports from India, South Africa and France rose by 19.2%, 15.2% and 2.4% respectively while those from China fell by 12.1%.




Figure 3: Imports from main countries

5. Trade with Member States of Regional Organisations – 1st Quarter 2017

During the first quarter of 2017, total exports to African, Caribbean and Pacific (ACP) States stood at Rs 4,072 million against imports of Rs 5,754 million (Table 14). The trade deficit with ACP countries worked out to Rs 1,682 million.

Exports to COMESA member states attained Rs 2,085 million while imports from these countries amounted to Rs 2,557 million, resulting in a trade deficit of Rs 472 million. Madagascar was the main buyer with a share of 56.4% followed by Kenya (25.9%). Our main suppliers were Madagascar (45.5%), Seychelles (25.6%), and Kenya (12.4%) - (Table 15).

Trade with SADC countries showed a deficit of Rs 2,297 million, resulting from imports of Rs 5,211 million against exports worth Rs 2,914 million. The main supplier was South Africa (58.9%) and our main buyers were South Africa (46.3%) and Madagascar (40.4%) - (Table 16).

6. Trade in Freeport Zone – 1st Quarter 2017

During the first quarter of 2017, total imports of the Freeport Zone stood at Rs 3,494 million, lower by 26.5% compared to the corresponding quarter of 2016 – (Table 12). Reexports were valued at Rs 4,512 million, representing an increase of 4.1% compared to the corresponding period of 2016 (Table 6). The main items imported and re-exported were from "Food and live animals" and "Machinery and transport equipment".

7. Forecast 2017

Based on recent past trends and information from various sources, total exports for 2017 is forecasted at around Rs 87,000 million and imports at Rs 181,000 million. Trade deficit for 2017 is therefore expected to be around Rs 94,000 million.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the Harmonised Commodity Description and Coding System Nomenclature (HS2017). However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the Standard International Trade Classification (Revision 4) (SITC Rev. 4). The HS and the SITC Rev. 4 are six and five digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
