Export Oriented Enterprises (EOE) 2nd Quarter 2017

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of June 2017.

It also includes provisional figures on EOE imports and exports for the 2nd quarter of 2017 as well as figures for the years 2015 and 2016. Table 1 shows the main indicators of the EOE sector for the period 2008 to 2016.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the Board of Investment.

2. Employment

2.1 Employment – 2nd Quarter 2017

Compared to the first quarter of 2017, employment in EOE decreased by 201 (-0.4%) from 51,954 to 51,753. Male employment decreased by 8 from 25,554 to 25,546 and female employment decreased by 193 from 26,400 to 26,207 (Table 2).

The number of Mauritians employed in the EOE sector dropped by 563 from 29,504 to 28,941 and the number of foreign workers increased by 362 (+1.6%) from 22,450 at the end of March 2017 to 22,812 at the end of June 2017 (Table 2).

The decrease of 201 in employment during the second quarter of 2017 is the net result of 690 job losses and creation of 489 new jobs in existing enterprises.

2.2 Evolution of employment from June 2016 to June 2017

From June 2016 to June 2017, total employment in EOE decreased by 840 (-1.6%) from 52,593 to 51,753. The number of Mauritian workers decreased by 939 (-399 males and -540 females). Employment of foreign workers increased by 99 (+539 males and -440 females) (Tables 2 and 5).

Job losses occurred mainly in enterprises engaged in the manufacture of "Wearing Apparel" with a decrease of 416 jobs. On the other hand, new jobs were created mainly in "Food" with an increase of 63 jobs.

Details of employment by product group and sex are given in Table 3 and changes in employment by product group in Table 4.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2015 are final, those for 2016, 1st quarter and 2nd quarter 2017 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 2nd Quarter 2017

3.1.1 Exports (f.o.b)

Provisional figures show that EOE exports during the 2^{nd} quarter of 2017 amounted to R 11,149 million, that is, R 1,752 million (+18.6%) higher compared to the 1^{st} quarter of 2017 (Table 6). That was mainly the result of increases of R 793 million (+18.7%) in the exports of "Articles of apparel and clothing" and R 723 million (+32.2%) in "Fish and fish preparations".

Compared to the corresponding quarter of 2016, EOE exports decreased by R 544 million (-4.7%).

Details on EOE exports by section are given in Table 7.

France, United Kingdom (UK), United States of America (USA) and South Africa remain the principal EOE markets, together accounting for R 5,981 million (53.6%) of total EOE exports. Italy, Netherlands, Spain and Madagascar are among the other main destinations of EOE exports (Table 9). The table below highlights the changes in our main EOE exports markets.

Compared to the previous quarter, EOE exports to all our main markets showed increases: France (+21.7%), United Kingdom (+13.0%), USA (+18.2%), South Africa (+16.7%), Italy (+51.9%), Netherlands (+30.4%), Spain (+21.9%) and Madagascar (+15.1%).

When compared to the second quarter of 2016, decreases were observed for: France (-10.1%), United Kingdom (-10.0%), USA (-22.4%), and Madagascar (-8.6%). On the other hand, increases were noted for South Africa (+13.8%), Italy (+31.0%), Netherlands (+9.5%) and Spain (+7.1%). Further details are given in Table 9.

3.1.2 Imports (c.i.f)

EOE imports during the 2^{nd} quarter of 2017 were estimated at R 6,933 million, representing an increase of R 1,155 million (+20.0%) compared to the 1^{st} quarter of 2017 (Table 8). This increase is mainly due to higher imports of raw materials by R 1,216 million (+22.5%).

Compared to the corresponding quarter of 2016, imports increased by R 87 million (+1.3%), mainly due to increases in imports of "Cotton" by R 162 million (+75.0%) and "Textile yarn and fabrics" by R 130 million (+9.1%), partly offset by a decrease in imports of "Pearls, precious & semi-precious stones" by R 123 million (-20.6 %). Details on EOE imports by section are given in Table 8.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 4,216 million in the second quarter of 2017 and its ratio to total exports worked out to 37.8% compared to 41.5% in the corresponding quarter of 2016 (Table 6).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport, considered as local sales, were valued at R 53 million in the second quarter of 2017 compared to R 79 million in the second quarter of 2016. These sales are included in exports of Freeport, as and when the goods leave the country.
