Export Oriented Enterprises (EOE) 2nd Quarter 2020

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of June 2020.

It also includes provisional figures on EOE imports and exports for the second quarter of 2020 as well as figures for the years 2018 and 2019. Table 1 shows the main indicators of the EOE sector for the period 2011 to 2019.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the ex-Board of Investment.

2. Employment

2.1 Employment – 2nd Quarter 2020

Compared to the first quarter of 2020, employment in EOE decreased by 837 (-1.9%) from 43,488 to 42,651. Male employment dropped by 427 from 22,697 to 22,270 and female employment decreased by 410 from 20,791 to 20,381 (Table 2).

The number of Mauritians employed in the EOE sector went down by 814 (-3.5%) (-345 males and -469 females) from 23,376 to 22,562 and the number of foreign workers decreased by 23 (-0.1%) (-82 males and +59 females) from 20,112 at the end of March 2020 to 20,089 at the end of June 2020 (Table 2).

The decrease of 837 in employment in the EOE sector during the second quarter of 2020 is the net result of 106 jobs created due to expansion in existing enterprises and 943 jobs lost. The job losses were due to the contraction of workforce.

2.2 Evolution of employment from June 2019 to June 2020

From June 2019 to June 2020, total employment in EOE decreased by 3,897 (-8.4%) from 46,548 to 42,651. The number of Mauritian workers decreased by 2,773 (-961 males and -1,812 females). Employment of foreign workers decreased by 1,124 (-1,343 males and +219 females) (Tables 2 and 5).

Job losses occurred mainly in enterprises engaged in the manufacture of "Wearing apparel" with a decrease of 2,950 jobs.

Details of employment by product group and sex are given in Table 3 and changes in employment by product group in Table 4.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2018 are final, those for 2019 and for first and second quarters 2020 are subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 2nd Quarter 2020

3.1.1 Exports (f.o.b)

Provisional figures show that EOE exports which was declining since the third quarter of 2019, plummeted during the second quarter of 2020 to reach R 5,304 million, that is, R 4,231 million (-44.4%) lower compared to R 9,535 million in the first quarter of 2020 (Table 6). That was mainly the result of decreases observed in exports of "Articles of apparel and clothing" (-R 2,039 million or -53.7%) and "Fish and fish preparations" (-R 953 million or -37.2%).

Compared to the figure of R 11,461 million for the corresponding quarter of 2019, EOE exports decreased by R 6,157 million or -53.7%.

Details on EOE exports by section are given in Table 7.

United Kingdom (UK), United States of America (USA), France and Italy, together accounted for R 3,066 million (57.8%) of total EOE exports (Table 9). The table below highlights the changes in our main EOE exports markets.

Compared to the previous quarter, EOE exports to our main markets showed decreases as follows: USA (-41.0%), United Kingdom (-30.9%), France (-21.5%) and Italy (-4.9%).

When compared to the second quarter of 2019, decreases of 52.0%, 46.6%, 43.3% and 10.6% were noted for USA, United Kingdom, France and Italy respectively. Further details are given in Table 9.

3.1.2 Imports (c.i.f)

EOE imports during the second quarter of 2020 were estimated at R 3,693 million, representing a decrease of R 1,118 million (-23.2%) compared to R 4,811 million in the first quarter of 2020 (Table 6). This decrease is mainly due to lower imports of raw materials by R 1,106 million (-24.1%).

Compared to the figure of R 6,195 million for the corresponding quarter of 2019, EOE imports decreased by R 2,502 million (-40.4%), mainly due to decreases in imports of "Pearls, precious and semi-precious stones" by R 690 million (-82.8%), "Fish & fish preparations" by R 623 million (-40.6%) and "Textile yarn and fabrics" by R 550 million (-39.7%). Details on EOE imports by section are given in Table 8.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 1,611 million in the second quarter of 2020 and its ratio to total exports worked out to 30.4% compared to 45.9% in the corresponding quarter of 2019 (Table 6).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport, considered as local sales, were valued at R 5 million in the second quarter of 2020 compared to R 58 million in the second quarter of 2019. These sales are included in exports of Freeport, as and when the goods leave the country.
