

External Merchandise Trade Statistics

3rd Quarter 2020

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics from the first to third quarters of 2020 and the years 2018 and 2019. These statistics are compiled from declarations lodged at the Customs Department of the Mauritius Revenue Authority (MRA), by importers and exporters. Some of these declarations are usually revised at a later period and corrections are made accordingly on the computerised database of the Mauritius Revenue Authority (MRA).

Thus, while revised figures for 2018 and 2019 are published in this indicator, those for 2020 are still provisional and subject to revision as and when the Customs Department of the MRA submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the third quarter of 2020 was valued at Rs 59,826 million, i.e. 27.8% higher than the value of Rs 46,818 million of the previous quarter and 16.3% lower than the value of Rs 71,515 million of the corresponding quarter of 2019.

For the third quarter of 2020, total exports (inclusive of ship's stores & bunkers¹) were valued at Rs 19,561 million against total imports of Rs 40,265 million.

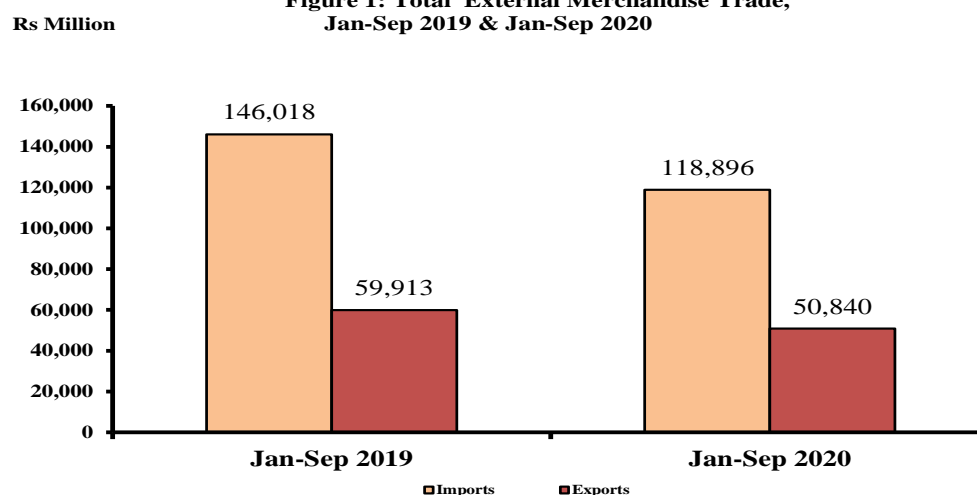
In the previous quarter, total exports (inclusive of ship's stores and bunkers) amounted to Rs 12,279 million against total imports of Rs 34,539 million while for the corresponding quarter of 2019, total exports (inclusive of ship's stores & bunkers) amounted to Rs 20,166 million against total imports of Rs 51,349 million.

In the third quarter of 2020, total exports and total imports were higher by 59.3% and 16.6% respectively, compared to previous quarter while compared to the corresponding quarter of 2019, total exports and total imports went down by 3.0% and 21.6% respectively.

The resulting trade deficit for the third quarter of 2020 worked out to Rs 20,704 million, 7.0% lower than the deficit of Rs 22,260 million of the previous quarter and 33.6% lower than the deficit of Rs 31,183 million of the corresponding quarter of 2019.

From Figure 1, compared to the first nine months of 2019, total exports (inclusive of ship's stores & bunkers) dropped from Rs 59,913 million to Rs 50,840 million, showing a decrease of around 15.1%. A similar decreasing trend was observed in total imports for the same period. Total imports, fell by 18.6% in first nine months of 2020, compared to the corresponding period. Consequently, the trade deficit for the first nine months of 2020 works out to around Rs 68,056 million, compared to Rs 86,105 million in the corresponding period of 2019, showing an impact of 21.0%.

3. Total Exports

3.1 Total exports (Tables 1 & 3) – 3rd Quarter & January to September 2020

Total exports proceeds for the third quarter of 2020, including domestic exports², re-exports³ and ship's stores and bunkers amounted to Rs 19,561 million, showing an increase of 59.3%, compared to the previous quarter. This is mainly explained by increases in the exports of "Manufactured goods classified chiefly by material" (+156.7%), "Miscellaneous manufactured articles" (+134.6%) and "Food and live animals" (+30.9%), partly offset by a decrease in exports "Ship's stores & bunkers" (-8.5%).

Compared to the corresponding quarter of 2019, total exports for the third quarter of 2020 decreased by 3.0%. This is mainly explained by decreases in exports of "Ship's stores & bunkers" (-45.4%) and "Miscellaneous manufactured articles" (-0.6%), partly offset by increases in the exports of "Manufactured goods classified chiefly by material" (+10.4%) and "Food and live animals" (+9.7%).

Compared to corresponding period of 2019, total exports for the first nine months of 2020, decreased by 15.1% which is mainly explained by decreases in the exports of "Miscellaneous manufactured articles" (-25.5%), "Manufactured goods classified chiefly by material" (-18.5%), "Ship's stores & bunkers" (-18.1%), and "Food and live animals" (-5.3%), partly offset by an increase in "Crude materials, inedible, except fuels" (+62.1%).

Domestic exports, amounting to Rs 14,226 million, accounted for 72.7% of total exports in the third quarter of 2020. Compared to a value of Rs 7,588 million recorded in the second

quarter of 2020, domestic exports increased by 87.5%. This is mainly explained by increases in domestic exports of “Manufactured goods classified chiefly by material” (+183.6%), “Miscellaneous manufactured articles” (+157.1%), “Crude materials, inedible, except fuels” (+82.1%), “Food and live animals” (+28.9%) and “Chemicals and related products, n.e.s.” (+14.3%).

Compared to the corresponding quarter of 2019, domestic exports were higher by 9.1%, mainly explained by increases in exports of “Manufactured goods classified chiefly by material” (+10.8%), “Food and live animals” (+8.8%), “Miscellaneous manufactured articles” (+4.2%) and “Chemicals and related products, n.e.s.” (+2.2%).

Compared to corresponding period of 2019, domestic exports for the first nine months of 2020, was lower by 14.2%. This decrease is mainly due to decreases in “Miscellaneous manufactured articles” (-23.8%), “Manufactured goods classified chiefly by material” (-19.9%), “Food and live animals” (-5.4%) and “Chemicals and related products” (-1.6%).

For the third quarter of 2020, re-exports stood at Rs 3,246 million, i.e. higher by 34.9% compared to the previous quarter, mainly due to increases in re-exports of “Food and live animals” (+40.5%) and “Chemicals and related products” (+16.2%), partly offset by decreases in re-exports of “Miscellaneous manufactured articles” (-10.6%) and “Crude materials, inedible, except fuels” (-8.0%) (*Table 5*).

Compared to the corresponding quarter, re-exports of merchandise goods dropped by 1.8% mainly explained by decreases in “Miscellaneous manufactured articles” (-46.8%), partly offset by increases in “Food and live animals” (+13.7%) and, “Manufactured goods classified chiefly by material” (+6.8%).

Compared to the corresponding period of 2019, re-exports decreased by 15.8% in the first nine months of 2020. This decrease is mainly due to fall in exports of “Miscellaneous manufactured articles” (-40.5%), “Machinery and transport equipment” (-22.8%), “Manufactured goods classified chiefly by material” (-7.5%) and “Food and live animals” (-4.6%), partly offset by an increase in “Chemicals and related products” (+0.1%).

3.3 Exports of Export Oriented Enterprises (EOE) –3rd Quarter 2020

For the third quarter of 2020, exports of EOE amounted to Rs 11,458 million, compared to Rs 5,304 million in previous quarter (+116.0%) and to Rs 10,677 million in the corresponding quarter of 2019 (+7.3%) (*Table 1*).

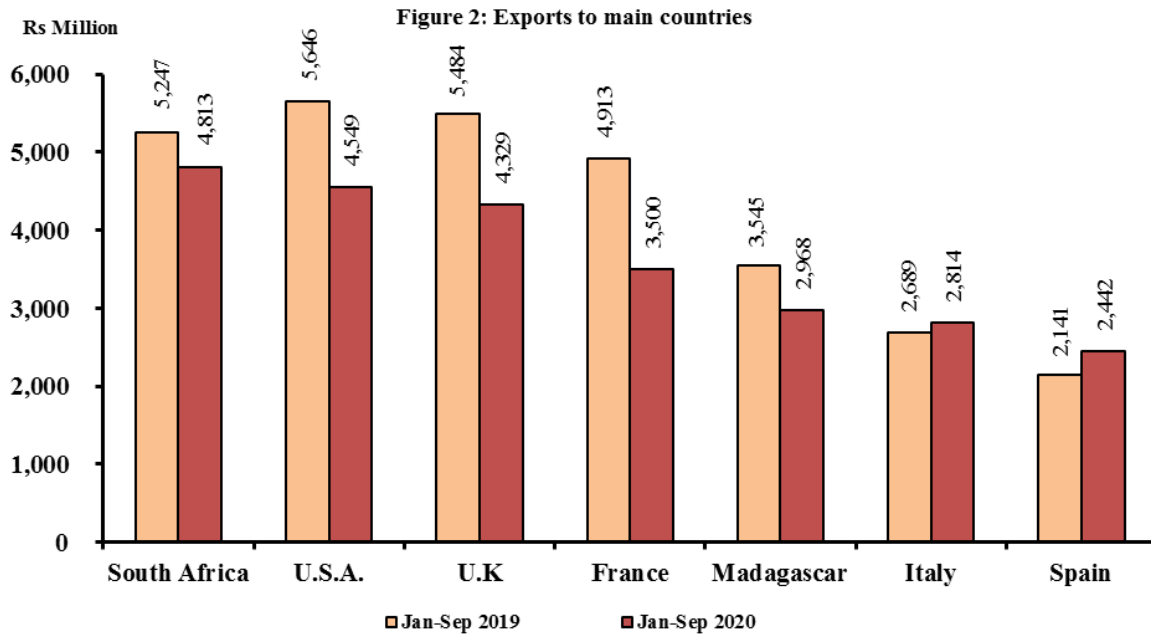
Compared to the corresponding period in 2019, exports of EOE decreased by 18.5%, from Rs 32,276 million to Rs 26,297 million in the first nine months of 2020.

Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 23 December 2020.

3.4 Exports by country of destination (Table 7) – 3rd Quarter 2020

Analysis of exports figures by country of destination for the third quarter of 2020 shows that the European countries were our main buyers, purchasing some 44.6% of our exports for a value of Rs 7,784 million. Among countries, the major destinations for our exports were South Africa (14.7%), U.S.A. (11.0%), U.K (10.4%), France (7.6%), Italy (6.2%), Madagascar (5.8%) and Spain (5.7%).

Compared to the corresponding quarter of 2019, exports to South Africa, Italy, Spain, U.S.A, and U.K, increased by 34.6%, 31.2%, 28.0%, 6.7% and 1.6% respectively, while exports to Madagascar and France dropped by 11.6% and 8.8% respectively.



From Figure 2, compared to the corresponding period of 2019, exports to most main markets decreased in the first nine months of 2020. Exports to France, UK, U.S.A, Madagascar and South Africa witnessed decreases of 28.8%, 21.1%, 19.4%, 16.3% and 8.3% respectively, as compared to Spain and Italy which have witnessed increases of 14.1% and 4.6% respectively.

4. Total Imports

4.1 Total imports (Table 10) – 3rd Quarter & January to September 2020

Total imports for the third quarter of 2020 amounted to Rs 40,265 million, showing an increase of 16.6%, compared to the previous quarter. This is mainly due to increases in imports of “Miscellaneous manufactured articles” (+63.3%), “Manufactured goods classified chiefly by material” (+25.6%), “Machinery and transport equipment” (+19.7%), “Mineral fuels, lubricants and related materials” (+17.2%), and “Food and live animals” (+0.2%), partly offset by a decrease in “Beverages and tobacco” (-23.2%).

Compared to the corresponding quarter of 2019, total imports for the third quarter of 2020 decreased by 21.6%. This is mainly due to decreases in imports of “Mineral fuels, lubricants and related materials” (-52.5%), “Machinery and transport equipment” (-33.9%), “Miscellaneous manufactured articles” (-19.8%), “Manufactured goods classified chiefly by material” (-12.2%) and “Chemicals and related products” (-2.6%), partly offset by an increase in the imports of “Food and live animals” (+9.6%).

Compared to the corresponding period of 2019, total imports decreased by 18.6% in the first nine months of 2020. This decline is mainly explained by decreases in the imports of “Mineral fuels, lubricants, & related products” (-30.3%), “Miscellaneous manufactured articles” (-26.2%), “Machinery & transport equipment” (-24.1%), “Manufactured goods classified chiefly by material” (-22.2%) and “Chemicals and related products, n.e.s.” (-10.2%), partly offset by an increase in “Food and live animals” (+2.4%).

4.2 Imports by SITC section (Table 10) – 3rd Quarter 2020

Around 23.4% of imports in the third quarter of 2020 consisted of “Food and live animals” (Rs 9,416 million), 21.0% of “Machinery and transport equipment” (Rs 8,436 million), 17.4% of “Manufactured goods classified chiefly by material” (Rs 6,996 million), 11.6% “Mineral fuels, lubricants and related materials” (Rs 4,676 million), 10.6% of “Chemicals and related products” (Rs 4,280 million) and 10.3% of “Miscellaneous manufactured articles” (Rs 4,158 million).

Compared to the corresponding quarter of 2019, total imports decreased by 21.6%. Main changes by section are as follows:

- “Mineral fuels, lubricants and related materials” decreased by 52.5%, mainly due to decreases in the imports of “Refined petroleum products” (-53.6%) and “Gas, natural and manufactured” (-52.8%).
- “Machinery and transport equipment” decreased by 33.9%, mainly due to decreases in the imports of “Power generating machinery & equipment” (-40.4%), “General industrial machinery & equipment, n.e.s., & machine parts, n.e.s.” (-34.4%), “Road vehicles” (-33.6%), and “Telecommunications & sound recording & reproducing apparatus & equipment” (-6.6%).
- “Miscellaneous manufactured articles” decreased by 19.8%, mainly due to decreases in the imports of “Articles of apparel and clothing” (-15.1%), “Articles n.e.s., of plastic” (-11.3%) and “Professional, scientific & controlling instruments & apparatus, n.e.s.” (-10.4%).
- “Manufactured goods classified chiefly by material” decreased by 12.2%, mainly due to decreases in the imports of “Paper, paperboard & articles thereof” (-29.2%), “Pearls, precious & semi-precious stones” (-12.1%), “Textile yarn” (-8.1%) and “Manufactures of metal, n.e.s.” (-4.4%).

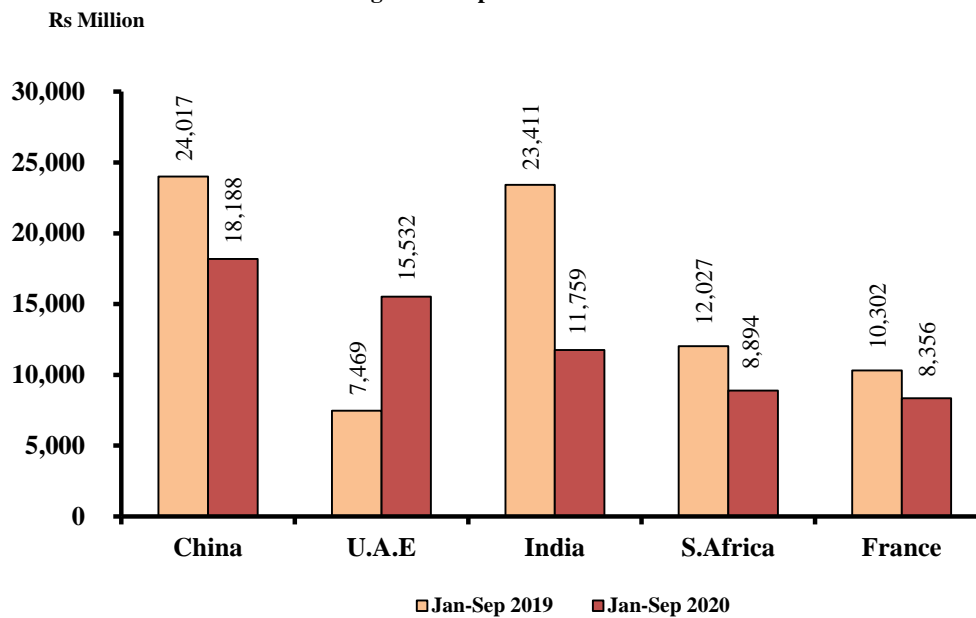
Note that the above mentioned decreases were partly offset by increases in imports of “Food and live animals” (+9.6%) and “Animal & vegetable oils and fats” (+9.0%).

4.3 Imports by country of origin – 3rd Quarter 2020

During the third quarter of 2020, our imports originated from five main countries, namely: China (16.0%), India (10.8%), U.A.E (9.5%), France (7.7%), South Africa (6.9%) and Spain (3.7%) (*Table 13*). Among continents, Asia was our main supplier with a share of Rs 21,332 million, representing 53.0% of total imports.

Compared to the corresponding period of 2019, total imports from Spain, U.A.E, India, South Africa, China and France fell by 34.9%, 28.4%, 26.9%, 24.5%, 22.9% and 1.9% respectively.

From the above Figure 3, compared to the corresponding period of 2019, India, South Africa, China and France have witnessed decreases of 49.8%, 26.0%, 24.3% and 18.9% in total imports for the first nine months of 2020, respectively, as compared to total imports from U.A.E which has increased by 108.0%.

5. Trade with Member States of Regional Organizations – 3rd Quarter 2020

During the third quarter of 2020, total exports to African, Caribbean and Pacific (ACP) States stood at Rs 4,632 million against imports of Rs 4,349 million (*Table 14*). The trade surplus with ACP countries worked out to Rs 283 million. South Africa is the main supplier and buyer, with a share of 64.3% and 55.5% respectively.

Exports to COMESA member states attained Rs 1,874 million while imports from these countries amounted to around Rs 1,581 million, resulting in a trade surplus of Rs 293 million. Madagascar was the main buyer with a share of 53.7% followed by Seychelles (18.4%). Our main suppliers were Seychelles (43.4%), Kenya (24.2%), Egypt (14.7%) and Madagascar (12.8%) (*Table 15*).

Trade with SADC countries showed a surplus of Rs 231 million, resulting from imports of Rs 3,859 million against exports worth Rs 4,090 million. The main buyers were South Africa (62.9%) and Madagascar (24.6%) and the main suppliers were South Africa (72.5%) and Seychelles (17.8%) (*Table 16*).

6. Trade in Freeport Zone – 3rd Quarter 2020

During the third quarter of 2020, total imports of the Freeport Zone stood at Rs 2,260 million, lower by 15.3% compared to the corresponding quarter of 2019 and by 77.8% compared to the previous quarter – (*Table 12*).

Compared to the corresponding period of 2019, Freeport imports fell by 29.0% in the first nine months of 2020 mainly explained by decreases in “Miscellaneous manufactured articles” (-35.5%) and “Machinery and transport equipment” (-19.9%), partly offset by increases in “Manufactured goods classified chiefly by” (+9.4%) and “Food and live animals” (+7.5%).

In the third quarter of 2020, Freeport re-exports were valued at Rs 2,110 million, representing an increase of 17.7% compared to the previous quarter and a decrease of 10.8% compared to the corresponding quarter of 2019 (*Table 6*).

Compared to corresponding period of 2019, a decrease of 18.1% was noticed in the first nine months, mainly explained by decreases in “Miscellaneous manufactured articles” (-46.4%) and “Food and live animals” (-4.0%).

7. Forecast 2020

Total exports for 2020 is forecasted at around Rs 68,200 million and total imports at around Rs 169,100 million.

The trade deficit for 2020 is forecasted at around Rs 100,900 million, 15.8% lower compared to 2019.

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis, whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to **the Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six- and five-digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
