

External Merchandise Trade Statistics

4th Quarter and Year 2020

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the years 2019 and 2020. These statistics are compiled from declarations lodged at the Customs Department of the Mauritius Revenue Authority (MRA), by importers and exporters. Some of these declarations are usually revised at a later period and corrections are made accordingly on the computerised database at the Customs Department.

Thus, while revised figures for 2019 are published in this indicator, those for 2020 are still provisional and subject to revision as and when the Customs Department of the MRA submits latest amendments to Statistics Mauritius.

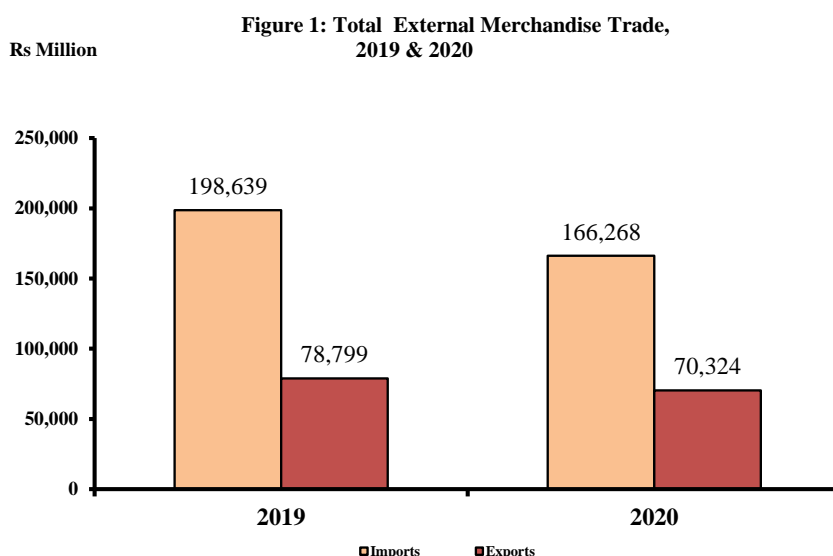
Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the fourth quarter of 2020 was valued at Rs 66,856 million, i.e. 11.8% higher than the value of Rs 59,826 million of the previous quarter and 6.5% lower than the value of Rs 71,507 million of the corresponding quarter of 2019.

For the fourth quarter of 2020, total exports (including ship's stores & bunkers) were valued at Rs 19,484 million against imports of Rs 47,372 million. This resulted in a trade deficit of Rs 27,888 million, 34.7% higher than the deficit of Rs 20,704 million of the previous quarter and 17.3% lower than the deficit of Rs 33,735 million of the corresponding quarter of 2019.

Total export proceeds for the year 2020 stood at Rs 70,324 million, representing a decrease of 10.8% over the 2019 figure of Rs 78,799 million. Total imports, for the year 2020 amounted to Rs 166,268 million, a decrease of 16.3%, compared to Rs 198,639 million in 2019. The trade deficit for year 2020 worked out to Rs 95,944 million, around 19.9% lower than the deficit of Rs 119,840 million for the year 2019.



3. Exports

3.1 Total exports (Tables 1 and 3) - 4th Quarter 2020

Total exports for the fourth quarter of 2020, including domestic exports¹, re-exports² and ship's stores and bunkers, amounted to Rs 19,484 million, showing a decrease of 0.4% compared to the previous quarter. This is explained by decreases in the exports of "Crude materials, inedible, except fuels" (-20.0%), "Chemicals and related products, n.e.s." (-10.0%), "Ship's stores and bunkers" (-7.7%) and "Miscellaneous manufactured articles" (-4.8%), partly offset by increases in the exports of "Machinery and transport equipment" (+16.0%), "Food and live animals" (+6.4%) and "Manufactured goods classified chiefly by materials" (+1.9%).

Compared to the corresponding quarter of 2019, total exports for the fourth quarter of 2020 increased by 3.2%. This is mainly explained by increases in exports of "Machinery and transport equipment" (+47.6%) and "Manufactured goods classified chiefly by material" (+16.8%) and "Food and live animals" (+11.7%), partly offset by decreases in the exports of "Ship's stores and bunkers" (-32.0%).

3.2 Domestic Exports

Domestic exports for the fourth quarter of 2020 amounting to Rs 14,114 million accounted for 72.4% of total exports. Compared to a value of Rs 14,226 million recorded in the third quarter of 2020 domestic exports decreased by 0.8%. When compared to the corresponding quarter of 2019 an increase of 12.0% was observed.

3.3 Re-exports

In the fourth quarter of 2020 Re-exports stood at Rs 3,441 million i.e higher by 6.0% compared to previous quarter, and lower by 0.3% compared to the corresponding quarter of 2019. (Table 5)

3.4 Exports by SITC sections (Tables 1 and 3) - Year 2020

Total export proceeds for the year 2020 stood at Rs 70,324 million, representing a decrease of 10.8% over the 2019 figure of Rs 78,799 million. Around 38.3% of total exports consisted of "Food and live animals" (Rs 23,181 million), 34.1% of "Miscellaneous manufactured goods" (Rs 20,649 million) and 14.2% of "Manufactured goods classified chiefly by material" (Rs 8,623 million).

Compared to the year of 2019, the main changes by section are as follows:

- "Miscellaneous manufactured goods" registered a decrease of 18.5%, mainly explained by a decrease in exports of "Articles of apparel & clothing accessories" (-19.7%).
- "Food and live animals" decreased by 1.1%, mainly due to a decrease of 5.9% in exports of "Fish and fish preparations".
- "Manufactured goods classified chiefly by material" decreased by 9.9% mainly as a result of decreases in the exports of "Pearls, precious & semi-precious stones" (-35.7%) and "Textile yarns, fabrics, made-up articles" (-0.3%)".

¹ Domestic exports are defined as goods of national origin.

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

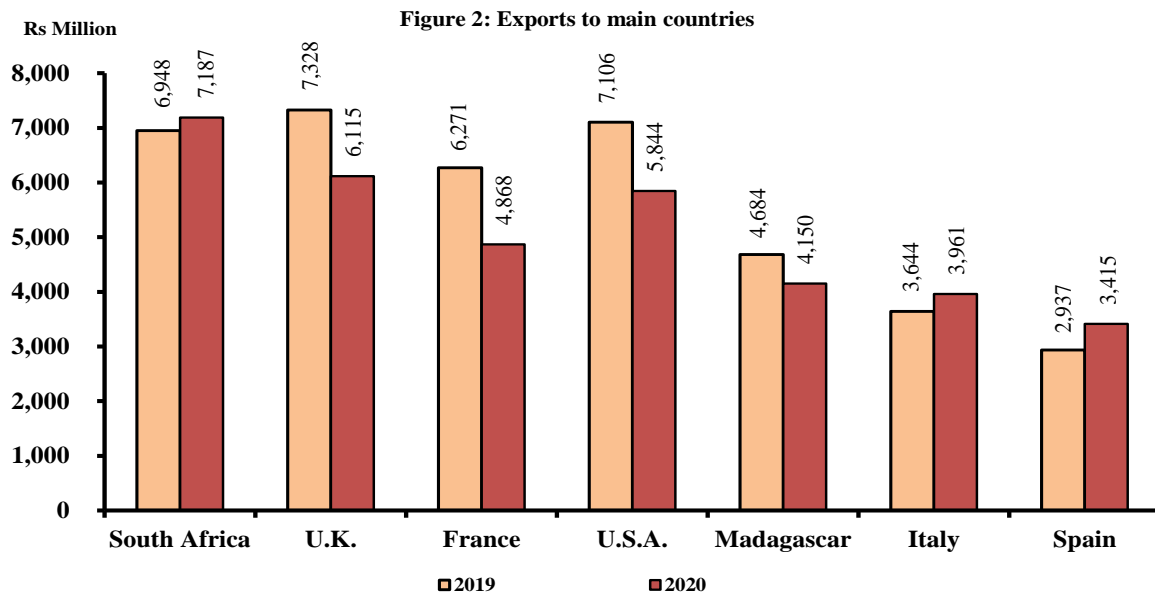
3.5 Exports of Export Oriented Enterprises (EOE)

For the year 2020, exports of EOE amounted to Rs 37,385 million, compared to Rs 42,319 million in 2019, representing a decrease of 11.7%.

Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 30 March 2021.

3.6 Exports by country of destination (Table 7) –Year 2020

Analysis of exports figures by country of destination for the year 2020 shows that the European countries were our main buyers, purchasing around 45.4% of our exports excluding Ships stores and Bunkers, for a value of Rs 27,509 million. Among countries, the major destinations for our exports were South Africa (11.9%), United Kingdom (10.1%), U.S.A. (9.7%), France (8.0%), Madagascar (6.9%), Italy (6.5%) and Spain (5.6%).



Compared to the year 2019, exports to France, U.S.A., United Kingdom and Madagascar decreased by 22.4%, 17.8%, 16.6% and 11.4% respectively, On the other hand exports to Spain, Italy and South Africa increased by 16.3%, 8.7% and 3.4% respectively.

4. Total Imports (Table 10) - 4th Quarter 2020

Total imports for the fourth quarter of 2020 amounted to Rs 47,372 million, showing an increase of 17.7%, compared to the previous quarter. This is due to increases in imports of “Miscellaneous manufactured articles” (+38.6%), “Chemicals and related products” (+17.4%), “Machinery & transport equipment” (+26.9), “Mineral fuels, lubricants, & related products” (+20.0%) and “Manufactured goods classified chiefly by materials” (+16.1%) partly offset by a decrease in “Animal & vegetable oils and fats” (-16.5%).

Compared to the corresponding quarter of 2019, total imports for the fourth quarter of 2020 decreased by 10.0%. This decline is due to decreases in imports of “Mineral fuels, lubricants, & related products” (-35.4%), “Machinery & transport equipment” (-17.8%), “Crude materials, inedible, except fuels” (-14.9%) and “Food and live animals” (-4.5%), partially offset by increases in “Manufactured goods classified chiefly by material” (+3.6%), “Miscellaneous manufactured articles” (+3.1%) and “Chemicals and related products” (+14.7%).

4.1 Imports by SITC section (Table 10) – Year 2020

Total imports, for the year 2020 amounted to Rs 166,268 million, a decrease of 16.3%, compared to Rs 198,639 million in 2019. Around 22.0% of imports in year 2020 consisted of “Machinery & transport equipment” (Rs 36,622 million), 21.7% of “Food and live animals” (Rs 36,000 million), 16.1% of “Manufactured goods classified chiefly by material” (Rs 26,851 million), 15.0% of “Mineral fuels, lubricants, & related products” (Rs 24,902 million), 10.0% of “Chemicals and related products, n.e.s.” (Rs 16,651 million) and 9.5% of “Miscellaneous manufactured articles” (Rs 15,750 million).

Compared to the year 2019, total imports for 2020 decreased by 16.3%. Main changes by section were as follows:

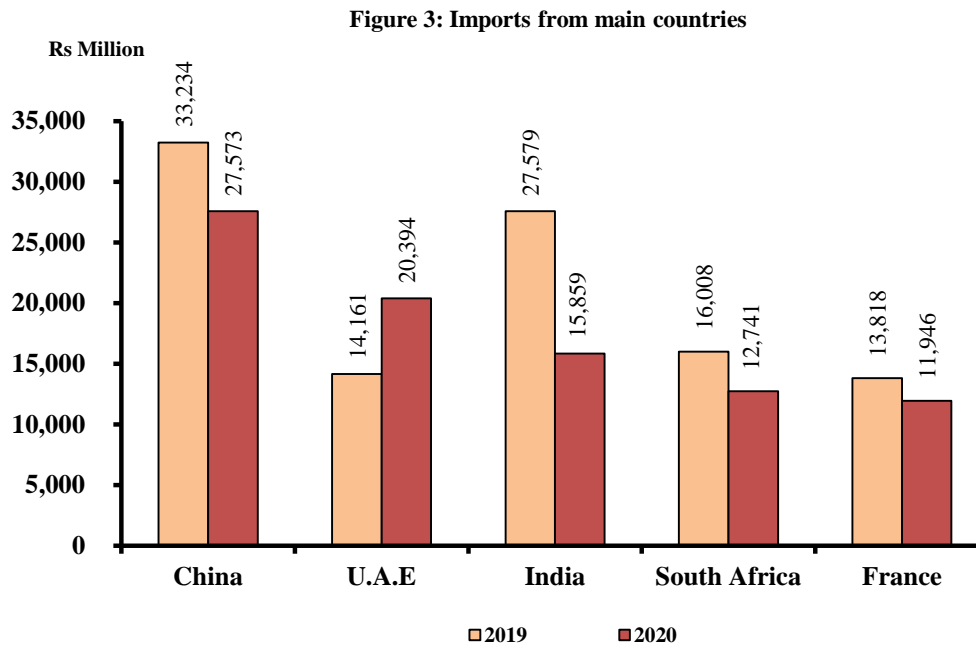
- “Mineral fuels, lubricants, & related products” (-31.5%), mainly due to decreases in imports of “Gas, natural and manufactured” (-55.3%) and “Refined petroleum products” (-31.9%).
- “Crude materials, inedible, except fuels” (-22.5%), mainly explained by decreases in imports of “Textile fibres” (-39.1%) and “Cork and wood” (-13.4%).
- “Machinery & transport equipment” (-22.3%), mainly due to decreases in imports of “Aircraft, marine vessels and parts” (-52.8%), “Machinery specialised for particular industries” (-32.8%), “Power generating machinery & equipment” (-30.3%) and “Telecommunications & sound recording & reproducing apparatus & equipment” (-27.9%).
- “Miscellaneous manufactured articles” (-17.6%), mainly due to decreases in imports of “Printed matter” (-37.3%), “Footwear” (-29.1%), “Prefabricated buildings; sanitary plumbing, heating & lighting fixtures & fittings, n.e.s” (-28.3%), and “Articles of apparel and clothing” (-16.9%).
- “Manufactured goods classified chiefly by material” (-15.8%), mainly due to drops in imports of “Pearls, precious & semi-precious stones” (-41.9%), “Cotton fabrics” (-40.5%) and “manufactures of metals n.e.s” (-17.8%).
- “Beverages and tobacco” (-10.7%), due to decreases in imports of” Beverages” (-18.5%) and “Tobacco & tobacco manufactures” (-4.0%).
- “Chemicals and related products (-3.9%) n.e.s.”, mainly due to decreases in imports of “Plastics in primary forms” (-20.2%), “Plastics in non-primary forms” (-19.4%), “Fertilisers” (-13.5%) and “Dyeing & tanning materials” (-12.1%).

The above mentioned decreases were partly offset by increases in “Animal & vegetable oils and fats” (+9.0%) and “Food and live animals” (+0.5%)

4.2 Imports by country of origin – Year 2020

For the year 2020, our imports originated from five main countries, namely: China (16.6%), United Arab Emirates (12.3%), India (9.5%), South Africa (7.7%) and France (7.2%). Among continents, Asia was our main supplier with a share of Rs 90,475 million, representing 54.4% of total imports. (Table 13)

Compared to 2019, total imports from India, South Africa, China and France fell by 42.5%, 20.4%, 17.0% and 13.5% respectively, while imports from United Arab Emirates went up by 44.0%.



5. Trade with Member States of Regional Organizations – Year 2020

Total exports to African, Caribbean and Pacific (ACP) States stood at Rs 15,524 million against imports of Rs 18,182 million. The trade deficit with ACP countries worked out to Rs 2,658 million. South Africa is the main supplier and buyer, with a share of 70.1% and 46.3% respectively. (Table 14)

Exports to COMESA member states attained Rs 7,597 million while imports from these countries amounted to around Rs 5,801 million, resulting in a trade surplus of Rs 1,796 million. Madagascar was the main buyer with a share of 54.6% followed by Kenya (25.2%). Our main suppliers were Seychelles (34.9%), Kenya (24.4%), Egypt (20.6%) and Madagascar (15.7%). (Table 15)

Trade with SADC countries showed a deficit of Rs 3,374 million, resulting from imports of Rs 16,338 million against exports worth Rs 12,964 million. The main buyers were South Africa (55.4%) and Madagascar (32.0%) and the main suppliers were South Africa (78.0%) and Seychelles (12.4%). (Table 16)

6. Trade in Freeport Zone – Year 2020

For the year 2020, total imports of the Freeport Zone stood at Rs 6,922 million, lower by 28.3% compared to 2019 – (Table 12).

The main imports of the Freeport zone were “Food and live animals” and “Chemicals and related products, n.e.s.” with a share of 33.4% and 18.4% respectively.

Freeport re-exports were valued at Rs 8,778 million, representing a decrease of 16.4% compared to 2019 – (Table 6). “Food and live animals” and “Chemicals and related products, n.e.s.” with a share of 43.2% and 18.4% respectively, were the main exports.

7. Forecast 2021

Based on trends and information from various sources, the forecast of total exports for year 2021 will be around Rs 75,000 million and total imports including one off items such as marine vessels, machinery for metro terminals, cranes and tugs will be around Rs 180,000 million.

The trade deficit for 2021 is forecasted to be around Rs 105,000 million, compared to Rs 95,944 million in 2020.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis, whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to **the Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six- and five-digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
