Export Oriented Enterprises (EOE) 1st Quarter 2021

1. Introduction

This issue of "Economic and Social Indicators" (ESI) presents the results of the Quarterly Survey of Employment among Export Oriented Enterprises (EOE), conducted by Statistics Mauritius at the end of March 2021.

It also includes provisional figures on EOE imports and exports for the first quarter of 2021 as well as figures for the year 2019 and 2020. Table 1 shows the main indicators of the EOE sector for the period 2012 to 2020.

EOE consist of enterprises formerly holding an EPZ certificate as well as enterprises manufacturing goods for export and holding a registration certificate issued by the ex-Board of Investment.

2. Employment

2.1 Employment – 1st Quarter 2021

Compared to the fourth quarter of 2020, employment in EOE decreased by 229 (-0.6%) from 36,736 to 36,507. Male employment dropped by 391 from 20,461 to 20,070 while female employment increased by 162 from 16,275 to 16,437 (Table 2).

The number of Mauritians employed in the EOE sector increased by 275 (+1.4%) (108 males and 167 females) from 19,120 to 19,395 and the number of foreign workers decreased by 504 (-2.9%) (-499 males and -5 females) from 17,616 at the end of December 2020 to 17,112 at the end of March 2021 (Table 2).

The decrease of 229 in employment in the EOE sector during the first quarter of 2021 is the net result of 593 jobs lost and 364 jobs created. The job losses were due to some contraction of workforce whilst jobs created were due to expansion in existing enterprises.

2.2 Evolution of employment from March 2020 to March 2021

From March 2020 to March 2021, total employment in EOE decreased by 6,981 (-16.1 %) from 43,488 to 36,507. The number of Mauritian workers decreased by 3,981 (-972 males and -3,009 females). Employment of foreign workers decreased by 3,000 (-1,655 males and -1,345 females) (Tables 2 and 5).

Job losses occurred mainly in enterprises engaged in the manufacture of "Wearing apparel" with a decrease of 6,009 jobs (Table 4).

Details of employment by product group and sex are given in Table 3 and changes in employment by product group in Table 4.

3. Exports and Imports

Statistics on imports and exports are compiled from declarations lodged at Customs by importers and exporters. Some of these declarations are, at times, revised at a later period and corrections made accordingly on the computerised database of the Mauritius Revenue Authority (MRA) - Customs Department. Thus, while figures for 2019 are final, those for 2020 and first quarter 2021 are provisional and subject to revision as and when the MRA - Customs Department submits latest amendments to Statistics Mauritius.

3.1 Exports and Imports – 1st Quarter 2021

3.1.1 Exports (f.o.b)

Provisional figures show that EOE exports during the first quarter of 2021 amounted to R 9,435 million, that is, R 1,653 million (-14.9%) lower compared to the fourth quarter of 2020 (Table 6). That was mainly the result of decreases observed in exports of "Articles of apparel and clothing" (-R 537 million or -12.9%), "Pearls, precious & semi-precious stones" (-R 295 million or -43.2%) and "Textile yarn, fabrics, made up articles" (-R 271 million or -20.6%).

Compared to the corresponding quarter of 2020, EOE exports decreased by R 100 million (-1.0%).

Details on EOE exports by section are given in Table 7.

South Africa, United Kingdom (UK), France and United States of America (USA) remain the principal EOE markets, together accounting for R 4,928 million (52.2%) of total EOE exports (Table 9). The table below highlights the changes in our main EOE exports markets.

Compared to the previous quarter, EOE exports to our main markets showed decreases as follows: South Africa (-17.2%), USA (-12.7%), France (-8.0%) and United Kingdom (-3.7%).

When compared to the first quarter of 2020, increases of 33.1%, 19.7%, and 5.7% were noted for South Africa, United Kingdom and France respectively whilst USA registered a decrease of 29.0%.

Further details are given in Table 9.

3.1.2 <u>Imports (c.i.f)</u>

EOE imports during the first quarter of 2021 were estimated at R 5,401 million, representing a decrease of R 539 million (-9.1%) compared to the fourth quarter of 2020. This decrease is mainly due to lower imports of raw material by R 572 million (-9.9%) (Table 6).

Compared to the corresponding quarter of 2020, imports increased by R 590 million (+12.3%), mainly due to an increase in imports of "Fish and fish preparations" by R 559 million (+51.4%), partly offset by a decrease of R 187 million (-31.8%) in "Pearls, precious and semi-precious stones". Details on EOE imports by section are given in Table 8.

3.1.3 Net exports

Net exports, i.e. exports minus imports, amounted to R 4,034 million in the first quarter of 2021 and its ratio to total exports worked out to 42.8 % compared to 49.5 % in the corresponding quarter of 2020 (Table 6).

It is to be noted that the above exports and imports figures do not include transactions of the EOE with the Freeport. EOE sales to the Freeport, considered as local sales, were valued at R 36 million in the first quarter of 2021 compared to R 21 million in the first quarter of 2020. These sales are included in exports of Freeport, as and when the goods leave the country.
