

External Merchandise Trade Statistics

3rd Quarter 2021

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics from the first to third quarter of 2021 and the years 2019 and 2020. These statistics are compiled from declarations lodged at the Customs Department of the Mauritius Revenue Authority (MRA), by importers and exporters. Some of these declarations are usually revised at a later period and corrections are made accordingly on the computerised database of the Mauritius Revenue Authority (MRA).

Figures for 2019 and 2020 are published in this indicator and those for 2021 are still provisional and subject to revision as and when the Customs Department of the MRA submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.

2. Total value of trade and trade balance

Total external merchandise trade for the third quarter of 2021 was valued at Rs 77,115 million, i.e. 13.9% higher than the value of Rs 67,725 million of the previous quarter and 29.0% higher than the value of Rs 59,781 million of the corresponding quarter of 2020.

For the third quarter of 2021, total exports (inclusive of ship's stores & bunkers¹) were valued at Rs 22,274 million against total imports of Rs 54,841 million.


In the second quarter of 2021, total exports (inclusive of ship's stores and bunkers) amounted to Rs 19,447 million against total imports of Rs 48,278 million while for the third quarter, total exports (inclusive of ship's stores & bunkers) amounted to Rs 19,540 million against total imports of Rs 40,241 million.

Compared to the previous quarter, total exports and total imports in the third quarter were higher by 14.5% and 13.6% respectively. Compared to the corresponding quarter of 2020, total exports and total imports went up by 14.0% and 36.3% respectively.

The resulting trade deficit for the third quarter of 2021 worked out to Rs 32,567 million, 13.0% higher than the deficit of Rs 28,831 million of the previous quarter and 57.3% higher than the deficit of Rs 20,701 million of the corresponding quarter of 2020.

From Figure 1, compared to the period Jan-Sept of 2020, total exports (inclusive of ship's stores & bunkers) rose from Rs 50,749 million to Rs 59,074 million in same period of 2021, showing an increase of around 16.4%. Total imports increased by 24.6% for period Jan-Sept of 2021, compared to the corresponding period of 2020. Consequently, the trade deficit for the first nine months of 2021 was up by 30.7% and works out to around Rs 88,435 million, compared to Rs 67,661 million in the corresponding period of 2020.

3. Total Exports

3.1 Total exports (Tables 1 & 3) – 3rd Quarter & January to September 2021

Total exports proceeds for the third quarter of 2021, including domestic exports², re-exports³ and ship's stores and bunkers amounted to Rs 22,274 million, showing an increase of 14.5%, compared to the previous quarter. This is mainly explained by increases in the exports of "Miscellaneous manufactured articles" (+28.3%), "Ship's stores & bunkers" (+23.6%) and "Manufactured goods classified chiefly by material" (+8.5%), partly offset by a decrease in the exports of "Food and live animals" (-2.6%).

Compared to the corresponding quarter of 2020, total exports for the third quarter of 2021 increased by 14.0%. This is mainly explained by increases in exports of "Ship's stores & bunkers" (+62.8%), "Miscellaneous manufactured articles" (+13.4%) and "Manufactured goods classified chiefly by material" (+10.8%), partly offset by a decrease in the exports of "Food and live animals" (-6.0%).

Compared to corresponding period of 2020, total exports for the period Jan-Sept of 2021, increased by 16.4% which is mainly explained by increases in the exports of "Manufactured goods classified chiefly by material" (+31.3%), "Miscellaneous manufactured articles" (+29.5%), "Ship's stores & bunkers" (+8.9%) and "Food and live animals" (+1.4%).

Domestic exports, amounting to Rs 13,625 million, accounted for 61.2% of total exports in the third quarter of 2021. Compared to a value of Rs 12,607 million recorded in the second

quarter of 2021, domestic exports increased by 8.1%. This is mainly explained by increases in domestic exports of “Crude materials, inedible, except fuels” (+37.5%), “Miscellaneous manufactured articles” (+29.0%), “Chemicals and related products, n.e.s.” (+6.7%), partly offset by decreases in the exports of “Food and live animals” (-9.0%) and “Manufactured goods classified chiefly by material” (-3.6%).

Compared to the corresponding quarter of 2020, domestic exports were lower by 4.1%, mainly explained by decreases in exports of “Manufactured goods classified chiefly by material” (-27.3%), “Chemicals and related products, n.e.s.” (-5.0%) and “Food and live animals” (-3.8%), partly offset by increases in the exports of “Crude materials, inedible, except fuels” (+95.6%) and “Miscellaneous manufactured articles” (+1.9%).

Compared to corresponding period of 2020, domestic exports for the period Jan-Sept of 2021, was higher by 12.7%. This increase was mainly due to increases in “Crude materials, inedible, except fuels” (+74.9%), “Miscellaneous manufactured articles” (+19.7%) and “Food and live animals” (+10.4%), partly offset by a decrease in the exports of “Manufactured goods classified chiefly by material” (-2.6%).

For the third quarter of 2021, re-exports stood at Rs 5,247 million, i.e. higher by 28.4% compared to the previous quarter, mainly due to increases in exports of “Food and live animals” (+51.1%), “Machinery and transport equipment” (+45.9%), “Manufactured goods classified chiefly by material” (+31.4%), “Miscellaneous manufactured articles” (+24.0%) and “Chemicals and related products” (+22.9%) (*Table 5*).

Compared to the corresponding quarter, re-exports of merchandise goods rose by 61.6% mainly explained by increases in exports of “Manufactured goods classified chiefly by material” (+315.8%), “Miscellaneous manufactured articles” (+229.8%), “Machinery and transport equipment” (+58.6%) and “Chemicals and related products” (+28.4%), partly offset by a decrease in “Food and live animals” (-15.8%).

Compared to the corresponding period of 2020, re-exports increased by 36.6% for the period Jan-Sept of 2021. This increase is mainly due to increases in exports of “Manufactured goods classified chiefly by material” (+271.0%), “Miscellaneous manufactured articles” (+135.6%), “Machinery and transport equipment” (+48.6%) and “Chemicals and related products” (+16.0%), partly offset by a decrease in “Food and live animals” (-36.0%).

3.3 Exports of Export Oriented Enterprises (EOE) –3rd Quarter 2021 & January to September 2021

For the third quarter of 2021, exports of EOE amounted to Rs 11,421 million, compared to Rs 10,428 million in previous quarter (+9.5%) and to Rs 11,435 million in the corresponding quarter of 2020 (-0.1%) (*Table 1*).


Compared to the corresponding period in 2020, exports of EOE increased by 19.4%, from Rs 26,205 million to Rs 31,284 million for the period Jan-Sept of 2021.

Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 23 December 2021.

3.4 Exports by country of destination (Table 7) – 3rd Quarter 2021 & January to September 2021

Analysis of exports figures by country of destination for the third quarter of 2021 shows that the European countries were our main buyers, purchasing some 37.5% of our exports for a value of Rs 7,070 million. Among countries, the major destinations for our exports were South Africa (15.1%), France (9.9%), U.S.A. (8.7%), U.K (7.5%), Madagascar (7.5%), Reunion (4.6%), Spain (4.2%) and Italy (4.0%).

Compared to the corresponding quarter of 2020, exports to Reunion, France, Madagascar and South Africa increased by 113.5%, 40.5%, 39.9% and 11.2% respectively, while exports to Italy, U.K, Spain and U.S.A dropped by 29.1%, 21.7%, 21.6% and 14.4% respectively.



From Figure 2, compared to the corresponding period of 2020, exports to main markets increased for the period Jan-Sept of 2021. Exports to Reunion, South Africa, France, Madagascar, U.K and Spain witnessed increases of 118.3%, 47.5%, 27.6%, 25.1%, 12.3% and 3.4% respectively, as compared to U.S.A and Italy which witnessed both a decrease of 9.8%.

4. Total Imports

4.1 Total imports (Table 10) – 3rd Quarter & January to September 2021

Total imports for the third quarter of 2021 amounted to Rs 54,841 million, showing an increase of 13.6%, compared to the previous quarter. This is mainly due to increases in imports of “Manufactured goods classified chiefly by material” (+41.6%), “Miscellaneous manufactured articles” (+18.2%), “Mineral fuels, lubricants and related materials” (+15.1%), “Food and live animals” (+14.8%) and “Machinery and transport equipment” (+14.6%), partly offset by a decrease in imports of “Chemicals and related products” (-18.3%).

Compared to the corresponding quarter of 2020, total imports for the third quarter of 2021 increased by 36.3%. This is mainly due to increases in imports of “Mineral fuels, lubricants and related materials” (+94.0%), “Manufactured goods classified chiefly by material” (+57.6%), “Chemicals and related products” (+36.6%), “Miscellaneous manufactured articles” (+25.5%), “Machinery and transport equipment” (+21.5%) and “Food and live animals” (+12.1%).

Compared to the corresponding period of 2020, total imports increased by 24.6% for the period Jan-Sept of 2021. This rise is mainly explained by increases in the imports of “Chemicals and related products, n.e.s.” (+46.8%), “Miscellaneous manufactured articles” (+42.4%), “Manufactured goods classified chiefly by material” (+37.5%), “Mineral fuels, lubricants, & related products” (+30.6%), “Machinery & transport equipment” (+11.4%) and “Food and live animals” (+8.8%).

4.2 Imports by SITC section (Table 10) – 3rd Quarter 2021

Around 20.1% of imports in the third quarter of 2021 consisted of “Manufactured goods classified chiefly by material” (Rs 11,044 million), 19.2% of “Food and live animals” (Rs 10,509 million), 18.7% of “Machinery and transport equipment” (Rs 10,244 million), 16.6% of “Mineral fuels, lubricants and related materials” (Rs 9,104 million), 10.7% of “Chemicals and related products” (Rs 5,845 million) and 9.5% of “Miscellaneous manufactured articles” (Rs 5,214 million).

Compared to the corresponding quarter of 2020, total imports increased by 36.3%. Main changes by section are as follows:


- “Mineral fuels, lubricants and related materials” increased by 94.0%, mainly due to increases in the imports of “Gas, natural and manufactured” (+111.0%) and “Refined petroleum products” (+74.6%).
- “Manufactured goods classified chiefly by material” increased by 57.6%, mainly due to increases in the imports of “Iron and steel” (+139.2%), “Textile yarn” (+90.2%), “Pearls, precious & semi-precious stones” (+57.5%) and “Manufactures of metal, n.e.s” (+3.7%).
- “Chemicals and related products, n.e.s.” increased by 36.6%, mainly due to increases in the imports of “Plastics in primary forms” (+88.0%), “Plastics in non-primary forms” (+37.2%) and “Medicinal & pharmaceutical products” (+30.0%).
- “Miscellaneous manufactured articles” increased by 25.5%, mainly due to increases in the imports of “Articles n.e.s., of plastic” (+27.3%) and “Professional, scientific & controlling instruments & apparatus, n.e.s” (+26.2%), partly offset by a decrease in imports of “Articles of apparel and clothing” (-6.7%).
- “Machinery and transport equipment” increased by 21.5%, mainly due to increases in the imports of “Office machines and automatic data processing machines” (+66.8%), “Electrical machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (+34.2%), “Telecommunications & sound recording & reproducing apparatus & equipment” (+25.0%), “Road vehicles” (+17.2%) and “General industrial machinery & equipment, n.e.s., & machine parts, n.e.s” (+12.2%).

- “Food and live animals” increased by 12.1%, mainly due to increases in the imports of “Meat and meat preparations” (+40.2%), “Dairy products and bird’s eggs” (+19.0%), “Vegetables and fruits” (+14.4%), partly offset by a decrease in imports of “Fish and fish preparations” (-22.2%).

4.3 Imports by country of origin – 3rd Quarter 2021

During the third quarter of 2021, our imports originated from five main countries, namely: China (18.6%), India (15.8%), South Africa (7.7%), U.A.E (7.1%) and France (6.6%) (*Table 13*). Among continents, Asia was our main supplier with a share of Rs 29,931 million, representing 54.6% of total imports.

Compared to the corresponding quarter of 2020, total imports from India, China, South Africa, France and U.A.E rose by 99.4%, 58.1%, 50.1%, 17.0% and 2.6% respectively.



From Figure 3, compared to the corresponding period of 2020, India, South Africa, China and France have witnessed increases of 90.6%, 37.4%, 32.5% and 18.4% in total imports for the period Jan-Sept of 2021, respectively, as compared to total imports from U.A.E which has decreased by 8.7%.

5. Trade with Member States of Regional Organizations – 3rd Quarter 2021

During the third quarter of 2021, total exports to African, Caribbean and Pacific (ACP) States stood at Rs 5,665 million against imports of Rs 5,764 million (*Table 14*). The trade deficit with ACP countries worked out to Rs 99 million. South Africa is the main supplier and buyer, with a share of 72.8% and 50.5% respectively.

Exports to COMESA member states attained Rs 2,363 million while imports from these countries amounted to around Rs 1,686 million, resulting in a trade surplus of Rs 677 million. Madagascar was the main buyer with a share of 59.5% followed by Kenya (23.7%). Our main suppliers were Seychelles (39.7%), Kenya (24.8%), Madagascar (16.4%) and Egypt (16.0%) (*Table 15*).

Trade with SADC countries showed a deficit of Rs 611 million, resulting from imports of Rs 5,258 million against exports worth Rs 4,647 million. The main buyers were South Africa (61.5%) and Madagascar (30.3%) and the main suppliers were South Africa (79.8%) and Seychelles (12.7%) (*Table 16*).

6. Trade in Freeport Zone – 3rd Quarter 2021

During the third quarter of 2021, total imports of the Freeport Zone stood at Rs 3,060 million, higher by 35.6% compared to the corresponding quarter of 2020 and lower by 42.5% compared to the previous quarter – (*Table 12*).

Compared to the corresponding period of 2020, freeport imports rose by 108.1% for the period Jan-Sept of 2021 mainly explained by increases in imports of “Chemicals and related products, n.e.s,” (+359.3%), “Miscellaneous manufactured articles” (+234.3%), “Machinery and transport equipment” (+124.9%) and “Manufactured good classified chiefly by material” (+74.8%), partly offset by a decrease in “Food and live animals” (-29.1%).

In the third quarter of 2021, freeport re-exports were valued at Rs 3,382 million, representing an increase of 43.5% compared to the previous quarter and an increase of 60.3% compared to the corresponding quarter of 2020 (*Table 6*).

Compared to corresponding period of 2020, freeport re-exports increased by 18.8% for the period Jan-Sept of 2021, mainly explained by increases in exports of “Miscellaneous manufactured articles” (+209.8%) and “Chemicals and related products, n.e.s,” (+19.9%), partly offset by a decrease in exports of “Food and live animals” (-40.9%).

7. Forecast 2021

Based on trends and information from various sources, the forecast of total exports for 2021 will be around Rs 78,000 million, 11.1% higher than the total exports of around Rs 70,200 million in 2020. Total imports for 2021, including one-off items such as machinery for metro terminals, cranes and tugs, will be around Rs 198,000 million, 19.5% higher than the total imports of around Rs 165,700 million in 2020.

The trade deficit for 2021 is forecasted at around Rs 120,000 million, 25.7% higher as compared to around Rs 95,500 million in 2020.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis, whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2017)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to **the Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six- and five-digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
